Hunter Over Fences

Each horse will individually negotiate a course consisting of at least 8 jumps over a minimum of 4 different obstacles. At least one change of direction is recommended. The hunter should provide his rider with a safe, consistent ride at a working pace over a course of fences similar to those that might be encountered in the field. This requires that all horses must be serviceably sound and any horse showing evidence of lameness, broken wind or impairment of vision will be excused from the ring by the steward, show vet or judge.

Drivers will be asked to rein back. Judged on handling of reins and whip, control, posture, and overall appearance of the driver, condition of harness and vehicle and neatness of attire.

In Hand Suitability

This class judges the communication between handler and equine. Handlers will enter the ring at a walk while going the first way of the ring. Entries will be asked to follow given commands on the rail both ways of the ring that may include walking, trotting, stopping, backing and turning at any gait. Handlers and equine will also be asked to execute a pattern. Patterns may include any of the above gaits as well as ground tying. Equines and handlers will be judged 70% on suitability as a team in communication and execution of rail work, 15% on pattern completion and 15% on presentation of both handler and equine.

Class to be judged on performance and way of going with emphasis on manners throughout course. Entries will be evaluated on responsiveness and willingness, plus general attitude. Maximum time 60 seconds per obstacle, judges are encouraged to advance on to the next obstacle any horse taking excessive time at an obstacle. Horse to be penalized for any unnecessary delay or excessive time at object. Refusals do not constitute class disqualifications.

Hunter Under Saddle

All horses will enter the ring in a counter-clockwise direction at a trot until otherwise directed by the judge. Horses are to be shown at the walk, trot, extended trot, canter and hand gallop (Hand gallop will occur in groups with a suggested max. of 20). Western Trail

Horses will negotiate obstacles with style and consistency. Credit will be given to horses that show the capability of picking their way through the course when obstacles warrant it, and willingly respond to the rider's cues on more difficult obstacles. Horses with artificial appearance over obstacles will be penalized. The course must be designed to show appropriate gait differences (walk, jog/trot, lope/canter, halt, back). A minimum of 6 obstacles will be used. Time in excess of 30 seconds or 3 attempts in approaching an obstacle will eliminate the score for the obstacle and the rider will proceed to the next obstacle. The class will be judged on the performance of the horse over obstacles, with emphasis on manners, response to the rider and attitude. This class may be ridden in either English or Western tack or attire but not a combination of both.

In Hand Jumping

Judge(s) shall walk Hunter/Jumper course with designer and exhibitors. Course diagrams must show with arrows the direction each obstacle must be taken. A start and finish line must be established. Horses (exhibitors optional) must cross the line in the proper direction to start and complete the course. Horses must stay within the course boundaries as outlined by the start and finish cone. Baiting of horses to encourage an animal to perform any of the jumps is not allowed. Baiting in such class is a disqualification.

Jumpers are scored mathematically, based on faults incurred between the starting line and the finishing line. Exhibitors may go over jumps with horse. Whips are not permitted in show ring. Circling once upon entering the ring and once upon leaving the ring is permissible, but not after crossing starting line. SCORING jumpers: an in and out is to be considered as two (2) jumps. Jumpers are to be scored on a mathematical basis and penalty faults include knockdowns, refusals, and eliminations
