Dues to be collected from fairs \$36,500, attached. Transfer Harvest paid dues and will be re-instated. Fair Guide published May 26. Albion Fair filing for Sales Tax Exemption. Bedford Fair also has received a notice of filing. These Fairs should work with their attorney's to complete the exemptions, PSACF would not be involved. Lobbying disclosure, we are now compliant. Bruce and Fred drafted the agreement. Decennial Report filed.

Hershey has dropped from the chocolate baking contests, PA Preferred will be sponsoring. Fair Guides to be printed today, but must go out for bids, cutting back number printed from last year. Will have 1000 Fair Guides for the Zone Meetings. He is hoping to have a fair only PA Preferred contest \$1,000 1<sup>st</sup> place, \$500 2<sup>nd</sup>, and \$250 for 3<sup>rd</sup>, cash prize will come back to the fair. 3 years is length of time for retention of records for audit from the state. Fairs should apply for capital improvements by June 30<sup>th</sup> in case funds would be available.
