This includes any injury to others or to the Exhibitor/Contestant or to the Exhibitor/Contestant’s property.”

I forever release the GNR, the State, the County, affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representative (collectively “Releases”) from any and all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused by any Release, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives, will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release.
