Meeting called to order: 6:30 pm

## Consent Agenda:

- Fair board Election of officers. Henry Heimuller nominated Julie Pelletier as President, Peggy Howell as Vice President, MaryAnn Guess as treasurer, and Hanna Russell as secretary. MaryAnn Guess 2<sup>nd</sup> the motion. All in favor, motion passed.

- Julie reminded we still need a fair theme. Hanna will work on making a contest.

- Derek and Greg both resigned from the Fair board. Julie thanked them for their service and wish them well. Julie also reminded everyone that we now have 2 fair board positions open.
