



Lea County issued an RFP in the Spring of 2018 for a new financial accounting system. Two vendors responded and the County awarded the contract to Caselle on resolution 19-SEP-236R in September 2018. The implementation process was delayed due to the COVID-19 pandemic and the "Go-live" date was on September 12, 2022. Caselle was founded in 1978 by Alan Hutchings, who still serves as President of the company.

Caselle currently services 840 clients from their Utah office along with 2 resellers on the East Coast. Including Lea County, Caselle has 36 local government users in New Mexico. Those users include the Cities of Eunice, Jal and Belen. Doña Ana County is also a current user of the system.
