- Visit <u>www.salina.fairwire.com</u> for the Online Entries home page, starting February 1st.
- Livestock Exhibitors must have your <u>YQCA certificate</u> and a <u>SVF Sales Agreement</u> complete and ready to upload.
- Register as an exhibitor.
- Click "Add Entry" and choose a "Department"
- Within each department you will be asked to choose a "class" and information pertaining to your entry
 - Please answer each question accurately
 - o Continue to add additional entries
- When entries are complete, follow the prompts to complete your shopping cart and pay for your entries
 - o Remember! You must click "Save Cart" in order for your account to be saved
 - o After "saving your cart" you may come back to pay at a later date.
 - Any "carts" not paid for by April 1st 11:59 pm will not be accepted!
- You will then be prompted to upload livestock documents, for example;
 - YQCA Certificate
 - o SVF Sales Agreement
- Print out your receipt! This is your proof that you did indeed make the entry deadline

PASSES & CREDENTIALS

All ride bracelets, day passes and camping spots must be purchased in person at the Front Office

Livestock Exhibitor Pass-\$15

All livestock exhibitors must purchase this pass with their livestock entry. One per exhibitor, must have entered a market or breeding animal.

Adult Season Pass-\$30

Unlimited, includes adults 18 years and older, good for the duration of the fair.

Youth Season Pass-\$25

Unlimited, includes youth 5 - 17 years old, good for the duration of the fair.

Rabbit Show - 1 Day Exhibitor- \$6 & 1-Day Parent - \$8

One per exhibitor, parent passes not limited. Must be entered in the Rabbit Show, good for <u>Friday only</u>.

FFA/4-H Leader Pass-\$30

Passes will only be sold to recognized FFA & 4-H leaders. Please complete & deliver the leader form to the Livestock Office by April 1st. Parking permit for <u>Canal St. parking lot</u> included.

FFA/4-H Assistant Leader Pass- \$30

Recognized assistant leader passes will be issued for 25 or more animals, per species, on exhibit for that club/chapter. Assistant leader parking permits will be for the 101 Bowl parking lot only. Clubs/Chapters with over 25 animals in one species may purchase additional assistant leader passes for each additional 10 animals in a single species. Assistant leaders must be listed on the Leader Form. Any leaders who do not meet the specific requirement for purchasing leaders passes, are welcome to purchase an adult season pass, (parking permit not included).

Beef Grooming Chute Pass - \$20

Each beef chute that comes to the SVF must purchase a chute pass. Any chute passes purchased after April 1st will be \$30

New Changes & Reminders 2022

Market

- 1. Swine weigh-in will be on TUESDAY, May 10, 2022 from 7:00 a.m. until 2:00 p.m.
- 2. Market Goat weight restrictions are #60-#85 lbs. All overweight goats must go home on weigh in day.
- 3. Stall decorations are no longer included in "Clean Stall". Decorations are optional & must be in place by Saturday, May 7, 2022 by 4:00 p.m.
- 4. Weigh-in day is for animals and tack drop off only. Must enter through the Canal St. gate.
- 5. Stall teardown/walkout can begin at 3 pm on Sunday, driving on grounds will begin at 4 pm. No animals may leave before 4 p.m., with the exception of replacement heifers, which must leave on Sunday between 7:00 a.m. and 8:00 a.m. by arrangement with the Livestock Office. 831-385-3243

6. Don't forget your Still Exhibit

*A still exhibit is mandatory for all Market and Livestock exhibitors, with the exception of Primary Members (Rabbits & Poultry)

Showmanship

- 1. Showmanship is mandatory & classes have been changed and listed below.
- 2. There will no longer be a beginning showmanship class. See Showmanship rules for each division.
- 3. Exhibitors eligible for Round Robin must notify the clerk before they leave the show ring.

New Showmanship Classes

- 1. **4-H NOVICE** 1st year exhibitors who have never shown this species. Top 3 Progress to Jr.
- 2. **4-H JUNIOR** Exhibitors 10-13 years old, who have shown this species at a fair. Top 3 progress to Sr.
- 3. **4-H SENIOR** All exhibitors age 14-19 years of age, regardless of showmanship experience.
- 4. **FFA NOVICE** Exhibitor has never shown this species of animal at any fair. Top 3 progress to Sr.
- 5. **FFA SENIOR** All other FFA Exhibitors.

Beef & Replacement Heifer Show

- 1. Beef exhibitors may <u>only bring 2 head of cattle.</u> Feeders count as one of your 2 head. Please read the "area limits" for the acceptable beef combinations. (See Livestock Rules for details)
- 2. Market Steers will compete in a **SLICK SHEARING SHOW** this year and all shearing must be done before arriving on grounds. (*See department rules for details*)
- 3. Steers must be no older than 20 months, all teeth may be checked.
- 4. NO CATTLE BREEDING CLASSES will be offered for 2022- Market Show only.
- 5. Replacement Heifers must be at least 4 months bred by weigh in day

Junior Livestock Auction

- 1. Terminal sale. No market animals will be live pick up except Replacement Heifers.
- 2. In person auction only, no online bidding. We encourage you to send out Add-On forms.
- 3. Buyers letters are extremely important! Please send out at least 3 per exhibitor & encourage buyers from outside of Monterey County as well. Don't forget to send out a Thank You letter after the fair.
- 4. Auction checks will be available for pickup on July 27th.

GENERAL INFORMATION & LOCAL RULES

- 1. The Salinas Valley Fair opens to the public at 11:00 a.m. Thursday, May 12, 2022 and gates close at 10:00 p.m. Sunday, May 15, 2022.
- 2. The Fairgrounds Administrative Office is open year round. Mailing address: 625 Division Street, King City, 93930.
 - Administration Office (831) 385-3243
 - Livestock (831) 385-3538
 - Still Exhibits (831) 385-3538
 - Horse Show & Gymkhana (831) 385-3243
- 3. Responsibility rests with each exhibitor for knowing and abiding by these Local & State Rules, and the Local Rules under each department throughout the Exhibitors Guide Book. Read carefully all portions pertaining to your entries and ask the Fair Office, your 4-H or FFA leader to explain any part you do not understand.

AREA LIMITS

4. Unless otherwise specified by department, the Salinas Valley Fair competitions are open to residents and students of School Districts in the counties of Monterey, San Benito, Santa Cruz, Santa Clara & Northern San Luis Obispo. Junior Livestock Department, see Division Area Restrictions for participation.

AWARDS & Premiums

- 5. Still exhibit cash premiums will be available for pickup Monday, May 16th. Any premiums not picked up within 1 week will be considered a donation to the Salinas Valley Fair.
- 6. Auction and Livestock Premium checks will be available for pick up at the Livestock Office, Wednesday, July 27th, 2022 9am-4pm. This may be subject to change, exhibitors will be notified as soon as possible.
- 7. Prorated Premiums: Salinas Valley Fair has budgeted monies to pay the premiums at this fair. In the event that the total premiums won by exhibitors exceed this amount, the premiums may be prorated to the exhibitors at the discretion of the Board of Directors with the approval of the Division of Fairs and Expositions. Premium ribbons, tags or cards have no value as to payment. Only the official placing on the judging sheet constitutes the final payment.

ENTRIES

- 8. All entries are due online April 1st. No late entries will be accepted.
 - *Online entries open February 1, 2022 www.salina.fairwire.com
- 9. All 4-H & FFA Division entries must be approved by project leaders or advisors.
- 10. Wristbands; Livestock Exhibitor, Adult and/or Youth Season Passes must be purchased with the exhibitors' online livestock entry.
- 11. Livestock exhibitors are required to enter a Still (Non-Livestock) Entry. Still entries must be made online by April 1st.

REMOVAL OF EXHIBITS

12. Please be advised of the times specified in the rules at the beginning of each department. Premiums will be paid on a specified date. The management reserves the right to reject any exhibit offered if it is objectionable in any way, requires an excessive amount of space, or if the capacity of the department has been reached. Exhibits not picked up or removed at the time designated under individual department headings will be considered a donation to the Salinas Valley Fair.

TRAFFIC

- 13. No vehicles will be allowed to drive on-grounds between Thursday Sunday during the run of the Fair. Parking during the fair will be determined by Fair Management. Vehicles and trailers will be towed away if parked in undesignated areas of the grounds.
- 14. All Fair gates will be closed to admittance at 10 p.m. each night. Pedestrians may exit through west and/or front rotary gates. Curfew in the livestock area will be 9 p.m. at which time there will be no admittance by exhibitors, parents, or visitors into this area. This will be strictly enforced.

RESPONSIBILITY

- 15. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from any animal or article exhibited by him/her, and shall indemnify the Salinas Valley Fair against all legal proceedings in regard thereto. The fair will take reasonable precautions to ensure the safety of exhibits and property of description entered for competition or display or any other purpose while anywhere on the grounds that shall be subject to the control of the Salinas Valley Fair, but the owners themselves must take the risk of exhibiting them. In no case will the fair be responsible in any way for any loss, damage, or injury of any character to any property, article or person, while the same is on the fairgrounds or at any other time or place, nor be liable for or make any payment for damage, loss or injury. Presentation of entry shall be deemed acceptance of this rule.
- 16. Violation of rules and/or misconduct by any exhibitor, adjudicated by the "On the Spot committee" may result in forfeiture of premium money and/or nullification of proceeds from sale through the Junior Livestock Auction and return of animals to that particular exhibitor. Market animals will be terminated at resale market price as posted on auction day.
- 17. Buildings will be closed during judging.
- 18. Best of show or Judge's Choice will be selected from first placings only.
- 19. Only fully trained service dogs will be allowed on the grounds.
- 20. NO WHEELIES, NO BICYCLES, NO SKATEBOARDS, NO SCOOTERS or RECREATIONAL VEHICLES OF ANY KIND.

STATE RULES

21. State Rules for California Fairs are incorporated by this reference and will be enforced. State Rules are available on the California Department of Food & Agriculture website, the Salinas Valley Fair Website and a copy is on file at the Salinas Valley Fair Livestock Office. www.cdfa.ca.gov/fairs & expositions

2022 JUNIOR LIVESTOCK RULES

2022 Entries will be accepted ONLINE ONLY by April 1st

Please read this Exhibitor Guidebook carefully!

Division Areas

You must be a Primary Residence as well as a Club Member of the following areas;

Local:

Residents and members of 4-H Clubs and FFA Chapters located in Monterey County (including Parkfield 4-H), Santa Cruz County, and San Benito County

Extended:

Residents and members of 4-H Clubs and FFA Chapters located in Northern San Luis Obispo County, located within the Atascadero, Templeton, Shandon, Paso Robles and Santa Margarita High School District. *Districts North of the SLO Grade*

Livestock Entry Limits

Large market animal classes will be limited as follows:

- A. Local areas can take no more than one of the following
 - 2 Steers (or)
 - 1 Steer, 1 Heifer (or)
 - 2 Heifers (or)
 - 1 Steer & 1 Feeder (or)
 - 1 Heifer & 1 Feeder (or)
 - 2 Feeders (or)
 - 1 Hog or
 - 1 Lamb or
 - 1 Goat
- B. Extended areas can only take one of the following
 - Beef- Same as Local Areas (or)
 - 1 Lamb or
 - 1 Goat
- C. Rabbit & Poultry Classes
 - A. Rabbit Breed Show is open to all youth in the State of California, area limits do not apply.
 - B. Exhibitors from Local & Extended areas are limited to 2 Rabbit & Poultry Market/Meat pen entries, only Champion & Reserve Champion meat pens sold in the Junior Livestock Auction, *see class rules*.

FFA MEMBERS

1. FFA members must be enrolled in a high school vocational agricultural class to be eligible, and may exhibit as FFA members through the end of the calendar year following graduation.

4H MEMBERS

2. 4-H members must be 9 years old or in the 4th grade, as of January 1st. A member may show in 4-H through the calendar year they turn 19. If they turn 19 in December, they are not eligible to compete at the following Salinas Valley Fair.

INDEPENDENT EXHIBITORS

- 3. Non 4-H/FFA/GRANGE Junior Exhibitors of market animals will show and be judged in a class assigned by fair management. In order to qualify as an Independent Exhibitor, you cannot have been registered as a 4-H/FFA/Grange member for 2 full years prior to this year's fair. This rule is in place to keep exhibitors from "club hopping" to avoid an organization's rules and regulations. Exhibitors must be at least 9 years old or in the 4th grade on January 1st. Exhibitors are eligible to compete/exhibit through the calendar year they turn 19. If they turn 19 in December, they are not eligible to compete in the following SVF.
 - Independent Juniors entering a market animal must provide Fair Management with a picture, permanent tag and/or tattoo information 120 days prior to the fair for beef and 60 days for sheep, goats & swine.
 - Independent exhibitors must have all record books in order at weigh-in and supply emergency phone numbers of parents/guardians. No record book, no show.

ELIGIBILITY

- 4. An exhibitor must be in good standing with their 4-H/FFA/Grange chapter. A list of exhibitors will be emailed to the Leader/Advisor for verification. The Advisor or Community Leader has the final say on the exhibitor's participation, until the moment the exhibitor crosses the scale. At that time, the exhibitor is contractually obligated to show, receive a grading and sell the animal at the Salinas Valley Fair Terminal Junior Livestock Auction.
 - *Livestock entries will not be accepted if a family member purchased or acted as a buying agent for a market animal at any previous livestock auction and has not paid Salinas Valley Fair for the animal, before December 31st of that year.

BREEDING OWNERSHIP REQUIREMENTS

 Original registration certificates or duplicates (no photocopy) issued by a breed association showing sixty (60) day ownership, must be presented to the livestock office on check-in day. No partnerships are allowed in breeding projects excluding rabbit and poultry.

MARKET OWNERSHIP REQUIREMENTS

6. Date of ownership is defined as the date printed on the bill of sale, as well as the exhibitor's sole care and management of the market animal, within the ownership dates listed at the front of this guidebook.

TRANSPORTATION

7. Transportation permits for beef entries will be given to leaders prior to fair along with the ear tags. Beef must be ear tagged prior to weigh-in. All brand inspections, bill of sales, and out-of-state health inspection papers must accompany beef animals on weigh-in day.

WEIGH-IN

- 8. Market livestock will be classified by weight determined on weigh in day. The scales will close from noon to 1 pm for lunch.
- 9. All animals must be brought across the scale by an exhibitor. The Director or Department Supervisor will have the right to refuse any animal considered too wild for the safety of all concerned. Such animals will be removed immediately from the grounds and will not be allowed to show.
- 10. All market animals over/under weight will not be qualified for show and must leave the fairgrounds immediately.

- 11. **NO RE-WEIGHS** will be permitted unless the scale is in question. In this case, a re-weigh will be given immediately after balancing the scale.
- 12. Documentary proof of ownership such as Bill of Sale, (made out to exhibitor) must be available at weigh-in upon request.
- 13. No private scales of any size will be allowed on the fairgrounds during fair time.
- 14. SVF Medication Declaration form must accompany animals on weigh-in day.
- 15. Animals are to be weighed in prior to penning. Beef may be penned prior to weighing. All animals are to arrive 'show ready'.

POSTING OF CLASSES

16. Lists will be posted daily in each species area of the barn, located on the tripod. Market classes will be broken by weight and showmanship classes will be broken by experience and age. See "Showmanship" in the guidebook for specifications. It is the exhibitor's responsibility to read these posted lists. If an exhibitor believes they are in the wrong class, please notify the clerk or the Livestock Office immediately.

PEN DECORATIONS

CLEAN STALLS & BEDDING

- 17. **Decorations are optional and do not count towards Clean Stall Awards.** Decorations must be installed by Saturday, May 7th between 10:00 am 4:00 pm. Stanchions and beef blocking chutes may be unloaded when your animal arrives on grounds. Weigh-in day is primarily for the arrival of the animal. The fair is not responsible for loss or damage of any items. Decorations and kickboards may not be taken down until 3:00 pm on Sunday of the fair.
- 18. Bedding for all stalls and pens will not be provided. Bedding material must be shavings for all animals; however, beef may use straw or shavings. L. A. Hearne Co. will be on grounds with bedding and feed for purchase.
- 19. Feed, bedding, tools and other show equipment must be stored in your assigned tack pens. Exhibitors are to provide their own wheelbarrow and/or tools. Pens and stalls will be kept clean at all times. The aisles in all barns are to be clear of grain, hay, manure and bedding. Animals must be groomed and in show condition when the fair is open to the public. Manure must be deposited in designated areas. Awards may be withheld if exhibit areas are not kept clean or if animals are not fed, watered or cared for while at the fair. (See Red Tag Policy) Stalls will be checked daily and clean pen award results posted not later than 5:00 p.m. Points will be compiled by the Danish System on clean stalls.

GROOMING & WASHING

- 20. Junior exhibitors must groom and fit their own animals. This will include rabbit exhibitors. See state rules section vii rule #31.

 Professional groomers and fitters are not allowed and parents are not allowed to fit. All market and breeding animals must be in show condition on weigh-in day.
- 21. The Beef show is a Slick Shorn Show in 2022- See below for details.
- 22. Exhibitors may have assistance with showing if the exhibitor has more than one entry in a class or has a physical need. A request must be made in writing or by email to the Livestock Office prior to the start of the fair. The assistant must be in the same organization, and must be in appropriate uniform.
- 23. All washing operations will be performed in wash racks. Show rings will not be used for tying, feeding or drying animals.

 Blocking of lambs will be allowed only in designated blocking areas, stanchions must be placed outside the barns and only on the South facing side of the barns. No fitting of lambs or goats in wash racks or aisles.
- 24. The water conservation policy will continue into 2022. <u>NO washing of animals on Friday, Saturday and Sunday of fair.</u> All hoses at wash racks will be required to use a shut-off nozzle
- 25. All animals must be kept in the livestock area at all times.
- 26. Remember, the only impression many people ever receive of you, your project and your Club or Chapter, is the one they receive at the fair. Be certain that nothing about your exhibit or your conduct detracts from that impression. Continued growth and success of our fair depends upon continued public interest and support. Incidents of bad conduct will not be tolerated. Exhibitors guilty of a display of bad conduct will be sent home. Premium money will be withheld and the exhibitor will not be allowed to show at the fair again. Police will be notified if necessary.

27. False tail switches, tail fins, or any hair like substance or flocking added to the animal's body, or any grooming materials that allow color to come off the animal will not be permitted.

BEEF SLICK SHEAR SHOW

28. Prior to arrival of the show, steers must be pre-clipped to no more than ¼" of hair on any part of the body, except the ears and tail switch. (The Tail Switch being not more than 12" above the end of the cartilage of the tail). Tail Switches clipped to no more than 6" & may be ratted and balled or may be bobbed off. No clipping will be permitted on grounds, and **NO PROFESSIONAL FITTERS or parents** may assist in staging or pepping of the animal. False tail switches, tail fins, or any hair like substance or flocking added to the animal's body, or any grooming materials that allow color to come off the animal will not be permitted.

DAILY FEEDING TIMES & NIGHTLY CURFEW

29. Daily feeding times: 6 am - 8 am & 5 pm - 8 pm. This rule also applies to stall and pen cleaning. Curfew in the livestock area will be 9 pm at which time there will be no admittance by exhibitors, parents, or visitors into this area. This will be strictly enforced.

RED TAG POLICY

- 30. Livestock exhibitors are solely responsible for the care of their animals while on exhibit at the Salinas Valley Fair. If a Salinas Valley Fair Livestock Director or Livestock Superintendent becomes aware of any livestock exhibit that is not being cared for in an ethical, humane manner or situations where an acceptable state of pen cleanliness, as determined by the livestock management staff and/or Livestock Director, is not being maintained, the following will occur:
- A. The Salinas Valley Fair Livestock Director, overseeing the species of animal in question will determine the name and affiliation of the responsible exhibitor.
- B. The Salinas Valley Fair Livestock Director will notify the Livestock Superintendent of the responsible exhibitor to obtain a Red Tag and at such time the Livestock Superintendent will record the violation.
- C. A Red Tag, with the following information will be affixed to the exhibitor's pen/stall.
 - a. The exhibitor's name
 - b. The observed problem
 - c. The date and time of the citation
 - d. Signature of the responsible Livestock Director & Livestock Superintendent
- D. It is the exhibitor's responsibility to respond to the Red Tag by contacting, first, the Livestock Director and then the Livestock Superintendent within six (6) hours of the citation. The responsible Livestock Director and Livestock Superintendent will record the time at which the exhibitor responded to the red tag violation. The exhibitor will formulate and initiate a plan of correction approved by the responsible Livestock Director. Reasonable efforts will be made by the responsible Livestock Director to contact the exhibitor's FFA advisor, 4-H Leader, Parent or Designee and advise them of the situation resulting in the Red Tag citation.
- E. Any exhibitor failing to make contact with the livestock superintendent within six (6) hours of issuance of citation may be issued an automatic second Red Tag citation.
- F. Any exhibitor receiving two (2) Red Tag citations during the Fair will be declared ineligible for further competition. If the animal is a market entry, the animal will be sold in the terminal Jr. Livestock Auction at current market price. The exhibitor will forfeit all add-ons & awards. If the animal is a breeding show animal, the animal will be removed immediately.

RELEASE OF LIVESTOCK & LIVE PICK-UP

31. Live pickup is Sunday at 4:00 p.m. No animal can leave the fairgrounds before 4:00 pm. Walk out tack not to leave before 3:00 p.m. on Sunday. Vehicles entering the fairgrounds to pick up breeding livestock must enter at the Canal Street gate and the exit at the San Lorenzo Street gate. A group of vehicles will be permitted to enter, load, and exit before the next group of vehicles will be permitted to enter the fairgrounds. This will facilitate better access to driveways and loading chutes for faster removal of livestock exhibits. Please comply with fair staff and security in this matter. Absolutely no vehicles are permitted on fairgrounds before 4:00 p.m. Sunday, to pick up tack or animals.

SICK OR AILING ANIMALS

32. If an animal is in need of immediate care, SVF does not have a veterinarian on call. The livestock office will have a list of Veterinarian's the exhibitor may call; however, the exhibitor must assume the expense of the Veterinarian's service.

In the event that an animal is in need of immediate care, and the owner/exhibitor and leader/advisor is unreachable, the owner extends authority to take such action as deemed expedient and necessary, to the fair management. Fair management has power of attorney for the exhibitor in this instance and by virtue of signing the original entry, the Salinas Valley Fair will not assume any cost for action taken pursuant to this rule.

VIOLATION OF RULES & DISQUALIFICATION

- 33. Errors made on a livestock online entry may result in disqualification or a \$100 fee. Scrapie Tag I.D., breed, sex and birthdates are all important information that is recorded and kept on file for the USDA to inspect at any time. Records must be accurate. Incorrect information on an entry form will also appear as cheating.
- 34. Abuse of animals by exhibitors or handlers is grounds for disqualification.
- 35. Violation of rules and/or misconduct by any exhibitor, adjudicated by the on-the-spot committee, may result in forfeiture of premium money and/or nullification of proceeds from sale through the Junior Livestock Auction and return of animals to that particular exhibitor. All market animals will be terminated and sold at market price as posted on the day of livestock auction.
- 36. Exhibitors are urged to remember that the continued growth and development of the fair depends, in a large measure, upon the interest and support of their fair-going neighbors and the general public. For this reason, exhibitors should assist the fair management by keeping exhibits and displays clean, neat and attractive. Awards may be withheld if animals are not fed, watered and cared for while at the fair. See RED TAG Procedures.

PROHIBITED SUBSTANCES

- 37. The use of stimulants or depressants will not be permitted. **Important:** All market animals are subject to inspection for Drug Residues. Animals containing unauthorized residues will be condemned and the parties responsible for these residues are subject to prosecution under the Food, Drug and Cosmetic Act. Offenders will be banned from any future Salinas Valley Fair.
- 38. Any exhibitor with a market animal that does not pass the random drug test inspection, will forfeit all auction proceeds and will no longer be welcome to show at any future SVF events. Salinas Valley Fair takes the health and wellbeing of our community and consumers extremely seriously.

PARKING

39. All parking passes will be sold on a first come first served basis. Leader & Assistant Leader Passes must be purchased through the website (salina.fairmanager.com) & will come with a parking permit for the Canal Street parking lot and the 101 Bowl parking lot. Parking will be enforced by security. Anyone needing a trailer may purchase a Trailer Parking Pass for \$100 to park in the 101 Bowl parking lot. Any vehicle or trailer parked without a parking permit will be towed at the owner's expense. All camping spots are first come first served and must be purchased at the front office.

FFA & 4-H SHOWMANSHIP GENERAL RULES

EXHIBITORS MUST PRE-ENTER ONLINE ONLY BY APRIL 1st

- 1. Showmanship is mandatory for all animals entered into market classes, excluding Poultry & Rabbit Meat Pens. A \$25 fine for any exhibitor that is a No Show in their showmanship class. If an exhibitor has a valid reason they cannot participate in showmanship, they must notify by writing or email the Livestock Office asap with a request to livestock@salinasvalleyfair.com.
- 2. Age to be used is the age as of January 1st.
- 3. Horse showmanship will be judged in accordance with the score card printed in the 4-H Horse Manual.
- 4. All exhibitors are required to wear the official show uniform of the organization they represent.
- 5. Independent Junior exhibitors will dress in whites.
- 6. Independent Junior exhibitors will compete in the age appropriate showmanship class.
- 7. Premiums are offered for 4-H/FFA *Senior* **Showmanship** only:

1st 2nd 3rd Buckle \$20.00 \$10.00

- 8. You must show your own market animal in showmanship.
- 9. Showmanship class definitions:

A. 4-H NOVICE SHOWMANSHIP

1st year exhibitors who have never shown this species. Top 3 Progress to Jr.

B. 4-H JUNIOR SHOWMANSHIP

All exhibitors 10-13 years of age, who have shown this species at a fair. Top 3 progress to Sr.

C. 4-H SENIOR SHOWMANSHIP

All exhibitors age 14-19 years of age, regardless of showmanship experience.

D. FFA NOVICE SHOWMANSHIP

Exhibitors have never shown this species of animal at any fair. Top 3 progress to Sr

E. FFA SENIOR SHOWMANSHIP

All other FFA Exhibitors

Show Uniform

Complete uniform of the exhibitors organization is required. You may be disqualified if your uniform is incomplete or incorrectly worn.

FFA Uniform- This uniform shall be worn by FFA exhibitors and helpers while showing livestock. The uniform shall consist of white trousers, white dress shirt with an emblem attached to the left pocket and official blue necktie for boys or official blue scarf for girls. The Official FFA jacket is optional; if worn, the shirt emblem is not required. Hats or headgear of any kind shall not be worn with the official show uniform while showing, except equestrian helmet. Footwear and belts need to be clean, if boots are worn they must be inside and covered by the pant leg. No sandals allowed, and tennis shoes are discouraged. No covering up of the official uniform in the show ring.

4H Uniform - This uniform shall be worn by all 4-H exhibitors and helpers while showing livestock. Uniform shall consist of 4h cap worn on the head, white shirt or blouse with 4H collar for girls & a 4-H necktie for boys. Trousers may be black or white, no denim color or acid wash allowed, girls may also wear black or white skirts. Footwear and belts need to be clean, if boots are worn they must be inside and covered by the pant leg. No sandals allowed, and tennis shoes are discouraged. No covering up of the official uniform in the show ring.

Independent Uniform- Independent Jr. Exhibitors are required to wear the official 4-H uniform, excluding the cap, collar or tie.

Round Robin Showmanship

John Orradre, Director

- 1. Only 1st & 2nd place 4-H Junior/FFA Novice & Senior showmanship winners are eligible for Round Robin.
- 2. Exhibitors must sign up before leaving the show ring, by notifying the clerk.
- 3. An exhibitor may not enter both FFA & 4-H Round Robin Showmanship.
- 4. Each participant may show up to eight (8) animals, and must acquire all necessary equipment to show each species.
- 5. Once Round Robin has begun, exhibitors are prohibited from any public communication, with parents, leaders and surrounding audience members.

4-H JUNIOR & FFA NOVICE ROUND ROBIN SHOWMANSHIP

First Place Award

Ribbons 1st - 6th place

This class is open to the first place 4-H junior & FFA novice showmanship winners of each livestock division; Beef, Sheep, Swine, Dairy Goats, Meat Goats, Rabbits, Poultry & Horses. Horses, Dairy Goats & Poultry will not be shown in the Round Robin Showmanship. If the first place junior winner also wins first place in senior showmanship, the exhibitor will have the option to enter junior or senior Round Robin. The second place exhibitor in that species will then be eligible for the 4-H junior Round Robin. Exhibitors who qualify for Round Robin must notify the clerk before they leave the show ring or be considered a forfeit.

4-H & FFA SENIOR ROUND ROBIN SHOWMANSHIP

First Place Award Ribbons 1st - 6th

This class is open to the first place 4-H & FFA senior showmanship winners of each livestock division, Beef, Sheep, Swine, Poultry, Rabbits, Horses, Market & Dairy Goats. Horses, Dairy Goats & Poultry will not be shown in round robin showmanship. Exhibitors who qualify for Round Robin must notify the clerk before they leave the show ring or be considered a forfeit.

- 1. Exhibitors may not currently be enrolled in 4-H.
- 2. Classes are open to ages 5-6 & 7-9 years old.
- 3. Showmanship classes consist of Sheep, Goats & Swine.
- 4. Exhibitors must make their own arrangements to show an animal provided by another exhibitor prior to entering the show ring.
- 5. No uniform of any kind or open toed shoes.
- 6. Parents/Guardians are not allowed to assist inside the show ring.
- 7. Each species shows in it's own show ring. (Goats in the Goat Show ring)

JUNIOR LIVESTOCK AUCTION SALE

SATURDAY, MAY 14, 2022 – 8 AM CODY BASSETTI, Director

- 1. This is a terminal sale. All animals that cross the scale on weigh in day, become contracted to sell at the Junior Livestock Auction of the Salinas Valley Fair, with the exception of replacement heifers and poultry. No animals will be allowed to scratch from the auction. Only replacement heifers will be sold for a live pick up. All Group I, II & Group III steers will be sold in the auction. It is the exhibitor's responsibility to continue providing care for their animal, until 4 p.m. Sunday of the fair.
- 2. All Champion animals must be walked through the auction by the original exhibitor. If any exhibitor has a medical or family emergency, they may submit a letter to the Livestock Committee requesting a replacement exhibitor to walk their animal through the auction, approval is not guaranteed.
- 3. If the exhibitor is not with their animal by the time their auction lot begins, the animal will be scratched from the auction sales list. Any market animal exhibitor found to be in violation of rules and/or misconduct, adjudicated by the "on-the-spot" committee, will be scratched from the auction sales list.
- 4. Any market animal scratched from the Livestock Auction Sales List, except an emergency, will still be required to sell at the Posted Resale Price and will be harvested through the terminal Junior Livestock Auction.
- 6. Auction checks will be available for pick up Wednesday, July 27, 2022, to Project Leaders only. This date was chosen based on the reality that Auction checks cannot be issued until the majority of buyers have paid their auction bill in full. We thank you for your understanding.
- 7. Selling charges collected on all livestock sold through the SVF JLA:
 - A. SVF Commission 8%. (Auction & Add Ons)
 - B. Ca. Cattle Council Fee \$1.00 (Steers)
 - C. Ca. Beef Council Fee \$1.00 (Steers)
 - D. Pork Board Fee .0045 x the gross price (market hogs)
 - E. Lamb Council Fee .005 x times the total weight (sheep)
 - F. Photo Fee \$14.00 (two 5"x7" color pictures of the exhibitor and animal- All Market Exhibitors)
- 8. Exhibitors Photo Fee will provide the exhibitor with 2 professional photos. One photo shall be provided to your buyer along with their "Thank You" letter before receiving auction monies from advisors or project leaders. Seller/Buyer/Add-On information will be provided to the project leaders.
- 9. All market animals are subject to inspection for Drug Residues. Animals containing unauthorized residues will be condemned and the parties responsible for these residues are subject to prosecution under the Food, Drug and Cosmetic Act. Any exhibitor with a market animal that does not pass the random drug test inspection, will forfeit all Auction Proceeds, Add-Ons & Awards, be liable for 3 times the amount the animal was sold for in the JLA and will no longer be welcome to show at any future SVF livestock events. Salinas Valley Fair takes the health and wellbeing of our community and consumers seriously.
- 10. Beef cattle sold at Auction MUST be accompanied by a Brand Inspection Certificate or bill of sale as proper proof of ownership.
- 11. Junior livestock entries will not be accepted, if family member purchased or acted as a Buying Agent, for a market animal at any previous livestock auction and has not paid Salinas Valley Fair for the animal.

Livestock will be sold in the following order, but subject to change:

Ring A - Odd lot numbers

Ring B - Even lot numbers

Hogs, Heritage Animal, Champions (Including Rabbits & Poultry) Heifers, All Beef, Lambs Hogs, All Goats, Lambs

Note: Sale order is subject to change with management decision

- 12. In each species, auction sales are Group 2 (Red Ribbon), Champions, Group 1 (Blue Ribbon). All animals, especially champions must be sold through the Junior Livestock Auction. Only the Grand and Reserve Grand Champion 4H & FFA animals will sell for Poultry and Rabbit Meat Pens.
- 13. A stall card bearing the name of seller, name of buyer will be provided to each seller for display with the animal for the duration of the Fair. The stall card is not the official sale document. The buyer's receipt/sale contract is the only official sale price and document. All group 3 (excluding beef), white ribbon, not market ready animals, will not be permitted to go through the auction and must be live pick-up only at 4 pm on Sunday of the fair.
- 14. Qualified registered buyers may add an additional amount to the purchase price of a seller's lot. "Add-on" buyers will not have ownership of the lot. Buyers should refer to the Salinas Valley Fair sale catalog for restrictions, minimums and purchase procedures for auction sale add-ons. Salinas Valley Fair will charge a 8% administrative fee for all add-ons to the seller.
- 15. 2022 Sale order within each species will be in alphabetical order by club, starting with clubs that begin with the letter C. This gives the clubs who sold first in the last 2 consecutive auctions a chance to rotate. Hogs, beginning with clubs C, Beef beginning with clubs C, etc.

1. BEEF SLICK SHEAR SHOW- 2022

Prior to arrival of the show, steers must be pre-clipped to no more than ½" of hair on any part of the body, except the ears and tail switch. (The tail switch being not more than 12" above the end of the cartilage of the tail). Tail switches clipped to no more than 6" & may be ratted and balled or may be bobbed off. No clipping will be permitted on grounds, and **NO PROFESSIONAL FITTERS or parents** may assist in staging or pepping of the animal. False tail switches, tail fins, or any hair like substance or flocking added to the animal's body, or any grooming materials that allow color to come off the animal will not be permitted.

- 2. One (1) ear tag per animal will be sent to exhibitors prior to fair. If a tag is lost, a replacement tag will be issued when the animal arrives at the fair. Please call ahead if the tag needs to be replaced.
- 3. Brands and Brand Location or "No Brand" must be marked on entry for Market Steers.
- 4. No dairy breeds may be entered in the market beef divisions. Example: Holstein, Jersey, Brown Swiss.
- 5. Steers will be divided into weight classes & all breeds will show together.
- 6. All overweight and underweight steers must go home immediately and cannot stay on the grounds.
- 7. No generators inside the barns.
- 8. **Grooming Chutes** Exhibitors must purchase a \$20 Grooming Chute Pass for each chute they intend to bring. Passes must be purchased online & found in the Passes & Credentials Department. Any Chute passes purchased after the April 1st deadline, will be at a cost of \$30 for each chute. Chutes must be placed in the designated area, outside on the South side of the barn with the provided flag.

- 9. **Decorations, and kickboards** must be installed 10 am 4 pm Saturday, Still receiving day, prior to the start of the fair. Weigh-in day is for tack & animal drop off only.
- 10. Sunday, tear down may begin at 3 pm and be walked out of the gate. Drive in begins at 4 pm.
- 11. No Shows- Any Beef animal entered into the SVF, that does not show up, or does not notify the SVF 20 days prior to weigh-in day, will be assessed a \$50 fine, unless accompanied by a vet notice. All stalls assigned to no-show animals, will be forfeited.
- 12. Steers must be no older than 28 months and may not display their 2nd set of teeth. Teeth will be checked at Harris Ranch and the carcass may be rejected.
- 13. A health check will be performed by a Veterinarian at the scale prior to weigh-in.

MARKET BEEF SCORECARD GRADE

- **GROUP 1:** Animals grading USDA Prime or Choice in quality grade: having superior and **above average** conformation and cutability. Yield Grade 1 or 2.
- **GROUP 2:** Animals grade USDA Prime or Choice in quality grade: having **average** conformation and cutability. Yield Grade 1, 2, or 3. Animals grading USDA Select + in quality grade; having superior conformation and cutability. Yield Grade 1 or 2.
- **GROUP 3:** Animals grading USDA Prime or Choice in quality grade: having **below average** conformation and cut ability. Yield Grade 4 and 5. Under finished animals that are average or below average in conformation: grading Select + or lower in quality grade and will not be sold in the auction.

RULES

- 1. All market steers sold through the Salinas Valley Fair Junior Livestock Auction will be automatically entered into the Carcass Contest.
- 2. Carcasses will be graded by the time of slaughter by USDA graders and the results compiled in cooperation with the Agricultural Extension Service.
- 3. To be eligible for cash awards, steers must not have more than one pair of permanent incisor teeth showing and the carcass must have a USDA quality grade of select plus or better.
- 4. Placing will be based on USDA yield and quality grades. The actual mechanics of applying these principles will be as follows:
 - **a**. Yield of boneless retail cuts to the nearest 0.1% will be determined from USDA yield grades.
 - **b**. Quality grades will be determined to the nearest one- third of a grade under current USDA standards.
 - **c**. Subtract 0.8% from the estimated yield of cuts for each one-third grade quality difference from high prime. This combines the yield and quality factors into a carcass index.
 - **d**. Ties in the carcass index will be broken by dividing ribeye area by hot carcass weight, and those with higher values will be ranked first.
- 5. Carcass Awards Presentation dinner is June 21, 6 pm, at the Salinas Valley Fairgrounds Orradre Building. Please RSVP to livetock@salinasvalleyfair.com. *Only carcass awards will be available for pick up*. Auction checks will be available for pickup on July 27th, by project leaders only.

- 2. The exhibitor must have had ownership of the heifer by January 1, 2022. A bill of sale and brand inspection certificate is required at the scale as proof of ownership.
- 3. If a breeding or health problem occurs, a substitute heifer may be allowed if it is owned by the exhibitor by March 1, 2022 and is approved in writing by the Salinas Valley Fair.
- 4. The age limit for heifers is a minimum of 20-28 months old on opening day of the fair.

- 1. Entries are NOT limited to two entries per class per division except where specified. See State Rules for limits on cash awards.
- Rules, definitions and judging procedures as prescribed in the latest edition of the Guide Book and Standard of the American Rabbit Breeders Association, Inc. shall apply to all District and County Fair rabbit shows, provided they do not conflict with any rules and regulations prescribed by the Department of Food and Agriculture.
- 3. Rabbits must have a legible, permanent number, symbol, letter or series of either, or both, tattooed in its left ear, which must correspond with those on the entry form. Rabbits not legibly earmarked are to be eliminated from the class.
- 4. Any duplication of ear markings by one exhibitor in the same Breed and Class will not be allowed. Entries with duplicate ear numbers will have one of those rabbits eliminated. The entry fee will not be returned.
- 5. Animals will be shown and judged in show room divisions recognized by the ARBA.
- 6. Long sleeve shirts are required during showmanship.
- 7. It is the responsibility of the exhibitor to take the rabbit to the show table when the class is called for it to be judged. Those rabbits absent at the time of judging do not count when computing the number of rabbits in the class.
- 8. Exhibitors must not be older than 18 years old on show day of the Fair. The day they turn 19, they are ineligible.
- 9. The exhibitor is to check the show cards at the beginning of the Rabbit Show and report any discrepancies to the Show Secretary immediately. No changes will be allowed during the show. Substitutions can only be made within the same division, sex variety and class. This must be received in writing five days prior to the show date.
- 10. Pedigree papers or a Bill of Sale showing the required ownership period (30 days) may be used instead of a pedigree if ear number and other required entry information are shown on the Bill of Sale. This should be available upon request the day of the show.
- 11. Animals used in showmanship must belong to the exhibitor and be entered in one of the rabbit breed divisions. Highest placing 4-H Junior & 4-H Senior & FFA Novice & FFA Senior winners may advance to Round Robin competition. (Round Robin only 4-H & FFA exhibitors are eligible)
- 12. Primary 4-H members may show in the rabbit department as long as the exhibitor is in kindergarten or five years old by January 1st. Ribbons only. No premiums.
- 13. Junior exhibitors are expected to groom and care for their animals when at the Fair. Adults should refrain from assisting the junior member. Local Fair rules will determine enforcement.

- 4. All birds must be identified by leg bands conforming with the information on the entry form, on arrival at the show. The Entry Office must be notified of any changes before 5 pm April 1st. No changes will be made on the day of Judging
- 5. All entries must pass poultry inspection before being cooped in.
- 6. Primary exhibitors may show poultry as long as the exhibitor is 5 years old by January 1st.
- 7. No birds under 6 months of age

*** SPECIAL POULTRY NOTICE: ***

Because of California State Poultry Health Regulations, all birds entered in the Fair must first pass through a certified poultry health inspection before being placed in their show cages. A special inspection site will be placed on the fairgrounds and birds must pass through this station before entering the poultry building. A notice will be sent to each exhibitor entered in the show, giving the location of the inspection station.

The Salinas Valley Fair remains committed to hosting a quality poultry exhibition. Health checks are mandated by the Division of Fairs & Expositions and will be performed by certified Poultry Health Inspectors (PHI) from one of the designated CDFA/UC certification Programs. The PHI will evaluate the health and condition of every bird entered. As a result, coop-in times may be delayed. Look for signs when you enter the fairgrounds as to where to take your bird(s) for the examination – DO NOT proceed to the poultry barn until your bird(s) have been examined. Please make sure you carefully examine each bird before you leave home and follow your regular cleaning procedures. Any birds that show signs of illness, stress, or are not in top quality condition will not be allowed to enter the show. Birds with wing feathers or any other feathers that have been clipped or trimmed will be disqualified.
