To ensure the highest degree of integrity and the safety of our food supply, the North Idaho State Fair reserves the right to disqualify any animal that fails to meet the provisions of the 2023 North Idaho State Fair Exhibitor Handbook (Fair Book) including but not limited to the National Show Ring Code of Ethics, NISF Youth Stock Show and Sale, and Unethical Fitting/Prohibited Substance, Unapproved Drug Use, Approved Drug Use, Drug Testing Policies and Rules. By signing below, I acknowledge receipt of these documents.

ACKNOWLEDGEMENT OF SHOW AND SALE RULES, as a Parent or Guardian on behalf of my exhibitor:

1. My submission of a livestock entry expressly binds me to all terms and conditions contained in any and all parts of the North Idaho State Fair Youth Stock Show and Sale Rules and Regulations to include but not limited to consent to drug, steroid, or tissue tests; examination of my animal's carcass; and insertion of a microchip or ear tag for identification as a condition of entering the North Idaho State Fair.
2. I acknowledge that it is my responsibility to obtain a copy of the North Idaho State Fair Youth Stock Show and Sale Rules, and to attend the mandatory Livestock Exhibitor Meeting to understand all general rules as well as specific rules pertaining to the project areas in which I am exhibiting. I further agree to abide by any terms set forth within said documents.
3. I understand that it is my responsibility for all additional project completion requirements to be met for the corresponding program I am enrolled in, or I may be ineligible to register for the same class the following year.
4. As a livestock exhibitor, I have completed a satisfactory Quality Assurance Training. Myself and my parents/guardians agree that we are responsible for the care and custody of our animals in preparation for and while at the North Idaho State Fair. Any animal not receiving proper care as outlined in the NISF YSSS Rules and Regulations, may be subject to immediate disqualification and removal from the grounds, and exhibitor may forfeit any awards, premiums, sale proceeds, and/or be banned from future registration to show at the NISF.
5. I have disclosed all medications, vaccinations, injections, medical treatments, and all other foreign substances administered to my exhibit animal(s) by myself or others on the attached Animal Husbandry Form. **Each individual market animal must have its own Animal Husbandry Form.**
6. My market animal has not been maintained at a professional fitter's facility and has been in my continuous ownership since the deadline for possession and ownership at initial weigh in date for my animal, and I have been directly responsible for the care and feeding of my animal(s)
7. I am responsible for adhering to withdrawal times on all drugs administered to my animal; only giving my animal FDA approved drugs; and keeping my animal free of illegal drugs prior to and during the North Idaho State Fair. I also understand that listing any substance on this form (animal husbandry) that violates the NISF YSSS Rules and Regulations does not release me from the penalties associated with the violation.

I swear or affirm that I have read, understand, and accept the above statements to be true, accurate and complete. I further affirm that the animal(s) listed on the Animal Husbandry Form was/were born, fed, and raised in the USA. Failure to comply with rules and policies may give grounds for legal action associated with the violation and financial fees associated with damages incurred.




The NISF YSSS is committed to the humane treatment, appropriate management, safe exhibition of all animals exhibited at the fair, and every possible precaution is taken to ensure the animals' safety and well-being. All livestock exhibits are subject to inspection and evaluation for signs of unethical fitting, and the NISF YSSS reserves the right to question the alteration of any animal's physical or physiological structure.

In the chart below, please identify ALL medications, vaccinations, injections, medical treatments, and any foreign substances administered in any form or manner from the Animal Ownership Deadline for the corresponding species through the final entry. Any medications, injections, medical treatments administered on-site during the North Idaho State Fair Youth Stock Show and Sale will be documented with the official Fair Veterinarian.

Complete the information requested for **each** North Idaho State Fair livestock entry. Every livestock exhibitor must submit a notarized Animal Affidavit form for the 2023 NISF YSSS along with all completed Animal Husbandry forms before crossing the scale at entry.

If the information provided does not match carcass findings or drug test results, you may be disqualified and be subject to penalty according to the North Idaho State Fair Youth Stock Show and Sale Rules and Regulations in the Exhibitor Handbook/Fair Book including but not limited to forfeiture of titles and awards, premiums, sale proceeds, and restrictions on future participation in the North Idaho State Fair. All state livestock laws shall apply in addition to NISF YSSS rules and regulations.
