RULES

- 1. All market broiler entries are subject to the Fort Bend County Fair Association General Rules and Regulations and the Livestock General Rules and Regulations.
- 2. For an exhibitor to be eligible for the Fort Bend County Fair Broiler Show, the exhibitor must order their broiler chicks through the Fort Bend County Fair Association. Only wing-banded birds will be allowed to show.
- 3. All animals shall remain in Fort Bend County, at the address listed on the exhibitor's registration form, under the daily care of the exhibitor. Fort Bend County Fair projects are subject to random facility checks by Fort Bend County Fair officials. If an animal is found to be out of the county, during an official check, it will result in the project being disqualified from the Fort Bend County Fair. Animals will be allowed to leave the county overnight for shows, grooming or hoof trimming. Any animal needing to be absent from Fort Bend County for more than 72 hours must notify Fair Office to obtain approval from the Species Chairman and/or Livestock Superintendent.
- 4. ***Prior to delivery exhibitors are required to submit their \$20.00 entry fee and poultry order online at https://fbcfa.fairwire.com no later than May 25, 2023 by 4:00 p.m. All paperwork (entry form, W9, and Release of Liability) must be submitted and completed by May 25, 2023. If paperwork is turned in/and or completed after 4:00 p.m. May 25, 2023, the Fort Bend County Fair will access a \$50.00 late fee*** No late orders will be accepted.
- 5. A minimum of twenty-five (25) chicks per exhibitor MUST be ordered. Additional chicks are to be purchased in lots of twenty-five (25) only. An exhibitor may order a <u>maximum of 100 chicks.</u> The broiler chicks will be a straight-run commercial type. A box of chicks will be eligible for the show only. Family orders/tagging will be allowed with each exhibitor being assigned a set of consecutively numbered chicks. Exhibitors in the family may ONLY exchange WHOLE sets but no intermingling of birds within the sets will be allowed.
- 6. Broilers MUST be ordered in the name of the exhibitor who plans to show the broilers at the Fort Bend County Fair. All exhibitors must submit an online entry/order and paperwork. Family orders must be submitted through separate online entries/orders and on separate forms with all members listed on each form to be considered a family order.

- 7. Delivery date will be **Friday**, **August 18**, **2023**. **Location**, **delivery date**, and time will be confirmed via email to all exhibitors. It is the responsibility of the exhibitor to verify and ensure all wing bands are accounted for within his/her order, any missing/replacement birds shall be taken care of prior to the exhibitor leaving the pick-up location.
- 8. The broilers presented to the Judge/Sifter will be the exhibitor's "Official Entry". No alternate at official check-in time.
- 9. Evidence of tampering with wing bands will not be tolerated. The decision of the Broiler Committee is final.
- 10. Bruising due to wing bands will be disregarded. The judge's decision is final.
- 11. Broilers with missing wing bands will not be allowed to show.
- 12. Sick, diseased, or injured birds shall be refused entry into the arena at the judge's or chairman's discretion.
- 13. All exhibitors are required to bring two (2) 1 lb. coffee cans for feed and water per entry to be allowed to check-in. NO EXCEPTIONS!
- 14. Exhibitor is allowed to bring two (2) people to help hold the broilers during the show if needed. Those helping are not allowed to have any chapter/club affiliated attire being worn in the show arena.
- 15. One Showmanship award will be given to the exhibitor who has the best presentation of their livestock project proper handling of birds, following dress code, behavior in the show ring, etc. Showmanship will be judged during the Broiler Show by the Showmanship Judge. Only exhibitors showing their own project are eligible for showmanship.

16. Judge's decision is final.

- 17. Only the top two (2) placing pens of broilers will be required to remain in coops throughout the duration of the Fair for display. All others are required to check out immediately following the Broiler Show.
- 18. All non-placing Broilers must be removed immediately from the Fairgrounds following the show.
- 19. If your animal made the sale, you will be given a disposition sheet. This will advise you to whom and where to deliver your processed animal. Be sure to check with the buyer for preference of processing fresh or processed, frozen and bagged. Exhibitors are responsible for processing their own poultry.
- 20. Check out for all MARKET BROILERS making the Jr. Livestock Auction or the Freezer Sale will be on Sunday, October 8, 2023 from 7:30 a.m. to 10:00 a.m. as outlined in the Fort Bend County Fair Livestock Schedule. All exhibitors making either the Jr. Livestock Auction or the Freezer Sale MUST attend to clean up their pen/stall/area and receive their disposition papers.
- 21. All decisions are subject to change by the decision of the Fort Bend County Fair Board of Directors without prior notice.
