### Special Rules

- 1. A Professional Artist is one that shows or has sold artwork. Artists must be 18 years of age or older, a resident of New Mexico, and at least 1/4 Hispanic descent.
- 2. Artists who enter artwork in Hispanic Art Gallery may not enter artwork in African American Art, Fine Art, Native American Art Galleries or Non-Professional Art. See rules per art department.
- 3. All work submitted must be original. The New Mexico State Fair officials reserve the right to remove any work that is proved to be a copy.
- 4. Artists are asked to provide a completed W-9 upon registration in order for the Fair to process award premiums or art sales payable to artists.
- 5. Precaution is taken for the safety of all entries, but in no case, will the New Mexico State Fair, the State of New Mexico, employees, contractors or volunteers be liable for the loss or damages to any entry while in the Fair's possession. Artists are encouraged to carry their own insurance.
- 6. Artists are encouraged to visit our website at www.exponm.com for entry information. Entry cards will be available at time of entry or may be mailed to you by calling (505) 222-9738. Entry cards available after June 25, 2023. Cards must be filled out and signed by exhibitor.

- 7. Only 36 characters allowed including spaces in artwork title.
- 8. Out-of-town Artists may ship entries and arrive no later than August 10, 2023. Include 1 check payable to NM State Fair for entry fee along with completed entry cards and postage in the form of postage stamps for return shipping fee. Out-of-town entries must be shipped to:

- Each artist may submit up to four (4) original works of art. Work must be completed after October 1, 2022 except bronze sculptures completed after October 1, 2021 (and not submitted previously).
- 10. Artwork must be for sale. Artist must indicate price on the entry card. A 25% commission charge will be deducted from price stated by artist at time of entry on all work sold during the Fair.
- 11. Awards are given according to the artworks merit. At the discretion of the judges, award will not be given due to lack of completion in class entered.
- 12. Artwork will be juried by competent, non-competing artists, crafts people and/or qualified experts selected by the New Mexico State Fair Department. Artists whose work is not accepted will be notified by mail and those entries must be picked up on Saturday, August 19, 2023 between 9:00 AM - 4:00 PM at the Hispanic Arts Gallery.
- All wall art, prints and drawings must be framed and wired for hanging to qualify for the jury process.
  Wire must extend two inches below top edge of frame. Artwork may not be larger than 48" x 60", framed. Gallery style canvas wrapped sides must be painted as part of the artwork to be considered.

Hanging brackets or loops are not allowed on paintings, photography, drawings, etc. Leather Loops are allowed on Retablos. (Glass or Plexiglas may be used.)

- 14. The gallery uses "S" hooks; all Art work, Tinwork, Weavings and Retablos must have proper hanging hardware for proper installation; Size limitation is 48" x 60".
- 15. Photography entries must be original and entirely the work of the Artist. Commercial processing is allowed.

(a) Each print may be entered only once and may have not been submitted in subsequent years for competition.

(b) Prints are limited in size to a maximum of 600 square inches without frame (approximately 20" x 30"). Prints must be under glass or Plexiglas and ready to hang. Wire must extend two inches below top edge of frame.

Due to limited space, the jury may select three (3) qualified, mural sized paintings on canvas not to exceed 8' x 4'. To qualify, the following rules apply:

(a) Canvas sides must be painted as part of the art work to be considered.

(b) The piece must have proper hardware for installation. The gauge of the wire must support the weight of the piece to prevent damage to the art or injury to the public.

- 17. Sculpture: Maximum size limit 10' x 4' x 4' wide.
- 18. Multiple art entries entered as a set (clay, wood nativity sets, jewelry, small items, etc. must have one price on the entry card and sold as a set. These entries must be properly displayed, (ex. enclosed Plexiglas case, rigid base with velvet backing, jewelry box/stand, etc.) for judging. If possible, attach items to a base to prevent damage.
- 19. <u>NEW PLEASE READ:</u> Unsold artwork must be claimed upon presentation of entry card receipt Tuesday, September 19, 2023, from 9:00 AM 4:00 PM. Artists are responsible for picking up their own artwork or provide written authorization for pick-up by another individual, including entries which were mailed. Mailed entries will be returned in the same container received, provided shipping (postage stamps) was included with the entry. Any artwork/items remaining on the Fairgrounds after September 19, 2023 will be considered abandoned and shall become the property of the New Mexico State Fair to be disposed of at its discretion.
- 20. The New Mexico State Fair is a family-oriented event. Any artwork found to be offensive or in bad taste shall be removed by New Mexico State Fair officials.
- 21. Failure to comply with division rules will result in disqualification from judging process.
- 22. Artists recognize that marketing of the Fair and its grounds requires use of photography and video. Artist hereby expressly grants to the Fair the irrevocable, assignable right and license to take, use and publish Artist images and artwork without the need for any other approval. Artist images and artwork will not be used for profit.
