- Junior exhibitors must indicate age and have a parent and/or youth organization leader’s signature.
- Divisions and Classes will be judged under the American system and/or the Danish system.
 - American** – The judging process to rank exhibits against one another and award one first placing, one second, etc.
 - Danish** – The judging process to compare each exhibit on its own merit against the scorecard or recognized standard and award as many first placings, etc. as merited.

LOCAL RULES

1. San Joaquin County Fair will open its gates to the public on June 2 and close its gates to the public on Jun 4, 2023
2. Please carefully read all rules and regulations that pertain to your entry department.
3. Management reserves the right to limit entries according to space available and to eliminate/combine classes if insufficient entries are received.
4. State Rules, Health Rules and Score Cards for judging as prescribed by the Division of Fairs and Expositions apply to all entries of this Fair. A copy of the State Rules may be obtained at the local Fair Office, on our website or from the Division of Fairs and Expositions website. Questions can be answered by contacting the Administration Office at 1658 south airport way Stockton CA 95206, or call 209-466-5041. Submit entry forms as early as possible to ensure space for your exhibit. Official entry forms are available online: www.SanJoaquinFair.com. Office hours are 9:00 AM to Noon and 1:00 PM to 4:00 PM, Tuesday through Friday. No refunds will be made to exhibitors or organizations.
5. **PAYMENT OF FEES:** Online Entry Fees shall be paid by credit card only. Paper Entry Forms (still/non-livestock only) fees may be paid with cash or credit card in our office. **Checks are not accepted.** Entries will not be accepted until ALL fees are paid.
6. **PAPER ENTRY FORMS** (still/non-livestock only) must be postmarked on or before midnight for designated dates and times. All entry forms must contain correct names, mailing address (with proper zip code), telephone number, and, for Junior entries, the age of the exhibitor. Office staff will answer any questions you may have regarding your online entry.
7. All drapes, hangings, curtains, drops and all other decorative material, that would tend to increase the fire and panic hazard shall be made from non-flammable material or shall be treated and maintained in a flame-retardant condition by means of a flame retardant solution or process approved by the State Fire Marshal, as set forth in Sub Chapter 8, Chapter 1, Title 19, CAC. Exit doors, exit lights, fire alarm sending stations, wet standpipe hose cabinets, and fire extinguishers shall not be concealed or obstructed by any decorative material.
8. Exhibitors of animals, machinery in motion, and other exhibits that might cause accidents, injury, or damage to persons coming in contact with them shall guard their exhibits and protect the public. Every such exhibitor shall indemnify the 2nd District Agriculture Association from and against all claims and demands, costs, charges, and expenses which it may incur, suffer, or be put to, by reason of any accident or of any person being injured or suffering damages.
9. As a consideration of their exhibits or participation in events on San Joaquin County Fairgrounds the exhibitor holds harmless the renters who hold year round contracts or other parties from which the Fair leases ground to any and all claims or demands of any kind or nature which may be incurred directly by reason of such exhibits or participation including any and all claims or demands of their agents, servants and employees, or spectators of such exhibits or events.
10. Neither the Fair Management nor Departments will be responsible for unclaimed articles. All precautions will be taken during the Fair to protect the entries, but no liability for loss or damage from any cause can be assumed by the Department or the Fair Management.
11. No sign larger than 14" x 20" may be placed on or at any exhibit, nor shall any advertising be posted at exhibits without permission of Fair Management.
12. Local divisions are open only to legal residents or producers/business owners from San Joaquin county unless otherwise indicated.
13. Judge(s) shall award placing according to merit; and/or without merit, judge(s) shall make no award under any circumstances. This rule applies whether there are one or more entries in the class. See State Rule II Judging (1-7).
14. Entries cannot be entered in "Any Other" classification if there is a Division and Class for the specific item.
15. Exhibits must be adequately and correctly labeled unless otherwise instructed by the rules of the Department, Division, or Class.
16. Items which have been shown/displayed at a previous San Joaquin County Fair are not eligible for competition.
17. WITHOUT EXCEPTION, NO EXHIBIT SHALL BE RELEASED UNTIL THE TIME AND DATE SPECIFIED IN EACH SECTION OF THE ENTRY GUIDEBOOK. All entries are to be picked up at the building or area it was displayed, and the owner or parent guardian/project leader must present the claim to the item. No exception to this rule will be allowed without written permission from the Management of San Joaquin County Fair prior to release. Any exhibitor who removes his/her exhibit before the release date will have his/her premium monies withheld by Management.
18. **PROTESTS:** Protests will be considered only if there has been a violation of State or Local Rules that have not been enforced. Decisions of judges, veterinarians, weighmasters, Livestock Superintendent, breed callers, tail dock officials and timers cannot be protested and are final. All Protests must be accompanied by a deposit of \$500.00 (cash, money order or certified check made

payable to the Fair). NOTE: The deposit will be returned if the protest is upheld. If the protest is upheld, the violator may be held liable for any portion of the direct costs incurred by the Fair in the course of the protest resolution. Failure to reimburse the Fair shall be cause for disallowing future entries in any of the network of California fairs.

Given the short duration of the fair:

- The protestor shall make every effort to file the protest prior to judging. All protests must be filed in writing within 24 hours of the time of the cause of the protest and before conclusion of fair.
- The fair will make every effort to resolve protests as quickly as possible. All exhibitors by entering an exhibit and all persons by filing a protest agree to cooperate with Fair Management to resolve protests in a timely manner.
- Protests shall be adjudicated by Fair Management and/or members of Board of Directors.

Any exhibit involved in a filed protest before or during judging is eligible to compete until the protest is resolved.

Classes that involve a protested exhibit will not become official until the protest is resolved.

- In championship or special award classes that involve the protested exhibit the judge shall also select 1st and 2nd runners-up in case of disqualification.
- In the case of protest, the unofficial judging results may be used to prepare the sale list and other necessary information.

At the discretion of the CEO, judging can be delayed to allow time for the Fair to resolve the protest if to do so does not unreasonably delay or disrupt the operations of the remainder of the Fair judging and auction events.

Prior to judging the affected class, fairs may announce that an entry has been protested.

All questions concerning competition or non-protestable disputes or differences with staff or the exhibition not provided for under the State or Local Rules shall be referred to the CEO or their designee, whose decision shall be final.

Violations of State Rules may be appealed to F&E in writing. An individual may appeal to F&E only after adjudication at the local level and only if:

- The decision upholds a Local Rule that circumvents or is not in the spirit of a State Rule(s);
- The individual can substantiate new and credible information that was not available at the time of the local decision; or
- There was inappropriate adjudication at the local level that may have included conflict of interest, lack of due process, or a significant misinterpretation of rules.

A fair or state, national or international organization or subdivision thereof which has a significant stake in the interpretation of rules affecting the network of California fairs may make an appeal directly to F&E concerning multiple-fair issues, industry-wide issues, unavoidable

conflict of interest or assistance in enforcing its own organization rules.

No protest will be accepted unless it:

HOME FURNISHINGS

- Is filed or received, in writing, with a signed original and a signed duplicate copy;
- Clearly states which rule has been violated;
- States when the protestor first became aware of the facts and rule violation;
- States the facts relied upon for the basis of the protest;
- States that the protestor will cooperate with the investigation of the protest and that the protestor will be available and agrees to attend any hearing held to resolve the protest at the time and place directed by F&E;
- Includes the names of supporting witnesses, with accessible phone numbers; and
- Describes or attaches any documents relating to the protest, which must include the written decision issued by the local arbitrating body.

Fairs & Expositions Branch (F&E) must receive the appeal in writing within 24 hours from receipt of notice of local decision.

A hearing may be conducted at the discretion of F&E. The F&E Branch Chief may consult with and/or request that members of State Rules Advisory Committee participate in any hearing.

Once the Branch Chief has ruled on an appeal to F&E, no additional protest or appeal will be considered relating to that incident.

19. **AWARDS:** Ribbons and premium checks will be available at the time of release of the exhibit or will be mailed to the exhibitor according to the address printed on the online entry. \$50.00 will be charged for all replacement checks. All checks must be cashed within 90 days. NO checks will be issued after 90 days. Checks may be picked up on the designated day as listed in the Entry Guidebook by the exhibitor only. If exhibitor is under the age of 18, a parent or guardian may be designated to pick up check payment. Verification of parent or guardian will be requested at pick up.
20. **SALE:** Items with a 1st place ribbon or higher may be eligible to sell should the exhibitor indicate on entry form their interest in participating.
 - All sales must be coordinated through the SJCF
 - SJCF will deduct commissionable 15% transaction fee
 - If entry form indicates the item is not for sale (NFS) the exhibitor cannot change this to for sale once the item is accepted at receiving.

DIVISIONAL RULES AND REGULATIONS

1. Open to all organizations in San Joaquin County.
2. Entry forms for Feature Exhibits (Booths) should indicate the approximate number of square feet required for the display. Feature Booth measurements are set at an 8' height for rear walls. Please contact Exhibit Superintendent through the Fair Office 209-466-5041 for further space information.
3. Any and all water containers within booths shall be lined and leak proof.
4. All wiring contained within an exhibit booth must be type "S" or heavier. All booth supplies must be provided by the exhibitor.

DISPLAY ONLY - NO JUDGING

DIVISION 100 FEATURE EXHIBITS (BOOTHS)

Feature Exhibitors should display cultural heritage and concentrate on the connection to the history and community of San Joaquin County. The exhibit should be presented in such a manner as to inform the public of the value, need, desirability and interest to the patron. The educational value should be the most important part of the exhibit.

DEPARTMENTAL RULES AND REGULATIONS

1. The American system of judging will be applied in Divisions.
2. Exhibits in the Floriculture Department must have been grown by the exhibitor within the county, district or community represented by the exhibitor, except in Arrangements Division. Florists and nurseries may exhibit plants, plant material and flowers which they currently sell but do not necessarily grow.
3. Exhibits should be adequately and correctly labeled. Entries not labeled correctly may be disqualified.
4. This department is open to all exhibitors showing flowers and plants grown in San Joaquin, Sacramento, Contra Costa, Stanislaus, Alameda, Calaveras, and Amador counties, unless otherwise stated.
5. Exhibitors are required to keep their flowers in good condition for the duration of the Fair or forfeit their prizes. Flowers and gardens must be changed and/or watered as needed. IF YOU ARE UNABLE TO DO SO, PLEASE CONTACT THE EXHIBITS SUPERINTENDENT AT exhibits@sanjoaquinfair.com.
6. All materials and decorations must be made from a flame- proof material or treated and maintained in a flame-retardant condition.
7. **ENTRY LIMITS:** 5 entries per Exhibitor per Class, unless otherwise stated. Please read Divisional Rules carefully.
8. **LIABILITY:** Every precaution will be taken in the handling and exhibiting of work; however, the Fair will not be responsible for loss or damage which may occur from any cause. Submission of entries implies acceptance of all conditions stated in Local and State Rules.

ARRANGEMENTS

DIVISIONAL RULES AND REGULATIONS

1. Arrangements must be completed by Exhibitor at home. Minimal Fair workspace available for last minute details only. Exhibitors will be allowed to set their own completed arrangements in place in the exhibit area.
2. Owner's name on bottom of container is recommended.
3. Fresh Arrangements are not to exceed 10% of dry materials, unless otherwise stated.
4. The use of artificial flowers and materials will not be permitted unless specifically stated in Division or Class descriptions.
5. Small or valuable figurines and accessories should not be used in arrangements unless securely attached to base.
6. The attendants in charge will take every possible precaution but will not be responsible for loss or breakage. Natural plant materials may be dyed or sprayed.

DEFINITIONS AND RULES

Hobbyist: One who participates in the craft for personal enjoyment and has no financial gain.

Master/Commercial: Arrangement Lectures, Floral Arrangement Teachers, Arrangement Judges, or anyone who supplements their income in the field of Floral Arranging, or who has received 31 or more blue ribbons in flower arranging competition.

Flower Arrangement Rules: Flowers must be arranged in a single container unless otherwise specified. Arrangement designs may be enhanced by accessories. Accessories are considered anything in a design in addition to the plant material and container. Accessories may include a mat, small object, figurines, backdrop, and/or frame.

CUT FLOWERS

DIVISIONAL RULES AND REGULATIONS

1. Cut Flowers must be shown in clear vase provided by exhibitor. Judging will not consider the vase. May be plastic or glass. Exhibitor should label bottom with name and phone number.
2. Cut flower divisions are open to amateur and private growers.
 - **Amateur/hobby:** One who generally grows plants primarily for his/her own pleasure and who does not derive his/her livelihood therefrom.
 - **Private Grower/commercial:** A person who enjoys growing their own cut flowers and who may or may not offer them for sale.
3. **LIMIT:** Four entries per exhibitor per class.
4. All roses must be disbudded, except when shown as sprays.
5. Annual and Perennial Blossoms cannot have buds. Submit number of stems or sprays as specified for each Class.
6. All cut flowers will be discarded at close of Fair except when prior arrangements have been made with the Floriculture department.

2. All exhibitors must reside in San Joaquin, Sacramento, Contra Costa, Stanislaus, Alameda, Calaveras, or Amador counties.
3. An exhibitor may enter as many items as they like if a different recipe or pattern is used. However, be aware that per California State Rules and Regulations “an exhibitor who earns more than two cash premiums in a class will only receive the two highest premiums as ranked by the judges.”
4. Exhibitor’s name must not appear on front of exhibit.
5. If an exhibitor enters one item in the same category as Professional they must enter all items in professional divisions. Exhibitors may place themselves in the higher division at their own discretion but may not drop down in division to Hobby/Amateur in future years.

Amateur/Hobby: A person attached to a pursuit, study, or hobby in a nonprofessional or unpaid manner.

Professional/Commercial: A person or business who creates the item professionally and for profit.

6. Items entered in “Any Other” classes must be described in online entry and fall in the Division category (e.g., Cheese in Any Other Biscuits). If three or more “Any Other” items are similar enough, they will be judged as a separate class.
7. All perishable entries must be home prepared from scratch. Any exceptions will be noted in appropriate Divisions. Preserved foods may not be made more than one year in advance. REFRIGERATION WILL NOT BE PROVIDED.
8. Non-perishable items must be the personal work of the exhibitor and may NOT have been previously entered in the San Joaquin County Fair.
9. ITEMS NOT CLAIMED BY JUNE 6TH 2023, WILL BE FORFEITED UNLESS OTHER ARRANGEMENTS ARE MADE IN ADVANCE.
10. ALL PERISHABLE ITEMS WILL BE DISPOSED OF UNLESS OTHER ARRANGEMENTS ARE MADE IN ADVANCE WITH EXHIBIT SUPER.
11. **JUDGING:** The Fair will pay cash awards only to those classes

specified in this Entry Guidebook and only judging sheets will be the basis for any cash award payments. Ribbons and exhibitor tags have no value as to payment.

12. The American system of judging will be applied in Adult Home Arts Divisions.
13. Judges’ decisions are final and anonymous.

DEPARTMENTAL RULES AND REGULATIONS

1. If an exhibitor enters one item in the same category as Professional they must enter all items in professional quilting divisions. Exhibitors may place themselves in the higher division at their own discretion but may not drop down in division to Hobby/Amateur in future years.
2. All work must be done by exhibitor(s) ONLY, excluding machine quilting.
3. Quilt MUST be in good condition, clean, free from pet hair, dirt, and smoke or other odors, or it will NOT be judged.
4. Quilts must NOT have been entered in a prior San Joaquin County Fair.
5. Divisions may be split into Classes by size at the discretion of the Judge or Exhibit Super..
6. **LIMIT:** Two quilts per person per Class.
7. All quilts must have a 4" deep sleeve or alternate method for hanging. Sleeve should be on upper back and may be permanent or temporary. For best presentation, quilts larger than 60" wide require a split sleeve.
8. All quilts must have the length, width and total perimeter listed on the entry form. Quilts must be folded so the bottom right corner is on top with the quilt length, width and total perimeter pinned to that corner.
9. Except for Division 370-371 Hand-Quilted, all quilts may be machine or longarm/midarm machine quilted.
10. A Best of Show will be awarded per Division.

DEFINITIONS OF TERMS

Quilt: A quilt consists of three layers – a fabric top, a soft inner layer (such as batting), a fabric back. All three layers are held together with either patterned hand stitches or machine stitching that pierces all three layers.

Pieced: Piecing predominates over appliqué or other techniques.

Appliquéd: Appliqué predominates over piecing or other techniques.

Pieced & Appliquéd: Combination of piecing and appliqué where neither predominates more than 60%.

Kit: Composed of patterns, fabrics, and quilting designs packaged as a unit. This Division includes printed whole cloth quilt tops and block of the month quilts.

Art: Quilt must be a completely original design (no commercial pattern). Quilt styling may include painted textiles, thread painting, photo into quilt (not for photos transferred to fabric), or other innovative or original designs.

Group Quilt: Any quilt pieced and/or finished by more than one person.

HOBBY/AMATEUR: An exhibitor who engages in an art or craft as a hobby or for the love of the work, and whose income from sales or teaching does not exceed \$1,000 per year.

PROFESSIONAL/COMMERCIAL: An exhibitor who engages in an art or craft as a profession, and whose income from sales or teaching exceeds \$1,000 per year.

3. **ENTRY LIMITS:** An exhibitor may enter **TWO ENTRIES PER CLASS** if the class entered is not the same as an entry for another Division, or unless otherwise stated.
4. **MIXED MEDIA:** Any two-dimensional artwork that was created using two or more mediums. The mediums must be stated in description.
5. **OPEN TWO-DIMENSIONAL:** Works done in a single medium (watercolor, oil, acrylic, pastel, etc.) All entries will be hung based on available space unless determined unsuitable for display. In the event there are more entries in the Open Division than fit in the building, display may be limited to one entry per person.
6. **DISPLAY FORMAT:** All work must be securely wired for hanging. **NO SAWTOOTH HANGERS PLEASE.** Clip frames or uni-frames will not be accepted in any Division. The Department may rescind the right of hanging or displaying any work deemed unsuitable.
7. Two-Dimensional works must not exceed 42" wide by 62" high including frame. If a work exceeds 36" in width, only one can be entered in that class.
8. **LIABILITY:** All reasonable care will be taken in handling each entry. Neither the Fair Management nor this Department will be responsible for unclaimed articles. PHOTOGRAPHY

DEPARTMENTAL RULES AND REGULATIONS

1. Entries must be original photographic work of the exhibitor completed with the last year.
2. **PRINT SPECIFICATIONS:** Prints may be from any camera type, film, or digital capture. The image may be a traditional photographic print or high-quality digital print. See Division specifications for any additional information.
3. **PRESENTATION SPECIFICATIONS:**
 - **DISPLAY SIZE:** Backing/mount board must be 16"x20" except in Large Format or Digital Panoramic classes. The print on the mount board may be mounted for vertical or horizontal viewing. LARGE FORMAT PRINTS MUST BE MATTED AND FRAMED UNDER GLASS OR PLEXI.
 - **PRINT SIZE:** Minimum print size is 5"x7" up to 16"x20" except in Large Format and Digital Panoramic Classes. Digital Panoramic may be up to 24" on the longest side. Large Format minimum size is 8"x10" and maximum size is 24"x36". Presentations may be either vertical or horizontal.
 - **DISPLAY FORMAT:** A high-quality white mount board, foam core or gatorboard, no more than 3/16" thick, must be used for all color, black and white, or digital art photos (this is the board you mount your photo on). Color borders, color mats, double matting, or color mount boards are not allowed in any class. A 4-ply or 8-ply single-window over-mat, securely affixed, MAY be added. Window mats must be white but may have a black core. Over-mats are optional but help protect the image from scratches.
- A digital-stroke border touching the image is allowed, either black or white, but not more than 1/8" wide. No embossed, beveled or altered borders are permitted.
- NO signatures should show on the front of exhibit.
- Prints may fade and change color with exposure to light and humidity at the Fairgrounds. To maintain color quality, we recommend you select high-quality archival paper and inks.

- **DO NOT USE PICTURE FRAMES, GLASS, OR HANGING DEVICES.** Exception: Large Format.
 - **IDENTIFICATION:** ALL ENTRIES MUST BE IDENTIFIED ON BACK UPPER LEFT CORNER with entrant's name, address, phone number, Division number, Class, and title. Title MUST be the same as given on the online entry. All information is to be neatly hand printed or typed.
 - **MODEL RELEASE:** A Release is required for each print in which a person is recognizable unless taken at a community activity, event, or a public occasion.
 - **DISPLAY:** The Department reserves the right to display all entries in a way that is aesthetically pleasing. The Fair reserves the right to refuse any entry or refuse to display any entry considered not to be in accordance with the rules of entry or in the best interest of the Fair.
 - **MOUNTING SUGGESTIONS:** Mount photo with acid-free artist tape. Do not use masking tape or Scotch tape!
 - Turn the photo over (back side up) and apply 2 or 3 strips of tape at the top edge of the photo. Half of the strip on the photo and half off the photo.
 - Turn photo right-side-up. Lay it face-up on backing board.
 - With photo face up and tape on the back, put another strip of tape down on top of the piece that is hanging off the photo so that half of the new tape is adhered to the backing board and the tape on the photo.
 - Now that the print is mounted to the backing board, run double-sided tape around the perimeter of the photo on the backing board 2 times to get the proper coverage.
 - Firmly press single-window over-mat in place to secure and complete the mounting process.
4. **LIABILITY:** All reasonable care will be taken in handling each entry. Neither the Fair Management nor this Department will be responsible for unclaimed articles. All precautions will be taken during the Fair to protect the entries, but no liability for loss, theft or damage from any cause can be assumed by the Dept. or Fair Management. Submission of

any work constitutes an agreement to this effect.

5. **JUDGING:** Judges will be looking for creative ways of photographing chosen subjects. Appropriate soft focus or selective focus photos are acceptable. Out-of-focus images or blurred handheld pictures are regarded as poor work; sharp, clear images are valued. In black and white prints, a full range of tones from black through grays to white is expected.
 - Judges need not give awards if they decide awards are not merited.
 - Best of Show will be chosen from all first-place winners of each department.
6. **ENTRY LIMITS:** Four (4) entries per class by a single exhibitor.

DEFINITIONS OF TERMS

Non-manipulated: Photographic image that has not been digitally altered prior to either printing or scanning. Exhibitors may use computer editing tools to adjust for contrast, exposure, cropping, and other traditional adjustments that could be obtained through a traditional darkroom process.

Computer Manipulated: Photographic image has been digitally altered prior to either printing or scanning in a manner that could not otherwise have been produced during traditional darkroom printing. Changing color can be radical manipulation (even when fairly subtle) significantly altered from original photograph.

Creative Processes: Photographs modified through creative image—making or alternative image processes. These include platinum or palladium, Polaroid transfers, in-camera multiple exposures and blends. Photo montages and multiple prints on one board.
