- 2. This application is neither an offer nor a guarantee of space.

3. If you are applying for more than one stand, you must submit a separate application and non-refundable application fee for each.

- 4. All questions on this application must be answered completely. Be sure the information you give is accurate, as it will be the sole representation of your business for the selection process.
- 5. Submit a **TYPED** menu with all items and proposed prices (including beverages). If selected, a formal menu will be negotiated.
- 6. Submit recent photos of your food stand(s) with application; day, night and backyard.
- 7. A footprint of your food stand(s) is required. Include the service support area in operational form. Be very specific for all dimensions (i.e., if hitch is not removable, please include in size of unit).
- 8. A copy for your California Seller's Permit and Food Handlers (ServSafe) Certificate is required with your application. Food Handlers certification is required by the State of California (exceptions: prepackaged food and beverage carts).
- 9. Management will determine the location of your booth. Locations are subject to change from year to year.
- 10. The utility and health fees on this application are subject to change per final agreement with governing agencies and departments.

Applications for returning vendors are due by February 1, 2024, with a non-refundable application fee of \$25.00.
After February 1, 2024 applications are open to all with the non-refundable application fee of \$25.00. After February 28, 2024 non-refundable application fees will be increased to \$50.00. Checks should be payable to the Sacramento County Fair.
