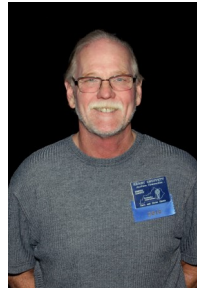

**Ms./Mrs. Kentucky County Fair Rules**

**Q1.** Contestants must meet the deadline requirements established by KAFHS. Candidates who fail to meet the deadline will not be allowed to compete in the state pageant.

**Q2** An entry form for the pageant shall be available to Association members prior to June 1. Completed entry forms should be submitted (electronically) to the Secretary within 30 days of the local pageant and must be received by December 1. No entries will be accepted after December 1. Contestants not meeting that deadline will not be allowed to compete in the state pageant.

**Q5** Contestants may not compete in any other pageant system that would prohibit the fulfillment of responsibilities through the state during her reign as Ms. /Mrs. Kentucky County Fair.

**Q6** Kentucky (KAFAS) its affiliates, volunteers are not to be held responsible in any way for disqualifications of winners and/or contestants. Grounds for disqualification can be BUT are not limited to untrue statements or registration forms, misconduct, obscene, foul language, unruly/unbecoming behavior that on social media and/or the internet such as porn and any other reasons the pageant committee may deem as necessary. The board will make all decisions and they will be final.

## Miss Kentucky County Fair, Through The Years

**Q7** Cameras, cell phones, iPad, and other electronic devices are not allowed backstage. Use of these electronic devices can disqualify any contestant during the pageant and such devices will be confiscated for the remainder of the pageant.

**Q8** Clothing for the pageant will be MODEST, meaning no cut outs in the attire, very MODEST cleavage showing in all attire (no low cut in tops that go to belly button), no slits will be allowed higher than mid-thigh, no see-through attire.

**Q10** Each County Fair will send ONLY 1 Contestant and maybe either a Ms. or Mrs. (married or single) to compete in the State Pageant.

### General Rules Applicable to All Pageant Programs

**G1** In order to participate in pageant programs, a Fair Member desiring to enter a contestant must be a member of the Kentucky Association of Fairs and Horse Shows (KAFHS) and have paid all dues and pageant fees prior to the local pageant being held and be eligible for state aid through the Kentucky Department of Agriculture.

**G7** Each member association shall designate one person to receive all correspondence from the association. It shall be that person's responsibility to see that all rules, forms and other information are delivered to the appropriate person(s).

**G8** Anyone winning a KAFHS state title is not eligible to compete in that pageant thereafter.

**G9** Local fairs cannot accept contestants with out of state residence.

# By - Laws

## The Kentucky Association of Fairs And Horse Shows, Inc.

Adopted at the 1988 Annual Convention; Amended - January 2002 and January 2012

### Article 1 - Name

The organization shall be known as the **Kentucky Association of Fairs and Horse Shows, Inc.** Its principal place of business and address shall be designated by the Board of Directors.

### Article 2 - Purpose

he purpose of the Kentucky Association of Fairs and Horse Shows, Inc. shall be to encourage the formation of and aiding in the betterment of fairs and horse shows in the Commonwealth of Kentucky.

### Article 3 – Membership

The members of the Kentucky Association of Fairs and Horse Shows, Inc. shall be designated as: 1) Fairs; 2) horse shows; 3) community events; 4) Associate Members; and, 5) Individual and Family memberships.

**3.1.1 Fairs**—A County fair recognized as such by the Kentucky Department of Agriculture and eligible for state aid to County fairs.

**3.1.2 Horse Shows**—A horse show conducted and promoted by any organization within the Commonwealth or Kentucky.

**3.1.3 Community Event**—A community Event is a community festival or special event promoted by any organization within the Commonwealth of Kentucky.

**3.1.4 Associate Member**—An associate Member shall be a business firm, organization or individual whose interest rest in the promotion and encouragement of fairs and horse shows.

**3.1.5 Individual and Family Membership**—Those interested in the support and promotion of fairs, horse shows and community events.

### Article 4 - Voting

4.1 Each Fair member shall have one(1) vote in the proceedings of all business brought before the Kentucky Association of Fairs and Horse Shows, Inc. and shall be represented at such a meeting by an officer thereof or other person duly authorized. Each Fair member shall be responsible for designating the individual authorized by the association to vote in the meetings of the Kentucky Associations of Fairs and Horse Shows, Inc. That individual must present evidence of his designation to the Secretary-Treasurer prior to the meeting at which the individual wishes to vote. Challenges to an individual’s right to vote on behalf of a Fair Member shall be determined by the Grievance Committee of the Kentucky Association of Fairs and Horse Shows, Inc., whose decision shall be final.

4.2 Community Events, Associate Members and Individual and Family members shall not have the right to vote in any proceedings nor be eligible for election or appointment to an office in the Kentucky Association of Fairs and Horse Shows, Inc. None of these members shall be allowed to participate in the demolition derby program or any of the beauty pageant programs sanction

by the association if accepted for membership after 2007.

#### **Article 5 - Officers**

The officers of the Kentucky Association of Fairs and Horse Shows, Inc. shall consist of a President, a President-Elect, First Vice-President, Second Vice-President and Secretary-Treasurer.

5.1 All of the above officers except the President shall be elected at the annual meeting of the Kentucky Association of Fairs and Horse Shows, Inc. to be held in January of each year.

5.2 The President-Elect shall assume the office of President immediately following the election of officers at the annual meeting of the Kentucky Association of Fairs and Horse Shows, Inc. next succeeding his election as President-Elect and shall serve as President for a term of one (1) year.

5.3 The First Vice-President and Second Vice-President shall serve for a term of one (1) year.

5.4 The Secretary-Treasurer shall serve for a term of three (3) years.

5.5 The terms of office of the above offices shall extend to such time as their successors have been duly elected qualified as provided for herein. Their terms shall end upon their death, resignation, or upon the removal from office in the manner provided for herein.

#### **Article 6 - Meetings**

6.1 The annual meeting of the Kentucky Association of Fairs and Horse Shows, Inc. shall be held in the month of January each year at the time and place designated by the Board of Directors upon reasonable notice to the Fair Members for the purpose of electing directors, officers, and for the transaction of such business as may come before the meeting.

6.2 Special meetings of the Kentucky Association of Fairs and Horse Shows, Inc. for any purpose or purposes may be called by the President or by a majority vote of the Board of Directors, and shall be called by the president at the request of; not less than ten (10%) percent of the Fair Members entitled to vote at such a meeting.

6.3 Written notice of the time, place and purpose of any special meeting must be given to the Fair Members a minimum of thirty (30) days prior to such meeting.

6.4 Fair Members and Associate Members shall register for each Annual or Special Meeting. All business before the Kentucky association of Fairs and Horse Shows, Inc. shall be by a majority vote of the Fair Members present. Each Fair Member shall have one (1) vote.

#### **Article 7 - Board of Directors**

7.1 The Board of Directors shall consist of the officers, President, President-Elect, First Vice-President, Second Vice-President, and the Immediate Past President, plus nine (9) Directors, who shall be elected by the Kentucky Association of Fairs and Horse Shows, Inc. at the annual meeting, plus two (2) Associate Member Representatives, who shall be selected by the Associate Members and serve one (1) year terms as ex-officio (non-voting).

7.2 The elected directors shall serve for a term of three (3) years or until their successor shall have been duly elected and qualified. The Commonwealth of Kentucky shall be divided into three zones and designated as Zone 1, 2 and 3. Three (3) directors shall be elected from each zone. At each annual convention, each zone shall elect one (1) director for a term of three (3) years. Should

a vacancy exist, directors will be elected to fill the unexpired term.

7.3 The Board of Directors is authorized to promulgate rules and regulations for the conduct of the committee's business and functions. These rules shall be subject to revision, modification or deletion by the Board of Directors at any time, or by the Fair Members of the Kentucky Association of Fairs and Horse Shows, Inc. at any annual meeting or special meeting called for that purpose.

7.4 The Board of Directors are hereby authorized and directed to pay compensation to the Secretary-Treasurer, plus expenses of his/her office as it may deem proper and reasonable. The Board of Directors are hereby authorized to order paid such expenses incurred by others on behalf of the Kentucky Association of Fairs and Horse Shows, Inc. as may be authorized or approved by the Board of Directors or membership of the Kentucky Association of Fairs and Horse Shows, Inc.

7.5 Any director, officer, or appointed official may be removed, by a majority of the vote of the Board of Directors, whenever in its judgment, the best interest of the Kentucky Association of Fairs and Horse Shows, Inc. would be served thereby, after reasonable notice and a hearing thereon.

7.6 A vacancy in any office because of death, resignation, removal, disqualification or otherwise, may be filled by the Board of Directors, on a majority vote, for the unexpired portion of the term.

7.7 A quorum for the transaction of business before the Board of Directors shall consist of a majority of the entire board.

7.8 The Board of Directors is authorized to appoint an Executive Director, when the financial and other conditions warrant, to fix compensation and to define duties. The duties may include, but not be limited to, any portions of the duties and responsibilities currently assigned to the Secretary-Treasurer. The Board of Directors shall have the authority to negotiate with an employee or potential employee, to hire and fire, and other responsibilities as normally related to employer/employee relationships.

#### **Article 8 - Nominating Committee**

The President, at the first session of the annual meeting, shall appoint a nominating committee consisting of not less than three (3) members who shall report to the Kentucky Association of Fairs and Horse Shows, Inc. those individuals who have been nominated for the Board of Directors and Officers of the Kentucky Association of Fairs, and Horse Shows, Inc.

The report of the nominating committee shall be presented to the Secretary-Treasurer and be posted at the Registration Desk of the Annual Convention on or before 3:00 p.m. on the day before the election of the officers and directors.

#### **Article 9 - Elections**

The President shall call for other nominations for such officers from the floor. All elections shall be by a majority vote of the eligible voting Fair Members present. Should there be more than one (1) nomination for any one office, ballots shall be distributed only to those authorized to cast votes for their Fair Members. The ballots, after being cast shall be collected and tallied by three (3) Directors designated by the President. Following the counting of the ballots, the ballots shall be returned to the Secretary-Treasurer and the results reported immediately to the members. Any qualified voting delegate of any Member Association shall be entitled to examine the ballots during the remainder of the annual meeting.

#### **Article 10 - Kentucky State Fair Board Representative**

10.1 The President, at any session of the annual meeting of the Association, immediately preceding the end of the term of the Association's Representative on the Kentucky State Fair Board, shall direct the nominating committee to compile a list of names to be presented to the membership for selection of the six individuals who will be presented to the Governor of the Commonwealth of Kentucky for appointment to the Kentucky State Fair Board.

10.2 There shall be nominated as representative of the Kentucky Association of Fairs and Horse Shows, Inc. six (6) individuals, two (2) from each zone. The nomination must be equally divided between the two (2) major political parties of the Commonwealth of Kentucky. A list of six (6) individuals shall be approved by the Corporation. The list shall be transmitted by the Secretary of the Association to the Governor of the Commonwealth of Kentucky.

10.3 Should a vacancy occur in the office of the Association's representative on the Kentucky State Fair Board, the Board of Directors of the Kentucky Association of Fairs and Horse Shows, Inc. shall be authorized to submit a list of six (6) individuals to the governor of the Commonwealth of Kentucky for selection to fill such unexpired term. The list shall be subject to the criteria stated herein.

10.4 The representative of the Kentucky Association of Fairs and Horse Shows, Inc. to the Kentucky State Fair Board shall during their term of office endeavor to represent the interest of the Association and shall regularly report to the Association all activities of the said Kentucky State Fair Board as same relates to the interest of this Association.

#### **Article 11 - Residence and Membership Requirements**

All Officers, Directors and the Representative to the Kentucky State Fair Board of the Kentucky Association of Fairs and Horse Shows, Inc. must be and remain during their term of office a resident of the Commonwealth of Kentucky and an individual who is a member in good standing of any member fair or horse show in good standing with the Kentucky Association of Fairs and Horse Shows, Inc. A vacancy shall occur and exist automatically should any officer or director fail to meet these requirements during their term of office.

#### **Article 12 - Duties of Officers**

12.1 The President shall be the principal executive officer of the Kentucky Association of Fairs and Horse Shows, Inc. subject to the control of the Board of Directors, and shall preside at all meetings of the Kentucky Association of Fairs and Horse Shows, Inc. and Board of Directors. The President is authorized and directed to establish such committees as the President or the Board of Directors deem necessary or proper.

12.2 The President-Elect shall, during his/her tenure as President-Elect, endeavor to thoroughly familiarize themselves with the duties of the President and the work of the Kentucky Association of Fairs and Horse Shows, Inc. as well as the Board of Directors and shall perform such other duties as may be directed by the Board of Directors.

12.3 The First Vice-president shall perform the duties of the President during the absence or disability of the President.

12.4 The Second Vice-President shall perform the duties of President during the absence or disability of both the President and the First Vice-President.

12.5 The Secretary-Treasurer shall keep minutes of all meetings of the Kentucky Association of Fairs and Horse Shows, Inc. and Board of Directors; shall have charge of all books, papers and correspondence thereof and keep the same in a fair and complete order, subject, at all reasonable times, to the inspection of the association members or Board. He/she shall keep accurate

records of accounts for all receipts and disbursements and at the annual meeting, or in the event he should resign or his tenure be terminated, he shall produce a fair and regular statement of accounts showing receipts, payments and expenditures and shall deliver all books, papers, correspondence, money and property of the Kentucky Association of Fairs and Horse Shows, Inc. into the hands of his successor or as ordered by the Board of Directors. He shall be bonded in an amount determined by the Board of Directors.

#### **Article 13 - Dues and Fees**

Annual dues shall be charged each member of the Kentucky Association of Fairs and Horse Shows, Inc. Those Fair members participating in the pageant contests, i.e., Miss County Fair, Miss Teen County Fair, Miss Pre-Teen County Fair; Little Mr. & Miss, special programs; and Horse Show members participating in the high point awards, sponsored by the Kentucky Association of Fairs and Horse Shows, Inc., shall pay additional annual fees. Annual dues and fees, referred to herein, shall be established by the Board of Directors. No association member may advertise they are members of the Kentucky Association of Fairs and Horse Shows, Inc. unless they are in good standing, nor may they advertise they participate in the pageant contests or horse show awards, unless they have paid the additional fees.

#### **Article 14 - Robert's Rules**

Robert's Rules of Order shall govern the conduct of any business meeting.

#### **Article 15 - Zone Map**

The three (3) zones referred to herein shall be according to the list attached hereto and made a part hereof.

#### **Article 16 - Amendments**

The Constitution and By-Laws may be altered, amended or modified at any annual meeting of the Kentucky Association of Fairs and Horse Shows, Inc. or special called meeting for said purpose, upon reasonable notice to said Fair members and upon a majority vote of those members present.

#### **Article 17—Zone Meetings**

Zone meetings will be held in conjunction with the Annual Meeting held in January. One vote per Fair Member and for the team of 3 Zone Directors to be responsible for conducting the meetings and reporting the results.
