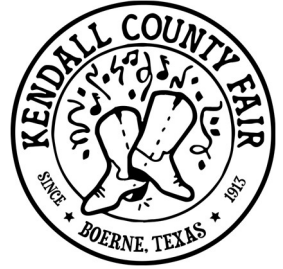

## Pre & Post Pageant Information

**Tardiness or failure to attend and comply with any and all events will be grounds for a Pageant Contestant's immediate elimination from the Pageant.**

### Pre-Pageant:

- **Pageant Entry Deadline:** Packets to be postmarked no later than Thursday, July 31, 2024.
- **Pageant Contestants & Parent/Guardian Mandatory Meeting and Picture Day:** Saturday, August 3, 2024.
  - **Pageant Contestants & Parent/Guardian Mandatory Informative Meeting** at 10:00 am at the Kendall County Fair Grounds pavilion. All Pageant Contestants and at least one (1) parent/guardian are required to attend.
- **Pageant Contestants Pictures** are at 11:00am. Attire for pictures is collared shirt. . All Pageant Contestant pictures will be taken on an individual basis with the Contestant, the Fair Photographer and the Queen's Court Director. All Parents/Guardians must remain in the meeting area during pictures. If you are unsure how to dress, please consult the Director of the Queen's Court & Pageant. A picture CD will be available for purchase from the Fair Photographer and will include all Pre-Pageant and Pageant pictures of each Contestant.
- **Pageant Contestants Wardrobe Fitting:** We will be having wardrobe fittings in Boerne. Your assigned time will be provided during the mandatory meeting August 3, 2024.
- **Pageant Contestant Fair Promotion: time TBA**
- **Pageant Rehearsal with KCFA Directors, Families & Sponsors:** Saturday, August 17, 2024, KCFA Pavilion.
  - **Pageant Rehearsal** at 10 am at the KCFA Pavilion. ALL Pageant Contestants and at least one (1) Parent/Guardian are required to attend.
- Each Queen's Contestant (Jr. Miss & Little Miss Contestants do not do this) will prepare a two-minute speech that will be given during the private interview with the panel of judges. The topic of the speech **will be given on Pageant Day.**
- Each Jr. Miss Contestant (Queen & Little Miss Contestants do not do this) will prepare a one-minute speech that will be given during the private interview with the panel of judges. The topic of the speech is: **"Why I should be the next Kendall County Fair Jr. Miss?"**
- All Pageant Contestants **MUST** arrive on time to **ALL** meetings to include Pageant Contestant & Parent/Guardian Mandatory Meeting & Picture Day, Contestant Wardrobe fittings, Pageant Rehearsal, Interviews on Pageant Day and all other mandatory events. Plan accordingly and arrive early! Again, **tardiness or failure to attend and comply with this rule will be grounds for a Pageant Contestant's immediate elimination from the Pageant.**

### Pageant Day:

- **Pageant Day:** Thursday, August 29, 2024
- **Pageant:** All contestants will be given an arrival time to be at the Kendall County Fairgrounds on Pageant Day. Times will be assigned and given to the contestants at rehearsal.
- **Pageant Attire: Formal Gowns-** Gowns must be age appropriate **No midriffs or plunging necklines, Slits may not be higher than 5 inches from knee, Dresses may not be shorter than fingertip length.** If there is a question, please feel free to contact the Queen's Court Chairmans.

### **Pre & Post Pageant Information Continued**

- Parents/Guardians will need to drop **ALL** Pageant Contestants (including Little Miss) off at the Kendall County Fair Grounds assigned meeting room. Please do not linger, as this makes it harder on the Pageant Contestants. **PARENTS WILL NOT BE PERMITTED TO STAY OR HANG OUT IN THE PAGEANT AREA OR ON THE KENDALL COUNTY FAIR GROUNDS. NO EXCEPTIONS!** Chaperones will be on duty.
- **Pageant & Coronation: 6:30 PM, KCFA Pavilion – Admission is free!** All Contestant's Parents/Guardians, Family, Friends, Sponsors and General Public are invited to attend.
- **Cell phones are not permitted by pageant contestants on Pageant Day!** Once they arrive on the KCFA grounds they must be left in the possession on Parents/Guardian or in the off position in the possession of the Volunteer chaperone in the holding area.
- The Kendall County Fair Association will provide snacks, drinks, restrooms, etc. If your child has special dietary requirements or is allergic to any foods, arrangements may be made in advance with the Queen's Court Director for you to provide appropriate snacks.
- There will be Pageant Chaperones on site that will consist of past Queen's Court members, KCFA Board of Directors and Volunteers as selected by the Director of the Queen's Court & Pageant.
- All Pageant Contestants will meet independently and as a group with Pageant Judges with an interview proctor present to monitor the time of the interview. (Queen 7 Min Max, Jr. Miss 6 Min Max, Little Miss 5 Min Max)
- The scores from the Pageant Judges will be tallied after the Pageant Contestants are brought on stage and the Pageant Judges are retired to finalize their scores. The Pageant Judge's scores are final and the KCFA Board of Directors, significant others, and affiliates do not have any control over the Pageant Judge's tallies.
- Any negative comments about the KCFA Board of Directors, Director of the Queen's Court & Pageant, Pageant Judge's or newly elected Queen's Court will not be tolerated.

#### **After the Pageant, for Contestants not selected on the 2024-2025 Queen's Court:**

- The Kendall County Fair Association Board of Directors, Director of the Queen's Court & Pageant and Pageant Committee would like to thank you all for participating and we hope that you will consider running again in the future as you are able.
- Pageant Contestants who are not selected on the new 2024-2025 Queen's Court will be free to leave the pageant with a Parent/Guardian as soon as the on-stage portion is completed.
- All Pageant Contestants are **required** to ride in the Kendall County Fair Parade on Saturday, August 31, 2024, in a show of good sportsmanship and to represent your Pageant Sponsor or Sponsors. There is no entry fee for a Contestant to ride in the parade.
- The Parade Line Up begins at 8:00 AM. Judging is at 9:00 AM. The Parade starts promptly at 10:00 AM. Please go to your designated Parade entry position to decorate and wait for the parade to start.
- All Pageant Contestants are responsible for securing your own vehicle, driver and signage. The signage **MUST** include the Pageant Contestants Name and Pageant Sponsors Name.
- All Parade participants are required to follow the rules and regulations of the Kendall County Fair Parade and the City of Boerne. To view the Parade rules, please visit [www.kcfa.org](http://www.kcfa.org).

#### **After the Pageant, for the newly crowned 2024-2025 Runner Ups:**

***Immediately following the Pageant, please meet for official photos by the KCFA Photographer. Parents/Guardians and family may also attend.***

- The Runner Ups are required to ride in the Kendall County Fair Parade on Saturday, August 31, 2024.
- The Parade Line Up begins at 8:00 AM. Judging is at 9:00 AM. The Parade starts promptly at 10:00 AM. Please go to your designated Parade entry position to decorate and wait for the parade to start.
- If you do not ride in the Parade as a Runner Up, you will be restricted from entering future KCFA Queen's Court Pageants.

- All Runner Ups are responsible for securing your own vehicle, driver and signage. The signage **MUST** include their name, Pageant Title (Runner Up, Jr. Miss Runner Up or Little Miss Runner Up) and Pageant Sponsors Name.
- All Parade participants are required to follow the rules and regulations of the Kendall County Fair Parade and the City of Boerne. To view the Parade rules, please visit [www.kcfa.org](http://www.kcfa.org).

**After the Pageant, for the newly crowned 2024-2025 Queen's Court:**

***Immediately following the Pageant, please meet for official photos by the KCFA Photographer. Parents/Guardians and family may also attend.***

- It is **mandatory** that the newly crowned Queen, Princess, Duchess, Jr. Miss and Little Miss attend a Post Pageant Meeting after pictures are taken. Parents/Guardians **MUST** also attend this important meeting.
- The 2024-2025 Queen's Court Contract signing will take place in the meeting.
- It is **mandatory** that the newly crowned Queen, Princess, Duchess, Jr. Miss and Little Miss attend the entire 2024-2025 Kendall County Fair Labor Day Weekend and participate in all events as designated by the Kendall County Fair Board of Directors and the Director of the Queen's Court & Pageant.
- Any issues/concerns about your attendance need to be immediately discussed with, Director of the Queen's Court & Pageant. Failure to attend any of your assigned events during the Fair are considered a Class II Offense and you may be immediately removed from the Queen's Court and your scholarship revoked.
- The Queen's Court will be chaperoned by a member of the KCFA Board of Directors or Queen's Court Committee member during the Fair.
- The KCFA will provide some food tickets and unlimited water & sodas for the Queen's Court during the weekend of the Kendall County Fair & Rodeo.
- The newly Crowned 2024-2025 Queen's Court will ride on the KCFA Float in the Parade. Meet at the Kendall County Fair Grounds at 8:00 AM to be transported to the Parade by the Director of the Queen's Court & Pageant or member of the Queen's Court Committee. The Parade starts promptly at 10:00 AM.

*All rules, regulations, prizes and scholarships are subject to change when needed at the direction of the KCFA Board.*

**Queen's Court Scholarship Pageant**  
**Rules & Regulations**

1. The Queen, Princess, Duchess category is open to all 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> & 12<sup>th</sup> grade girls in the 2024-2025 school year, up to the age of 18, and who reside in and/or attend school in Kendall County, Texas, as of August 1, 2024. All contestants must provide proof of age via an original Birth Certificate and proof of grade level via Verification of Enrollment
2. The Jr. Miss category is open to all middle school girls, who are 11 & 12 years of age, in the 2024-2025 school year, and who reside in and/or attend school in Kendall County, Texas, as of August 1, 2024. All contestants must provide proof of age via an original Birth Certificate.
3. The Little Miss category is open to all elementary school girls, who are 7, 8 & 9 years of age, in the 2024-2025 school year, and who reside in and/or attend school in Kendall County, Texas, as of August 1, 2024. All contestants must provide proof of age via an original Birth Certificate.
4. A Runner Up will be chosen for each pageant category. She will be recognized on stage during the Pageant. She may also be called upon to fill in at any time a member of the 2024-2025 Queen's Court is unavailable. This may include parades and other functions requested.
5. The Runner Ups will be required to adhere to the same rules and regulations as the other members of the 2024-2025 Queen's Court.
6. All Contestants must reside with their parents/legal guardian during the time of the Pageant. Failure to do so will be grounds for immediate elimination from the Pageant.
7. The reigning Queen, Jr. Miss or Little Miss may not enter the same category again. If the Princess is moved into the Queen's position during the reigning year, she is eligible to run in the future if she meets all other eligibility requirements of the Queen's category. Reigning Jr. Miss and Little Miss may run for titles in the next age bracket when she meets all other eligibility requirement of the Queen's Scholarship Court Pageant.
8. If you are a member of the Kendall County Fair Queen's Court as Queen, Princess, Duchess, Jr. Miss, Little Miss or Runner Ups and you are removed from the Queen's Court for any reason, you may **NOT** enter the Queen's Court Pageant again in any age bracket.
9. The attire for the Queen's Court Scholarship Pageant is a formal gown.

**Rules & Regulations Continued**

10. The required attire for the 2024-2025 Queen's Court reigning year will be western attire. This will consist of the following:
- a. Buckle (Supplied by KCFA)
  - b. Crown (Supplied by KCFA)
  - c. Black Cowboy hat (to be approved by the Queen's Court Chairmans)
  - d. Black Western Belt that will hold a buckle
  - e. 2 pairs western jeans (These will be color specific and will be approved by the QC Chairmans)
  - f. 3 collared western shirts (to be purchased)
  - g. Black Cowboy Boots (to be approved by the Queen's Court Chairmans)
  - h. 1 Long Western Skirt (to be purchased)
  - i. Capris (to be approved by the Queen's Court Chairmans)
  - j. 3 T-shirts (Supplied by KCFA)
  - k. Western jacket (Sponsored)
  - l. NOTE: If court member already has some of the attire required, (where noted as to be purchased) it can be utilized for their court attire IF approved by the KCFA Queen's Court Chairmans.

**Additional Yearly Costs: Christmas Outfit, Spring top**

11. All Queen's Court Contestants will be required to submit a personal bio of 200 words or less, to be read by the MC as their introduction to the stage during the Pageant, **must be written in third person (use she/her in place of name)** and must include recognition of the Primary Pageant Sponsor.
12. All Queen's Court Contestants will be required to provide two (2) Letters of Recommendation from someone other than their immediate family (for example... a teacher, employer, business owner, Pastor or other community leader).
13. All Queen's Court Contestants will participate in a private interview with the Pageant Judges.
  - a. Each Queen contestant (Jr. Miss & Little Miss Contestants do not do this) will prepare a two-minute speech that will be given during the private interview with the panel of judges. The topic of the speech **on the day of the pageant. The Interview portion will begin at 30 minutes after topic is given.**
  - b. Each Jr. Miss contestant (Queen & Little Miss Contestants do not do this) will prepare a one-minute speech that will be given during the private interview with the panel of judges. The topic of the speech is: **"Why I should be the next Kendall County Fair Jr. Miss"**
14. All decisions of the Pageant judges are final. The KCFA Board of Directors has **NO** say in the scores. All score cards/results remain the property of the KCFA and shall not be accessible to the public. No Exceptions!
15. All Queen's Court Contestants and a Parent/Guardian must become a member of the Kendall County Fair Association, Inc. to participate in the Pageant. Applications available in this packet or online at [www.kcfa.org](http://www.kcfa.org).

**Queen's Court Scholarship Pageant**  
**Rules & Regulations Continued**

16. On Pageant Day, to maintain fairness, confidentiality and in the best interest of the contestants, girls are advised to leave cell phones in the care of their parents/guardians. We ask that parents/guardians respect our process by following this simple rule, once your child is dropped off for the pre-pageant activities, you will refrain from contacting her in person, by phone or any other method until after the pageant. If there is an emergency, we will contact you or allow your child to contact you. Parents/Guardians also have contact information for the Queen's Court Director, *in case of emergency*.
17. If any contestant is cited or charged with a minor in possession, minor in consumption, DUI or DWI, or is cited for unlawful acts by law enforcement officials/agencies, the Contestant will be eliminated from the pageant.
18. If any contestant is cited for stealing or willfully destroying school or community property, the contestant will be eliminated from the pageant.
19. If any contestant becomes engaged to be married, becomes married, becomes pregnant or gives birth to a child, the contestant will be eliminated from the pageant.
20. The use and/or possession (in hand, next to in a photo/video) of alcohol, tobacco products, illegal drugs or the use of any illegal substance (including illegal use of prescription medications) by any Contestant is strictly prohibited. If any Contestant is found using alcohol, tobacco products, illegal drugs or the use of any illegal substance (including illegal use of prescription medications), the contestant will be eliminated from the pageant.
21. All Contestants and their Parents/Guardians are expected to treat each other with respect. Gossiping, name calling, bullying, cyber bullying, fighting or negatively harassing a Contestant, member of the Court, their Parents/Guardians, and any member of the Board of Directors, including but not limited to verbal, social media, texting, and emails will not be tolerated. This is also expanded to any behavior/conduct during personal time and with any other person or persons not involved with the KCFA. This will not be tolerated and may result in disqualification from the pageant.
22. It is mandatory for all Court members and Pageant Contestants to friend the Queen's Court Director, KCFA Director(s) and allow access to any and all their social media accounts to ensure the Social Media Contract Rules and Code of Conduct are followed. It is also mandatory for their parents/guardians to friend all KCFA Directors including the Queen's Court Director. Court members and Pageant Contestants will friend all KCFA Directors with parent approval. All members of the Court and their Parents/Guardians will maintain a positive image on all social media. Please take into consideration what others are posting; you do not have to be tagged in the post for it to count against you. This includes but is not limited to Facebook, Instagram, Twitter, Tumbler, Snapchat, TikTok and etc. Any conduct deemed inappropriate or disrespectful and/or removing/blocking the Queen's Court Director and/or Directors and/or failure to notify of a new account will result in immediate removal from Pageant.
23. If you are not chosen as a member of the 2024-2025 Queen's Court, your sponsor and/or family member will be responsible for providing a vehicle and a driver for the Pageant Contestant to use in the KCFA Parade on Saturday, August 31, 2024. All contestants are **required** to participate in the KCFA Parade to show good sportsmanship to fellow contestants and thank your sponsor for their support.

**Queen's Court Contestants Judging Criteria (Queen)**

All Queen Contestants will be judged on the following criteria:

**A. Interview = 100 points**

**Appearance in Formal Wear = 15 points**

Judges evaluate a Contestant's qualities, overall appearance, and appropriateness of selection of formal wear from their outfit chosen on Pageant Day.

**Personality/Interview Questions = 25 points**

Judges evaluate a Contestant's personality, her ability to relate to others, her maturity and her ability to express herself during a personal interview.

**Fair Knowledge = 20 points**

Judges evaluate a Contestant's knowledge of the history of the Fair, upcoming Fair events and activities.

**Poise & Confidence = 15 points**

Judges evaluate a Contestant's poise and confidence during the Interview.

**2 Minute Speech = 25 points**

Judges evaluate a Contestant's ability to write and deliver a Two Minute Speech, **topic will be given at 30 minutes prior to the start of the interviews.**

**B. Stage = 100 points**

**Personality & Appearance= 25 points**

Judges evaluate a Contestant's personality, stage presence and overall appearance during the Pageant and Introduction..

**Onstage Interview Question = 50 points**

Judges evaluate a Contestant's ability to answer her question with articulation, poise, personality and the quality of the response.

**Poise & Confidence = 25 points**

Judges evaluate a Contestant's poise and confidence during the Pageant.

**C. Extra Points Opportunity = 10 points**

Each contestant has the opportunity to earn an extra 10 points as long as they enter an exhibit into the Exhibit Hall for the 118<sup>th</sup> Kendall County Fair. Must be received by the exhibit deadline. Exhibit Hall Director will sign off and provide confirmation of the contestant's entry to the Queens Court Director.

### **Queen's Court Contestants Judging Criteria (Jr. Miss)**

All Jr. Miss Contestants will be judged on the following criteria:

#### **A. Interview = 100 points**

##### **Appearance in Formal Wear = 15 points**

Judges evaluate a Contestant's qualities, overall appearance, and appropriateness of selection of formal wear from their outfit chosen on Pageant Day.

##### **Personality/Interview Questions = 25 points**

Judges evaluate a Contestant's personality, her ability to relate to others, her maturity and her ability to express herself during a personal interview.

##### **Fair Knowledge = 20 points**

Judges evaluate a Contestant's knowledge of the history of the Fair, upcoming Fair events and activities.

##### **Poise & Confidence = 15 points**

Judges evaluate a Contestant's poise and confidence during the Interview.

##### **1 Minute Speech = 25 points**
