



## TOMMYHAWK CONTEST

The Board of Directors of the Chowchilla-Madera County Fair are pleased to announce that applications are being accepted for the **TOMMYHAWK CONTEST**. This contest will be held as part of the Chowchilla-Madera County Fair in Chowchilla. A maximum of eight (8) participants will be randomly selected from all applications received by the deadline date. The **TOMMYHAWK CONTEST** is for males only.

**Applications must be submitted no later than 5:00 pm on Tuesday, April 9, 2024. A Mandatory Parent/Contestant Meeting will be held on Tuesday, April 16, 2024, at 6:00 pm in the Little Theater at the Chowchilla-Madera County Fairgrounds.**

The winner of the Tommyhawk contest will be selected by an impartial panel of judges who do not reside in Madera County. Contestants will be evaluated on the categories listed below. Contestants may choose to seek organizations or business sponsors to help offset any pageant related expenses. The pageant show changes each year and contestants may be required to participate in an opening dance number or other event activities. The Director(s) reserves the right to make changes as necessary.

Each contestant will be evaluated in the following categories:

- Poise
- Personality
- Behavior

Pageant winners will receive the following:

Tommyhawk	\$50.00
Costume Expense Contribution	\$35.00

The Tommyhawk contestant winner will be obligated to lead the opening of the Chowchilla Spring Festival parade on Saturday, May 11, 2024. The winner will be required to construct (sew) and wear a Native American Indian style outfit when he marches in the parade on Saturday, May 11th. Parents are responsible for creating the outfit including any additional costs above the \$35.00 contribution from the Chowchilla-Madera County Fair.

The winner of the Tommyhawk Contest will be required to be present at the Chowchilla-Madera County Fair and other community events that may be scheduled throughout the year in Madera County. It is the responsibility of the winner and parents to schedule their attendance to the events and activities.

## APPLICATION REQUIREMENTS

- A Tommyhawk application must be completed and submitted to the Chowchilla-Madera County Fair Office by no later than 5:00 pm on **Tuesday, April 9, 2024**
- Contestants must be between the ages of 6 and 9 years as determined by their age on **May 8, 2024**. **A copy of the applicant's birth certificate or official school record with a birth date must accompany payment that will be collected at the Mandatory Parent/Contestant Meeting on Tuesday, April 16, 2024.**
- Contestants must have resided in Madera County for at least six (6) months prior to the date of the pageant (proof of residence may be required).
- No contestant shall have won a prior Tommyhawk Contest, nor have been a professional model, have appeared professionally on TV, radio or in print of any form for professional compensation. Having won another amateur contest for awards does not exclude a contestant from participating.
- Those applicants in the pageant must pay a **\$25.00 Pageant Fee** on the night of the **Mandatory Parent/Contestant Meeting** on Tuesday, April 16, 2024 at 6:00 pm. Checks must be made payable to the Chowchilla-Madera County Fair.
- Specific dress attire will be discussed in detail during the rehearsal sessions and further changes may be added. In general, no shorts, tee-shirts or tank tops for Pageant Night, no sandals or flip-flops are allowed, and no jewelry of any kind will be allowed.
- **It is important that the Tommyhawk Contestants attend all rehearsals and be on time. Pageant meetings and rehearsals, dates and times may be subject to change.**
- The 2024 Pageant schedule will be given out at the meeting on **Tuesday, April 16, 2024**.
