MARKET SQUARE VENDOR PROGRAM RULES AND REGULATIONS

San Antonio Livestock Exposition, Inc and Market Square vendor rules must be read and acknowledged via the Rules and Regulations Form before vendors can participate and attend Market Square Plaza.

1. WORKING ARTISAN/VENDOR CONDUCT:

- 1.1. Vendor shall be cleaned and well-groomed.
- 1.2. Vendor must wear shoes at all times.
- 1.3. Clothing with offensive language is not permitted.
- 1.4. The use of offensive and/or abusive language (cursing and/or being argumentative) is prohibited.
 - 1.4.1. Arguments of any type in low voice or raised voice with employees, fellow working artists, and/or visitors are prohibited.
- 1.5. The consumption of any type of alcohol (beer, wine, wine coolers, hard liquor), by the vendor while vending is prohibited.
- 1.6. The destruction, vandalism, and/or damage of City property, including but not limited to fences, trees, plants, shrubs, flowers, pavers, building walls, electrical outlets, tree grates, etc. is prohibited.
- 1.7. Vendor is prohibited from soliciting and/or hawking.
- 1.8. Vendor shall not allow vending space to be left unattended.

2. SET-UP LOCATIONS:

- 2.1. Vending locations will be assigned by Vaquero Cook-Off Coordinator.
- 2.2. Vending locations shall not be considered permanent.
- 2.3. Vending locations are subject to change by the Market Square Office and/or Vaquero Cook-Off Coordinator.
- 2.4. Vendor must set up in the assigned location as assigned by the Vaquero Cook-Off Coordinator.
- 2.5. Vendor shall not be allowed to utilize another working artists' or vendors' assigned space without the authorization of the Market Square Facilities Events Coordinator and/or WHP Vaquero Cook-Off Committee.
- 2.6. The approved setup space shall not exceed 10 by 10 square feet.
- 2.7. The approved setup space must be presentable, clean, and free of clutter.
- 2.8. Artist/Vendor shall provide tent structures of professional-grade, that are properly weighted with at least 50 pounds on each tent leg.
- 2.9. Tents and booths must be set up beginning at the rear of the assigned space, to allow ample room for pedestrians.
- 2.10. Use of outdoor plaza benches is prohibited.
- 2.11. Any menu item different from the medium submitted at the time of application must be approved through the Vaquero Cook-Off Coordinator.
- 2.12. Vendor may begin to set their booth up on Friday, February 2, 2024 at 12 p.m. (Noon).

3. EXHIBIT SPACE WITHIN LOCATION:

- 3.1. Vendor space shall measure a maximum of 10 feet by 10 feet.
- 3.2. The display, including booth and viewing bins, must be within the 10 ft by 10 ft booth setup.
- 3.3. Market Square, WHP-Vaquero Cook-Off Committee and/or San Antonio Livestock Exposition, Inc. retains the right to regulate various aspects of the booth within the allotted space.

3.4. Market Square is a family-oriented public space, and exhibits must be in keeping with this atmosphere and acceptable to a general public audience.

4. STORAGE OF EQUIPMENT:

- 4.1. All equipment must be removed from the approved location on a daily basis. Failure to comply will result in termination of program participation. The Market Square office, Western Heritage Parade and Cattle Drive Committee Vaquero Cook-Off, and/or San Antonio Livestock Exposition, Inc are not responsible for the storage and/or securing of any equipment belonging to a vendor. Storage space is not available for any type of equipment.
- 4.2. Market Square, Western Heritage Parade and Cattle Drive Committee, Vaquero Cook-Off Subcommittee, and/or San Antonio Livestock Exposition, Inc are not responsible for the theft, loss, damage, vandalism of merchandise, property, or items left unattended.

5. TERMINATION:

The vendor is expected to acknowledge and follow all Market Square, Western Heritage Parade and Cattle Drive Committee, Vaquero Cook-Off Subcommittee, and/or San Antonio Livestock Exposition, Inc. vendor rules and guidelines. If a vendor is not compliant with requirements and rules, then such a lack of compliance shall result in termination of privileges at the Market Square Plaza. This process is generally constituted by the following steps: 1) verbal warning, 2) termination from Market Square Working Artist/Vendor Program but is subject to variance on a case-by-case basis.

- 5.1. The approval to setup as a Vendor is non-assignable and any attempt to assign this approval will terminate all rights and privileges granted to the artist/vendor.
- 5.2. Vendor may lose their setup privileges in the areas of Market Square for a 12-month calendar period. Reasons for losing set-up privileges include:
 - 5.2.1. Failure to pay in advance of setting-up.
 - 5.2.2. Any violations of the Behavior regulations outlined in Section 4.
 - 5.2.3. Any violation of the setup locations regulations outlined in Section 3.
 - 5.2.4. The addition of any merchandise/product without Market Square Facilities Operations Coordinator's and/or Vaquero Cook-Off Coordinator's written permission.
 - 5.2.5. Number and severity of written complaints from the public, and/or fellow working artist/vendor.
 - 5.2.6. Any violation of the storage regulations.

6. REFUNDS:

No Refunds. Payments referred to herein shall not be refundable under any circumstances, including but not limited to the termination of this Agreement for whatever reason.

Market Square Food Vendor Program Rules & Guidelines

Please read the following carefully. These rules and guidelines form part of your commitment to the Market Square Food Vendor Program. They have been established to provide operational rules to enhance the experience of Market Square.

- DO NOT USE DUCT TAPE ON THE PLAZA
- DO NOT DUMP ANYTHING IN THE STORM DRAIN
- DO NOT PUT CHAIRS, EQUIPMENT, OR SUPPLIES PAST THE AWNING POLES
- YOU ARE RESPONSIBLE FOR TAKING YOUR OWN TRASH TO THE DUMPSTERS; NOT THE CLEANING CREW.
- DO NOT USE OUR TRASH CANS IN THE PLAZA FOR YOUR OWN PERSONAL TRASH DUMPSTER
- DO NOT PUT TARP PAPER IN THE RECYCLE BIN; IT BELONGS IN THE GARBAGE DUMPSTER
- SHOW YOUR EMPLOYEES THE PROPER RECYCLE BIN, DUMPSTER BIN, AND ESPECIALLY THE GREASE CONTAINER. FOOD IS PROHIBITED IN THE GREASE CONTAINER.
- EVENTS ARE RAIN OR SHINE DESPITE WEATHER CONDITIONS. STAFF WILL CONTACT YOU IF CHANGES OCCUR.
- CHANGES/SWAPPING FOOD ITEMS IN THE LOTTERY IS PROHIBITED.
- MUST FOLLOW FDA/CDC HEALTH, FOOD HANDLING & PERSONAL HYGIENE.
- VENDORS ARE RESPONSIBLE FOR MAINTAINING A CLEAN BOOTH SPACE. ALL TRASH FROM YOUR OPERATION MUST BE REMOVED AND/OR PLACED IN PROPER RECEPTACLES AT THE EVENT END. ANY VENDOR LEAVING MATERIALS BEHIND WILL BE BILLED FOR ITS REMOVAL. GREASE BARRELS ARE PROVIDED FOR FOOD VENDORS AT NO CHARGE.

If these rules are violated, the food vendor agrees that Market Square may immediately revoke all rights of the vendor including removal from booth space without refund.
