At the conclusion of each contest, the **contest superviso**r will ask for the winners' names, addresses, and other pertinent information so that the awards can be distributed.

This completed record will be given to the Livestock Secretary.

RULES AND REGULATIONS

- □ A Judging Team shall consist of three (3) or four (4) bona fide 4-H Club or FFA members ages 8-18 as of September 1st of the current year. The three highest scores from a four person team will be used in competition.
- ☐ Individuals not on a team will be judged for high point individual only.
- ☐ Team member's ages shall be as follows:
 - Junior team members: ages 8-10 of the current year
 - Intermediate team members: ages 11-13 of the current year
 - Senior team members -ages 14-18 of the current year
 - FFA Sr. Division will be Senior High students.
 - FFA Jr. Division will be Middle School students.
 - *Clover buds* (ages 5-7) are welcome to judge for practice and they will be awarded a participation ribbon.
- 1. It is strongly recommended that all contestants wear appropriate 4-H or FFA official dress.
- 2. Oral reasons will be given on one class. Two minutes will be allowed for giving oral reasons.
