PREMIER EXHIBITOR PROGRAM

Auction Birds PROJECT

The Osceola County Fair offers its Premier Exhibitor Program to 4-H and FFA exhibitors in the Market Animal Programs, Fruit Crop Program, and/ or Auction Birds Program. The objective of the Premier Exhibitor Program is to highlight those exhibitors who best exemplify all aspects of the Market Animal Program, Fruit Crop Program, and/ or Auction Birds Program.

The Premier Exhibitor is a points system based on exhibitor participation beyond the required minimum. Points will be based on scoring and are given for the following: (Primary Project Only)

<u>Record Book Scores and Placings</u>	<u>Auction Birds Show Placings</u>
<u>Personally, Delivered Buyer Letters</u>	<u>Auction Birds Informational Poster</u>
<u>Resume (Seniors Only)</u>	<u>Resume Optional for Junior and Intermediate</u>
<u>Demonstrations</u>	<u>Essay/Video</u>
<u>Attending / Leading workshops</u>	<u>Premier Exhibitor Workshop</u>
<u>Youth Exhibits</u>	<u>Prospect Show</u>

At the end of the year, based on the number of points you have earned, you could win the Premier Exhibitor Award for the Auction Birds Project. An applicant must have a minimum of 150 points to be considered for an Auction Birds Premier Exhibitor placing:

- 1st Place- Belt Buckle, Jacket, and \$75.00
- 2nd Place- Ribbon and \$50
- 3rd Place- Ribbon and \$25

KVLS does not require your participation in the Premier Exhibitor Program. Verification forms must be completed correctly to receive your points.

You must accumulate a minimum of 150 points to be considered for the Auction Birds Exhibitor Award. In the event of a Tie, the following will be used to determine the tiebreaker:

- 1) Score on Record Book
- 2) Essay/Video
- 3) Informational Poster Placing

If you are exhibiting in more than one project area, you can only compete in Premier Exhibitor Program with your primary project.

PLEASE TURN YOUR VERIFICATION FORMS IN USING A NOTEBOOK OR LARGE MANILLA ENVELOPE. BE CERTAIN YOUR NAME IS ON ALL YOUR PAPERWORK!!!

You are required to register for the Premier Exhibitor Award online by **December 13, 2024**. When you register, you are registering to compete in the Auction Birds Premier Exhibitor Program. This means that you are competing against all exhibitors in that category. **An exhibitor may register to compete in a maximum of three (3) Premier Exhibitor Programs. (Primary Market Animal, Fruit Crop, and/ or Auction Birds).** Premier Exhibitor packet and **Auction Birds record book** must be turned in on Skill-A-Thon Day, **January 24, 2025**.
