**COMMERCIAL VENDOR
REGISTRATION INFORMATION**

March 14 & 15, 2025

GENERAL RULES:

Concessions and Vendors will agree to be open and available during duration of event:

Friday, March 14 – 5 PM – 10 PM

Saturday, March 15 – 10 AM – 5 PM

Set-up days: Access to vendor set up will take place Thursday, March 13 from Noon – 5 PM or Friday, March 14 from 9 AM – 4 PM. All vendors will need to be set up by 5 PM and all vehicles moved to vendor parking.

Commercial Vendor:

Approved vendors will receive a commercial vendor agreement. Once approved you will receive a vendor contract. Payment must be received with signed contract. Payment is non-refundable.

Commercial vendors are those that sell non-food products or pre-packaged food items, novelties, or items. Also included are those that display goods, equipment, products or services for the purpose of advertising or future sales.

All information subject to change.

Rates are as follows:

Outdoor Vendor Space – 10 x 10 - \$150

No electricity is available. If generators are used, they must be quiet.

Insurance: Applicable *Certificate of Insurance* naming Greater Hillsborough County Fair Association, Inc. additional insured with \$1 million coverage with \$250 per occurrence deductible coverage for each occurrence required to be on file with fair no later than March 13, 2025. Insurance can be provide for an additional \$10.

Additional: The Greater Hillsborough County Fair will accept deliveries on behalf of exhibitors; however, exhibitor assumes the risk of loss of all shipments delivered to the fair and releases the fair of all responsibility for the receipt and storage of all shipments. These can be delivered to the main office at 215 Sydney Washer Road Dover, FL 33527.

No Motorized Carts or Vehicles are allowed on fairgrounds during event hours except for fair manager and authorized fair employees.

Alcoholic Beverages/Tobacco Products: No alcoholic beverages or illegal substances as defined by Florida or Federal Law, are permitted to be brought, or distributed on the fairgrounds by any exhibitor. No tobacco products are allowed to be sold on the property unless authorized by fair in writing. Alcohol will ONLY be sold by fair concessions.

Weather

The Back Porch Jam is a rain or shine event. If needed, we will move event under cover if inclement weather is expected.

Liabilities The Exhibitor agrees to assume all liability for and the indemnify of Greater Hillsborough County Fair Association, Inc against any and all claims, with loss of life, personal injury, and/or property damage or theft arising from or out of the installation, setup, operation and dismantling of the exhibit. By applying to the Back Porch Jam, exhibitor agrees to have read and agree to the terms/conditions stated here.
