If you are issued a contract, a minimum deposit of 50% of the total contract cost will be required when you return your signed contract by the date stipulated. Full payment must be received by August 1st. Any space not totally paid for by August 1st will be considered cancelled and the space resold. All other requirements (insurance, seller's permit, health permit, etc.) must be on file prior to the fair opening. BOOTH SPACE PLACEMENT:

Placement depends on what space(s) open from previous vendors not returning. The Siskiyou Golden Fair staff will try to meet your accommodation requests as best as possible if you are granted a contract.

INSURANCE:

The State of California requires proof of commercial general liability insurance with a minimum coverage of \$1,000,000.00 per occurrence. If a contract is deemed hazardous, insurance coverage ranges from \$1,000,000.00 to \$3,000,000.00 depending on the activity. A premium quote is available from California Fair Services Authority at 916-263-6145. Full insurance requirements can be found on the website www.sisqfair.com.

CALIFORNIA SELLER'S PERMIT:

The California Department of Tax and Fee Administration requires a current sellers permit if you are selling products. There are regular and temporary permits depending on the amount of your sales and you cannot legally sell taxable items in California until you have been issued a seller's permit. SISKIYOU COUNTY HEALTH PERMIT:

If you are selling or having samples of any food/drink product, you must contract the Siskiyou County Environmental Health Department at 530-841-2100 or visit www.co.siskiyou.ca.us to obtain a health permit.
