In honor of the late Farren R. Dakin, the Dakin Family Scholarship Trust Fund Inc. will be awarding TWO \$2,000.00 scholarships in the year of 2025 to qualified applicants after consideration of the items below:

1. A resident of Manatee County and attending a school or home school program as a Senior in Manatee County and be eligible to graduate in the current school year.
2. Currently involved in the Manatee County 4-H or a chapter of FFA in Manatee County.
3. Scheduled to compete in and complete an Animal Science project at the Manatee County Fair in January 2025. If an animal project cannot be entered into the Manatee County Fair due to circumstances on behalf of the student or animal, such as death of the animal after check-in and prior to the show date of the fair, the Dakin Family Scholarship Trust Fund Inc. will consider a scholarship application. Applicants in this situation must indicate by letter mailed to Farren Dakin Dairy, LLC PO BOX 7, MYAKKA CITY FL 34251 an explanation of the circumstances when submitting the application.
4. The Dakin Family Scholarship Trust Fund Inc. application.

Winning Applicants must agree to apply the scholarship funds to tuition, books, fees or other required funds by the school at a two year or four-year college, university, or certified and accredited trade school and carry at least 12 credit hours per semester. The funds will be assigned to and administered by the applicant's college, university, or trade school. The scholarship funds must be distributed to the educational facility within one year of the date awarded by written letter to the scholarship winner. Should the applicant not complete their 12 credit hours per semester or complete their studies at the school, college or university, any unused portion of the scholarship funds are to be returned to the Dakin Family Scholarship Trust Fund Inc. PO BOX 7, Myakka City, FL 34251. Should the winning scholarship recipient not attend a college, university, or trade school within 1 year of the award, by written letter to the scholarship winner, the scholarship may be rescinded at the discretion of the Board of Directors of the Dakin Family Scholarship Trust Fund. Inc.

All applicants must agree to be interviewed in person or by an electronic means such as Zoom so the applicant can speak with the committee of the **DAKIN FAMILY SCHOLARSHIP TRUST FUND INC.** directly when scheduled before December 31st, 2024. Applicants will be contacted by email or by phone for the interview process if required.
