# **KLICKITAT COUNTY FAIR & RODEO QUEEN CONTEST**

## **CONTESTANT ELIGIBILITY**

1. Contestant must be 15 years of age by January 1<sup>st</sup>, 2025, and must not turn 21 years of age during her year of reign.
2. Contestants must be attending or have completed high school.
3. Contestants must have reliable transportation for herself and her horse during her full year.
4. Contestants must be single, never have been married, pregnant, or given birth to a child and must remain so for the duration of their reign. Contestants also need to appear single on all social media platforms.
5. Contestants must have not engaged in any act, which if made public, would be reasonably likely to cause harm or damage to the contestant's reputation, or to the goodwill and reputation of the Klickitat County Fair and Rodeo.
6. Contestants shall have never committed a crime or been convicted of a felony crime. Contestant shall not have any pending criminal charges against her.
7. Contestants must be honest and reliable with good moral standards and integrity.
8. Contestants must have never posed nude or seminude in any pictures, videos or on social media.
9. Contestant must live with her parent(s) and/or guardian(s) throughout her year. She must be a legal resident within 50 miles of Klickitat County line during her year of reign.
10. Contestant cannot have resigned or been removed from a previous Queen or court title.
11. Contestant cannot carry multiple titles at once, and a contestant cannot carry the Klickitat County Fair & Rodeo Queen title twice unless extenuating circumstances allow it.
12. If the contestant who earns the title of Queen violates any of the eligibility rules during her reign, she will relinquish all rights and privileges of her title, including belt buckle, sash, crown, clothing, chaps, equine travel panels and any accessories purchased with sponsorship money.

# KLICKITAT COUNTY FAIR & RODEO QUEEN CONTEST

## GENERAL RULES & EXPECTATIONS

1. Contestants must conduct themselves in a proper lady-like manner, you will not be able to drink alcoholic beverages, use illegal substances or paraphernalia, use tobacco, vape or marijuana products, use inappropriate language or profanity. The contestants shall not participate in any inappropriate internet or social networking behavior at any time during the contest of while representing the Klickitat County Fair & Rodeo.
2. The horse that the contestant tries out on must be the same horse she rides throughout the year of her reign. Only one horse can be used during try outs beside your draw horse that will be provided by the coordinator. In the case of a death, injury or mental break to the Queen's horse, she may substitute another horse with the approval of the Queen Coordinator. If the contestant is using a leased horse, a signed lease agreement must accompany this application. Lease must specify lessee has "full access" to the horse throughout the year of her reign. The title holder must have a back-up horse available at all times.
3. All contestants must complete the application in full and provide an 8x10 color headshot photo to Amanda Chambers no later than August 5<sup>th</sup>, 2024. The photo must be in full western attire, including a cowboy hat (no crown), long sleeve button up shirt. This photo will be used for the photogenic portion of the competition. Absolutely no copyright labels allowed on the photo turned in.
4. Judges and Queen coordinator have the final say on all scoring decisions.
5. Contestants must also understand in the event of winning the Queen contest you will work closely with the Queen coordinator Amanda Chambers throughout your year of reign.
6. The Queen and her parent(s) and/or guardian(s) will be required to sign a contract for her year of reign and abide by its rules.
7. The Queen coordinator and the Queen will select appropriate clothing, hat(s), boots, belt(s), and sash.
8. Klickitat County Fair Board will provide the belt buckle, crown(s), sash(s), chaps, and serapes for her year of reign.
9. The titleholder will be responsible for maintenance, damage, loss, or theft of possessions. Said property will also be returned to the Queen coordinator at the end of her reign or upon immediate dismissal. Items include chaps, serapes, crown(s), sash(s), equine travel panels.
10. The Queen will attend selected rodeos, parades, and other civic and social activities as determined by the coordinator. The Queen is never to attend any event representing the Klickitat County Fair & Rodeo without prior approval from the Queen coordinator.
11. Any poor sportsmanship, bullying, and gossiping **WILL NOT** be tolerated. Respect must be shown towards the judges, royalty committee, fellow contestants, volunteers, and fair board members. This includes a queen contestant, family, or friend. You will be asked to leave immediately. All prizes and awards received will be returned to the competition.
12. **NO CELL PHONES DURING THE PAGEANT.** Any time you are in full contestant attire cell phones are not to be present.
13. Coaching from the sidelines is not permitted.
14. Contestants will be on time for all functions. Tardiness will be deducted from the judge's points. You must be in the presence of the Queen coordinator 10 minutes prior to each category starting. Please plan accordingly.
15. Contestants must provide their own clothing for the competition and will agree to follow the wardrobe guidelines.

16. All decisions by judges are final. In the event there is a tie, the contestant that has the highest horsemanship points will be the new queen.
17. A judge may not be approached by a contestant, family member, or friend regarding the contest. This action will result in disqualification.
18. Each contestant and parent(s) and/or guardian(s) must attend the mandatory contestant meeting, Monday, August 5<sup>th</sup>, at 6pm in the Exhibit Building located at the Klickitat County Fairgrounds.
19. Each contestant must attend the tryout preparation day(s), parents are encouraged to attend but it is not mandatory. Prep days are Saturday August 10<sup>th</sup>, 9am at the fairgrounds and Sunday September 8<sup>th</sup>, 9am at the Goldendale American Legion.
20. All contestants are required to wear their contestant sash during all pageant events. The only exception to not wearing your contestant sash will be during horsemanship due to posing a safety risk. If lost, the contestant is responsible to give the value amount to the pageant for replacement.
21. Unnecessary discipline of your horse will result in immediate termination of the contest.
22. If the Queen fails to finish her year of reign, all items purchased or provided will be returned to the Queen coordinator and no scholarship will be awarded.
23. If a titleholder refuses to carry out the expectations and rules for this title, she will be immediately removed and replaced by the 1<sup>st</sup> runner up.
24. All fundraising efforts on behalf of the Queen shall be pre-approved and organized with the Queen Coordinator and Fair Board.
25. Each contestant is required to supply three silent auction items and one live auction item to be auctioned at the pageant. These items can be donated or purchased.

### **Obligations Of the Queen During the Week of Fair**

1. The Queen is to be available to help any of the fair superintendents and rodeo chairman, with such things as passing out ribbons or posing for pictures with champion animals and exhibitors.
2. While on the fairgrounds, the Queen shall be in fully appropriate Queen attire which include boots, hat, jeans and/or skirt, western long sleeve shirt, embroidered polo, buckle, crown and sash.
3. The Queen shall be at the Market Stock Sale for pictures with the Grand & Reserve Champion animals. If the Queen is selling an animal, they need to have someone available to hold the animal in line until it's time for them to go in the ring.
4. The Queen will help serve at the various BBQs.
5. The Queen will need to be present at the county penning, branding, sorting, and gaming for pictures with the winners.
6. The Queen will need to be present for the presentation of the Hay & Grain king and the Tri-County Saddle winners for pictures.

# **KLICKITAT COUNTY FAIR & RODEO QUEEN CONTEST**

## **EXPECTATIONS**

Upon winning the title of the Klickitat County Fair & Rodeo Queen, the titleholder becomes the official representative for the Klickitat County Fair & Rodeo; and as such is responsible to present the sport of high moral and ethical character and humane treatment of animals.

We wish to point out that this is not a beauty contest. Rather it is a competition, which recognizes several attributes such as horsemanship skills, personality, public speaking, and appearance. Therefore, as our official representative, the Queen is under the responsibility to act, speak and dress according to the esteem the title deserves any time she is in the public eye. As riding and horsemanship skills are a key promotion of the sport of rodeo, we encourage you to strive to always continue improving those skills.

Public speaking is essential to the role of the Klickitat County Fair & Rodeo Queen, I agree to continue to grow those skills.

The Queen will be responsible for the loss or damage to the Queens crowns, serapes, and chaps up to \$1,000.

Official duties and appearances must be approved by the Queen coordinator, I agree to keep in close contact to accomplish this.

The Queen must meet with the Queen coordinator at least twice a month to go over scheduling, work on horsemanship, practice speeches and continue to plan her year.

I understand that during my reign I will have chaperones attending events with me and I will abide by that chaperone.

I agree the official duties of the Klickitat County Fair & Rodeo Queen come first throughout my year of reign over other activities I may be involved in such as vacations, rodeo, school sports, summer sports, WAHSET/OHSET and work schedules.

I agree to live with my parent(s) and/or guardian(s) throughout my year of reign. I will not live with a significant other (male/female) and will not be involved in an intimate living relationship.

I understand that no significant other (male/female), who I am in a relationship with, shall attend events that I am representing the Klickitat County Fair & Rodeo. I will not travel to any appearances with him/her no matter what the situation is. I shall remain unmarried, observe a high standard of moral and ethical behavior and set a good example to the public and future competitors.

If I possess a personal website or social media profile (i.e., Facebook, Instagram, Twitter, Snap Chat, Tiktok, Be Real, etc.) I agree the material contained therein will be maintained to reflect a positive image of me, and my position as Klickitat County Fair & Rodeo Queen.

I understand I cannot create a Klickitat County Fair & Rodeo Queen Facebook, Instagram, Snap Chat, Twitter, Tiktok or any other social media platform by myself without the Queen coordinator's approval. The Queen is required to provide a small write up of each event and a few pictures to be given to the queen coordinator promptly after each event to be posted on the Queen's Facebook page.

As the titleholder, I understand that a first impression is most often the most memorable and that others will judge your appearance at all times.

The Queen must be careful when choosing attire when not in uniform, remembering that she constantly represents the Klickitat County Fair & Rodeo.

The Queen and family will keep family/personal matters private and not on display.

Avoid cell phone use during any event that I am a guest while representing the Klickitat County Fair and Rodeo. Phones are not to be carried in your clothing pockets at events. Phones are ok to be carried in your purse during events for emergencies.

As Queen, I will not engage in gossip or lying, making defamatory or slanderous comments concerning others, exhibit racial insensitivity, use inappropriate language, or participate in other conduct unbecoming of my title.

I agree to maintain a positive attitude throughout my year of reign.

I agree to never be seen with curlers or curls pinned in my hair. Fingernails will be clean and maintained.

I understand I must show up on time for official events fully dressed in approved Queen attire. Making sure clothes are clean, pressed, hats cleaned, shaped and boots cleaned.

I agree chewing gum while in public at events including riding horses in parades and rodeos is not acceptable.

I agree to encourage others to participate in future Queen contests.

The Queen is required to wear the items the Fair Board provided at all times when appropriate, which include crown, buckle, sash, serape and chaps.

The Queen will attend Klickitat County Fair & Rodeo fair board meetings in January, July, and August to update the fair board of her activities. We encourage our Queen to attend more meetings, if possible, your input is important to the Klickitat County Fair Board.

As Queen, she will be available for the two weeks preceding the Klickitat County Fair & Rodeo for daily to multiple daily appearances for luncheons, radio spots, and guest appearances. She also must, of course, attend all official functions during the Klickitat County Fair & Rodeo.

During the Klickitat County Fair & Rodeo the Queen's horse will be stalled in a corner box stall in Barn A or Barn B. Your horse will need to be stalled when not in use from Tuesday evening until 5pm Sunday evening. It is your responsibility for your horse's stall to be cleaned morning and night. Your horse must always have clean water and hay available in their stall. Your stall shall be decorated appropriately with pictures and posters. Please check in with the Horse Superintendent (Erika Beasley) to make sure you have the correct stall and are decorating according to the rules in the barn.

The Klickitat County Fair & Rodeo Queen agrees to indemnify, defend, and hold harmless the Klickitat County Fair Board and all rodeo committees, their officers, agents, or employees from against all loss of expense by reason of liability imposed by law for damages due to bodily injury. This includes death at any time resulting from or sustained by any person or persons and/or damages to property, including loss of use thereof arising out of or in damage to property due to any negligence.

The Queen represents she has (a) read all rules and regulations, (b) received a complete copy of all rules and regulations, (c) otherwise been fully advised as to any and all written and/or verbal amendments, if any to rules and/or regulations, (d) understands each and every rule and/or regulation, and (e) had the full opportunity to present all questions regarding rules and regulations, and such questions have been fully answered.

# KLICKITAT COUNTY FAIR & RODEO QUEEN CONTEST

## PAGEANT

The pageant will be held in one day. Horsemanship will be held in the Joan Fray indoor arena located at the Klickitat County Fairgrounds, and the speech, personal interview, modeling will be held at the Goldendale American Legion. There will be three or more judges. Contestants will be judged individually on horsemanship, speech, impromptu question, personal interview, photogenic, and modeling. The non-point earning category is sportsmanship. You will meet the judges before the horsemanship begins.

**Horsemanship:** This part of the competition includes four sections; rail work, reining pattern, presentation run, and a draw horse presentation run. This will start at 8:30am on the south side of the Joan Frey indoor arena in the gravel, with your horses tied to the trailer, but not yet saddled.

Judging criteria consists of:

- ❖ Equitation – your ability to ride correctly, balanced, relaxed body, position of hands, feet, and seat.
- ❖ Pattern – how well you execute the pattern given to you, correct leads, stops, pivots, speed changes.
- ❖ Presentation run – speed control, wave, and smile.
- ❖ Draw horse – sometimes you have to jump ride horses due to unforeseen circumstances. They will be watching how you handle change, and how you control your nerves on an unknown horse.
- ❖ Be prepared for questions pertaining to horse health, tack, rodeo events, rodeo terminology and more.

**Personal Interview:** This will be held at Goldendale American Legion in the meeting room at 3:30pm.

Judging criteria consists of:

- ❖ Knowledge of the Klickitat County Fair & Rodeo, county events held during the fair, NPRA rodeo, current news local and worldwide.
- ❖ How you present yourself: smile, personality, poise, and appearance
- ❖ Your ability to handle stressful situations with confidence, enthusiasm, and ambition.
- ❖ How well you can hold a conversation, correct use of the English language, and maintaining eye contact.

**Modeling:** This portion of the competition will be held at the Goldendale American Legion starting at 6pm. You will model your outfit while you make your way to the stage for your speech.

Judging criteria consists of:

- ❖ How your personality, individuality and creativity shine as you walk and show off your outfit. Your posture, smile, eye contact, interaction with the crowd and turns.
- ❖ Your appearance needs to be clean and neat; this includes your clothes from the tip of your hat to the tip of your boots, your hair, makeup, and nails.

**Speech & Impromptu Question:** This part of the competition will be held at the Goldendale American Legion in the banquet room following the modeling competition. Speeches will be given while guests are watching, supporting and eating dinner. Impromptu question will be asked at the end of each contestant's speech, each contestant will be asked the same question. The speech topic for this year is *I am a famous cowboy or cowgirl.* Think outside of the box!



Judging criteria consists of:

- ❖ Delivery of your speech.
- ❖ How well you have memorized it and how well you think on your feet.
- ❖ Your speech must be 2-3 minutes long.
- ❖ How you present yourself, smile, personality, poise, eye contact, and appearance.
- ❖ Be creative and have fun!

**Photogenic:** This portion of the competition will be based on the photo you turn in with your application.

Judging criteria consists of:

- ❖ Cleanliness of your outfit, outfit coordination with long sleeve button up, cowboy hat (no crown), jewelry if applicable.
- ❖ Your appearance needs to be clean and neat, curled hair, and fresh makeup.

**General Judging:** They will be watching how you conduct yourself from the time the day starts to when it ends; that includes informal and formal judging. They will be looking for your sense of humor, positive attitude, your ability to handle stress/nerves, ability to adapt. They will be paying close attention to how you speak; your grammar, and your ability to communicate with everyone of different ages and backgrounds you are in contact with that day. Make sure to be prompt on your time for each section of judging.

**Scoring:** There are a total of 450 points available to be awarded to each contestant. A minimum of 250 points must be met to be considered. If there is only one contestant competing, the 250 minimum points rule still stands. After judging is complete, each judge will place their judges sheets into a sealed manila envelope and sign the back flap. The Queen coordinator will gather the envelopes from each judge and give them to an auditor for counting. Silent judges will select a winner for the Sportsmanship award based on tryout prep days and the try outs themselves, no points are given for this award. Ties for category winners (horsemanship, speech, personal interview, modeling and photogenic) will be broken by adding the silent judges scores. The contestant with the highest overall score will be crowned the next Klickitat County Fair & Rodeo Queen. The contestant receiving the second highest score will become the first runner up. Ties for overall high scores will be broken by adding the silent judges scores for the contestants who are tied. No scoring sheets will be posted or given to contestants. Judges comments will be made available if there are any, approximately one-week post competition upon request of the contestant.

**Outfit Requirements:** Each contestant must supply their outfits for the competition and tack for their horse(s). During the horsemanship competition, each contestant must wear full western attire, a plain white long sleeve button up western shirt with a collar, shaped cowboy hat, pull on western boots (no lace up, “fat baby” or fashion heels), belt, and dark wash jeans. No chaps, gloves, crowns, or sashes are allowed to be worn. During your speech and personal interview, note cards and/or props are not allowed. For the personal interview, wear a full western attire outfit that shows your style and personality. This includes jeans, pants, skirt, cowboy hat, boots, long sleeve western button up shirt with collar, or dress (no leather dress or formal dress permitted). For the modeling, speech, and impromptu question, the contestant must wear a cowboy hat and boots. They may wear a leather or formal dress for this section of the competition, but contestants will not be penalized if they are not wearing one. Each contestant must supply the Queen coordinator with a 1–2-minute detailed description of your modeling outfit to be read while you model and make your way to the stage.

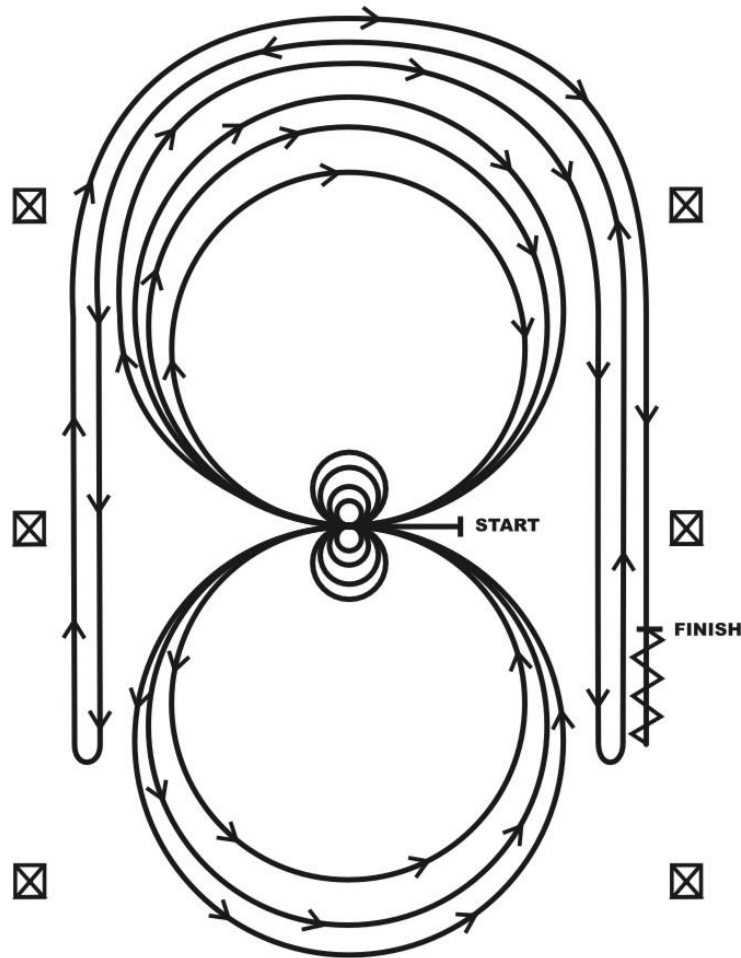

**AQHA Youth Reining Pattern #8**

**REINING PATTERN 8**



Horses may walk or jog to the center of arena. Horses must walk or stop prior to starting pattern. Beginning at the center of arena facing the left wall or fence.

1. Complete four spins to the left. Hesitate.
2. Complete four spins to the right. Hesitate.
3. Beginning on the right lead, complete three circles to the right: the first circle large and fast; the second circle small and slow; the third circle large and fast. Change leads at the center of the arena.
4. Complete three circles to the left: the first circle large and fast; the second circle small and slow; the third circle large and fast. Change leads at the center of the arena.
5. Begin a large circle to the right but do not close this circle. Run straight down the right side of the arena past the center marker and do a left rollback at least twenty feet (six meters) from the wall or fence—no hesitation.
6. Continue back around the previous circle but do not close this circle. Run down the left side of the arena past the center marker and do a right rollback at least twenty feet (six meters) from the wall or fence—no hesitation.
7. Continue back around the previous circle but do not close this circle. Run down the right side of the arena past the center marker and do a sliding stop at least twenty feet (six meters) from the wall or fence. Back up at least ten feet (three meters). Hesitate to demonstrate completion of the pattern.

- \* \_\_\_\_\_ 2. Contestant hereby grants permission to the Klickitat County Fair and Rodeo Board to verify any and all information contained on her application and attests that the information she has provided is true.
- \* \_\_\_\_\_ 3. Contestant hereby releases the Klickitat County Fair and Rodeo Board from responsibility of injury or loss to persons or property involving her or persons related to her appearance in the Contest, and which applies also to persons related to Contestant.
- \* \_\_\_\_\_ 4. Is 15-20 years of age as of January 1, 2025, and is currently in high school or a high school graduate (high school equivalency certificate allowed).
- \* \_\_\_\_\_ 5. Contestant hereby release title, claim and rights to photographs and/or public relations material involving her or her likeness to the Klickitat County Fair and Rodeo Board for use in Contest promotion.
