Senior 4-H: ages 14-18 (as of Sep. 1, 2024)

## **RULES AND REGULATIONS**

- 1. A judging team shall consist of four (4) bonafide 4-H or FFA members. A three (3) member team will be accepted if there are not enough participants for a four (4) person team. The scores from the three (3) highest scoring team members will be calculated for team prize awards. **Multiple teams from the same organization are allowed and encouraged, as this is a learning opportunity.** \*changes to team members CAN be made the day of the contest but it is encouraged to let us know changes in advance.
- 2. **Team Membership:** Junior, Intermediate and Senior team age limits are based upon the registering organization. FFA members will be required to register by grade level. 4-H members will be required to register by age, as of September 1<sup>st</sup> of the current 4-H year.
- 3. Scoring for the contest will be done by computer. Cards that are not filled out properly or not turned in after each class will be disqualified. If the class placing does not match in both areas on the judging card, the contestant could receive no score for that class.
- 4. Each team MUST pre-register by Tuesday, March 11, 2025. No late entries will be accepted.

- 5. There will be one questions class that will require youth participants to answer questions about the animals in a specific class that will be announced prior to the class coming into the ring.
- 6. The questions class is worth a maximum of 50 points and will serve as a tie breaker for awards.
- 7. The officials placings are **FINAL** and **NOT** negotiable. Participants that do not conduct themselves in a respectable and courteous manner will be disqualified from the contest.
- 8. All Senior Divisions will give 1 set of oral reasons to be included in their scores.
- 9. Any and all rules, regulations and/or requirements, are subject to change due to any federal, state and local government mandate. If such changes occur, a notification (or notifications) will be issued to agents, instructors, advisors and registered participants via the official registered contact information on file.
