2025 Southeastern Livestock Expo Livestock Judging Contest

GENERAL RULES

1.) ELIGIBILITY:

Competition is open to Youth, 4-H and FFA Members, and Agricultural Colleges in the United States. There is no limit on the number of teams that may come from a State, 4-H Club, or FFA Chapter, or University or College. Contestants cannot be entered on more than one (1) team.

Junior Youth Division: Contestants that are between 9 and 13 years old on January 1, 2025.

Senior Youth Division: Contestants that are between 14 and 19 years old on January 1, 2025.

<u>NOTE</u>: Even if a Senior Youth Division Participant has judged at the National 4-H Livestock Judging Contest (NAILE-Louisville, KY) or the National FFA Livestock Evaluation CDE (National FFA Convention-Indianapolis, IN) they are <u>still</u> eligible to judge in the SLE Livestock Judging Contest if they meet the age requirement stated above.

<u>Junior College/Collegiate Division:</u> Agricultural Colleges in the United States offering a B.S. or A.S. degree in Agriculture.

2.) Entries: Entries must be completed *ONLINE* by *5 PM* on *Tuesday February 25th* at SLE Livestock Judging Contest (slerodeo.com). *MAIL-IN ENTRIES WILL NOT BE ACCEPTED. WHILE PAYMENT OF ENTRY FEES CAN BE MADE AFTER THE 25TH, NO NEW ENTRIES WILL BE ACCEPTED AFTER THE 25TH. Entry fees are \$25 per person (credit card or check) if paid online/postmarked by February 26th. <i>IF PAYMENT IS POSTMARKED AFTER THE 25TH, OR DELIVERED AT THE CONTEST, THE ENTRY FEE WILL BE \$30 PER PERSON.*

- 3.) The Junior Youth Division and the Senior Youth Division will consist of a maximum of four (4) members per team and a minimum of three (3) members per team with the top three (3) scores constituting the team score. States, 4-H Clubs, and FFA Chapters may have multiple teams and alternates. Junior age youth contestants will be allowed to "move up" and participate in the Senior Division.
- 4.) Each Collegiate Team shall consist of up to six (6) contestants from each college or university. The top five (5) high scoring individuals will constitute the team score. Universities and Colleges may have multiple teams and alternates.
- 5.) CLASSES:

Junior Youth Division: 6 placing classes and 3 sets of 10 questions.

Senior Youth Division: 12 placing classes and 4 sets of oral reasons.

<u>Junior College/Collegiate Division:</u> 12 placing classes and 8 sets of oral reasons.

- 6.) Teams are to report to the Garrett Coliseum Lobby to check in, and immediately be seated in the Coliseum stands.
- 7.) You WILL NOT be able to add Contestants the day of the Contest, but you may substitute.
- 9.) All contestants must have #2 lead pencils. All contestants must bring their own notebooks or paper for taking notes for oral reasons and questions. Participants will be provided a contestant number that will identify them throughout the duration of the Contest.
- 10.) Scantron Sheets will be used for ALL Divisions. Contestants who fail to properly mark their placing on their scantron will receive a score of 0 for that class. Additionally, contestants who fail to properly fill in their contestant number, or cause damage to their

scantron as to make it unreadable, may be subject to disqualification.

- 11.) Talking or conferring during the contest is prohibited. Contestants cannot wear any markings, clothing items or jewelry that reveals identity or area of residency. Personal communication devices are prohibited. Contestants talking to anyone but a group leader may be disqualified.
- 12.) Contestants will be allowed twelve (12) minutes to evaluate all classes. Signals will be given to start the class and at various intervals to indicate time remaining. When the final signal is given, contestants will turn their back to the class.
- 13.) Lunch will be provided for all contestants during a break period in the contest. Coaches and leaders should plan to meet their contestants at the conclusion of their contests. REMEMBER, the Junior Youth Division will conclude before lunch time and the other Divisions will not conclude until later in the afternoon.
- 14.) The Executive Committee of the Southeastern Livestock Expo Judging Contest will interpret and enforce all rules contained here within and will rule on any other matters that may occur, of which, their decision will be final.


