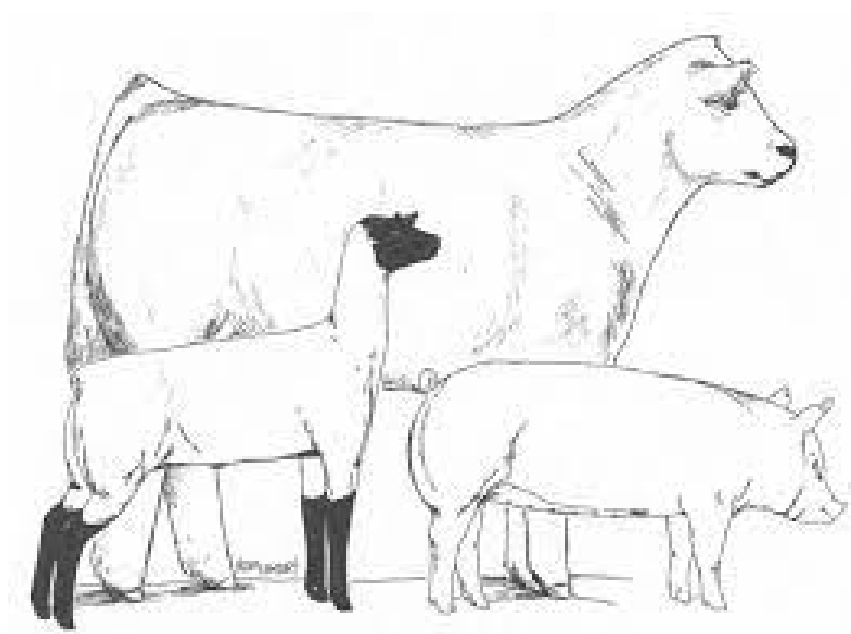

## **How to Enter the Fair**

- Visit [www.salina.fairwire.com](http://www.salina.fairwire.com) for the Online Entries home page, starting February 5th.
- Livestock Exhibitors must have your YQCA Certificate & SVF Sales Agreement complete and ready to upload.
- Register as an exhibitor.
- Click “Add Entry” and choose a “Department”.
- Within each department you will be asked to choose a “class” and information pertaining to your entry
  - Please answer each question accurately
  - Continue to add additional entries
- When entries are complete, follow the prompts to complete your shopping cart and pay for your entries
  - Remember! You must click “Save Cart” in order for your account to be saved
  - After “saving your cart” you may come back to pay at a later date.
  - Any “carts” not paid for by April 1<sup>st</sup> 11:59 pm will not be accepted!
- You will then be prompted to upload livestock documents, for example;
  - YQCA Certificate
  - SVF Sales Agreement
  - Prop 12 form (Hogs)
- Print out your receipt! This is your proof that you did indeed make the entry deadline

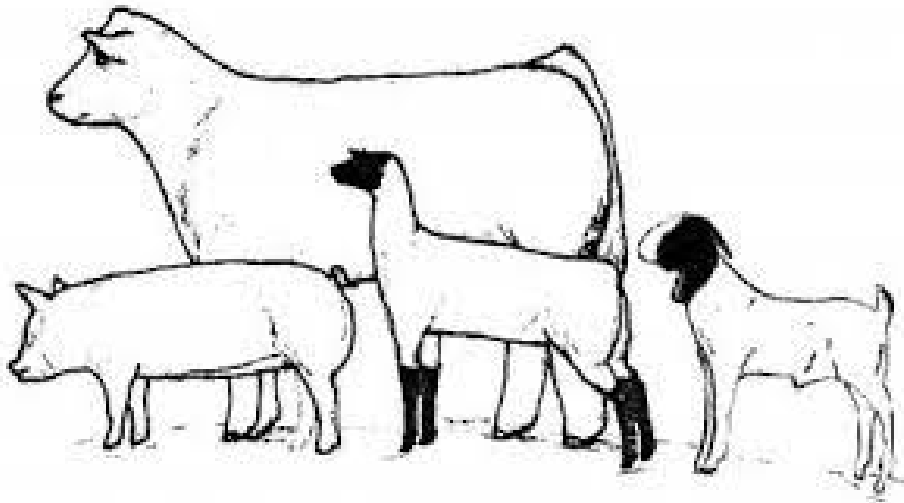

# CHANGES & REMINDERS 2025

## Still Exhibit

Livestock Exhibitors must enter at least 1 Still Exhibit in any department. This includes Rabbits and Poultry, except for primary members.

## Livestock

1. Pop-up tents may NOT have any sides. Tents must be completely visible to the inside of the tent, from all sides.
2. Stall decorations are optional, however club names must be identified. Decorations set up is Saturday receiving day, from 10 a.m.-4 p.m.
3. Pellet bedding is no longer allowed on grounds, shavings only (straw is acceptable for beef).

## Showmanship

1. Showmanship is mandatory.
2. Official uniform is required including a *4-H hat worn on the head* (see guidebook for uniform specifics).

## Market Hogs~ NEW

1. Market hogs will be divided into breed categories & weight classes. Breeds must be listed on your entry and cannot be changed after the entry deadline. At the scale, a Breed Classifier will evaluate each hog and determine if breed reclassification is necessary.
2. Breed categories- Light Cross, Dark Cross, Light AOB, Dark AOB, Hampshire, Yorkshire, Duroc.  
*See the Breed Classification PDF on our website, salinasvalleyfair.com for help*
3. Breed Champions and Reserve Breed Champions will compete in the final drive for 4-H & FFA Champions.  
4-H & FFA Champions will compete for Grand and Reserve Grand Champion.

## Market Goats~ NEW

1. Goat showmanship will be on FRIDAY 8:00 am.
2. Market Goats must be walked over to the hog show ring at 3pm on Sunday.

## Market Steers & Replacement Heifers

1. Exhibitors may only bring 1 market animal, specifically 1 Market Steer OR 1 Replacement Heifer.
2. Market steers will compete in a **SLICK SHEAR SHOW** and all shearing *must be done before arriving* on grounds.
3. Steers must be no older than 24 months,
4. Replacement Heifers must be at least 4 months bred by weigh-in day.
5. Replacement Heifer show is not a slick show, it is a “**Blow & Show**”.

## Gate, Security & Parking- NEW

1. **Clear purse/bag policy will be enforced** & all bags will be checked.
2. Food & drinks will be allowed through the gate until 10 am daily.
3. Ice chests will not be allowed to come in through the gates after weigh in day.
4. Absolutely no alcohol is allowed on grounds.
5. Please do not bring pocket knives on grounds, expect to be wanded at each gate.
6. Parking passes will be required to park on grounds beginning Tuesday of weigh-in, you will not be able to drive on grounds unless you are unloading animals & tack in the weigh in line. You will have time to unload and leave the grounds as soon as you are done. If you are arriving to feed your animal, you must walk in through any gate.
7. Stock trailer parking is available for purchase in the front office for the 101 Bowl or for free at the dirt lot behind Keefer's Inn on Canal St.

# **PASSES &** **CREDENTIALS**

*All ride bracelets, day passes and camping spots must be purchased through the Administration Office.*

## **Livestock Exhibitor Pass- Included in your Market Livestock Entry**

*All Market livestock exhibitors will receive a wristband with their livestock entry.* One per exhibitor, must have entered a market animal. Exhibitors who are solely entered in Rabbits, Poultry or breeding classes may still purchase the appropriate pass, email [livestock@salinasvalleyfair.com](mailto:livestock@salinasvalleyfair.com) with any questions.

## **Adult Pass- \$30.00**

Adults 18 years and older, good for the duration of the fair.

## **Non- Exhibitor Youth Pass- \$25.00**

**(not for livestock exhibitors)** Unlimited, includes youth 5-17 years old, good for the duration of the fair.

## **Rabbit Show- 1 Day Exhibitor- \$6.00, 1-Day Parent- \$8.00**

One per rabbit exhibitor. Parent passes are not limited. Must be entered in the Rabbit Show, good for Friday only.

## **FFA/4-H Leader Pass- \$30.00- (Not available to purchase online)**

-Leader wristbands will only be sold to recognized FFA & 4-H leaders. Please complete & deliver the Leader Form with payment to the Livestock Office by April 1st.

-Leader parking permits are an additional \$30, (regularly \$60). Please mark on your Leader Form if you would like a parking permit.

## **Beef Grooming Chute Pass- \$20.00**

Each beef chute that comes to the SVF must purchase a chute pass. Any chute passes purchased after April 1st will be \$30.00.

# GENERAL INFORMATION

## & LOCAL RULES

- The Salinas Valley Fair opens to the public at 11:00 a.m. Thursday, May 15, 2025 and gates close at 10:00 p.m. Sunday, May 18, 2025.

Entry Office (831) 385-3538 [livestock@salinasvalleyfair.com](mailto:livestock@salinasvalleyfair.com)
- Responsibility rests with each exhibitor for knowing and abiding by these Local & State Rules, and the Local Rules under each department throughout the Exhibitors Guidebook. Read carefully all portions pertaining to your entries and ask the fair office, your 4-H or FFA leader to explain any part you do not understand.

### AREA LIMITS

Unless otherwise specified by department, the Salinas Valley Fair competitions are open to residents and students of School Districts in the counties of Monterey, San Benito, Santa Cruz & Northern San Luis Obispo (North of SLO Grade), Coalinga High School & Coast Union High School Districts. See each division "Area Restrictions" for participation.

### ENTRIES

- **All entries are due online April 1<sup>st</sup>. No late entries will be accepted.**  
\*Online entries open February 1, at [www.salina.fairwire.com](http://www.salina.fairwire.com).
- All 4-H & FFA Division entries must be approved by project leaders or advisors.
- Livestock exhibitors are required to enter at least 1 Still (Non-Livestock) entry. It can be in any department and includes Rabbit and Poultry exhibitors, and excludes Primary Members.
- Wristbands: Adult and/or Youth Season Passes must be purchased with the exhibitors' online livestock entry.

### AWARDS & PREMIUMS

- Still exhibit premiums will be available for pickup Monday, following the fair. Any premiums not picked up within one week will be considered a donation to the Salinas Valley Fair.
- Auction and Livestock Premium checks will be available for pick up at the Livestock Office, 60 days post JLA. In the event that checks are ready early, leaders will be notified.

### REMOVAL OF EXHIBITS

- Check the beginning of each department for schedule, rules & premiums. Management reserves the right to reject any exhibit offered if it is objectionable in any way. Exhibits not picked up 1 week post fair will be considered a donation to the Salinas Valley Fair.

### TRAFFIC

- Weigh-in days and load out day, enter through Canal Street then exit to San Lorenzo Street.
- You must have proper parking permits to enter the grounds, and each parking lot will be assigned a parking pass. Parking passes may be purchased at the Admin. Office on Saturday (receiving day) starting at 12:00 noon, first come-first served.
- **Parking permits will be required beginning Tuesday, weigh-in day.** Vehicles unloading animals will pull through and leave immediately after unloading through the San Lorenzo gate. **No parking behind the barns as in years past. If you are coming on grounds to feed an animal, you must walk in using any of the gates.**

### RESPONSIBILITY

- Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from any animal or article exhibited by him/her, and shall indemnify the Salinas Valley Fair against all legal proceedings in regard

thereto. The fair will take reasonable precautions to ensure the safety of exhibits and property of description entered for competition or display or any other purpose while anywhere on the grounds that shall be subject to the control of the Salinas Valley Fair, but the owners themselves must take the risk of exhibiting them. In no case will the fair be responsible in any way for any loss, damage, or injury of any character to any property, article or person, while the same is on the fairgrounds or at any other time or place, nor be liable for or make any payment for damage, loss or injury. Presentation of entry shall be deemed acceptance of this rule.

- Violation of rules and/or misconduct by any exhibitor, adjudicated by the Livestock committee may result in forfeiture of market & showmanship awards, premium money and/or nullification of proceeds from sale, or participation in the auction. Market animals will be terminated at resale market price as posted on auction day.
- NO WHEELIES, BICYCLES, SKATEBOARDS, SCOOTERS or RECREATIONAL VEHICLES OF ANY KIND.
- Only Certified Service dogs allowed on grounds.

### STATE RULES

State Rules for California Fairs are incorporated by this reference and will be enforced. State Rules are available on the California Department of Food & Agriculture website, the Salinas Valley Fair Website and a copy is on file at the Salinas Valley Fair Livestock Office. # 2025 JUNIOR LIVESTOCK

## LOCAL RULES

### 2025 Entries ONLINE ONLY due by April 1st

*Please read this Exhibitor Guidebook carefully!*

#### Division Areas

*You must be a Primary Residence as well as a Club Member of the following areas:*

##### **LOCAL:**

Residents and members of 4-H Clubs and FFA Chapters located in Monterey County (including Parkfield 4-H), Santa Cruz County, and San Benito County.

##### **EXTENDED:**

Residents and members of 4-H Clubs and FFA Chapters located in Northern San Luis Obispo County located within the Atascadero, Templeton, Shandon, Paso Robles, Santa Margarita, Coast Union High School District (*Districts North of the SLO Grade*), and residents of the Coalinga High School District.

#### **LIVESTOCK ENTRY LIMITS**

*Large market animal classes will be limited as follows:*

A. Local areas can take no more than one of the following

- 1 Steer (or)
- 1 Heifer (or)
- 1 Hog (or)
- 1 Lamb (or)
- 1 Goat

B. Extended areas can only take one of the following

- 1 Steer (or)
- 1 Heifer (or)
- 1 Lamb (or)
- 1 Goat

C. Rabbit & Poultry Classes

- A. Rabbit Breed Show is open to all youth in the State of California, area limits **do not** apply.
  - Showmanship requires enrollment in 4-H or FFA to participate, area limits **do** apply.
- B. Exhibitors from Local & Extended areas are limited to 2 Rabbit & Poultry Market/Meat pen entries, only the 4 Champion and Reserve Champion meat pens will be sold in the Junior Livestock Auction, *see class rules*.

### **FFA MEMBERS**

FFA members must be enrolled in a high school vocational agricultural class to be eligible, and may exhibit as FFA members through the end of the calendar year following graduation.

### **4-H MEMBERS**

4-H members must be 9 years old or in the 4th grade, as of January 1st. A member may show in 4-H through the calendar year they turn 19. If they turn 19 in December, they are not eligible to compete at the following Salinas Valley Fair.

### **INDEPENDENT EXHIBITORS**

Non 4-H/FFA/GRANGE Junior Exhibitors of market animals will show and be judged in a class assigned by fair management. In order to qualify as an Independent Exhibitor, you cannot have been registered as a 4-H/FFA/Grange member for 2 full years prior to this year's fair. This rule is in place to keep exhibitors from "club hopping" to avoid an organization's rules and regulations. Exhibitors must be at least 9 years old or in the 4th grade as of January 1st. Exhibitors are eligible to compete/exhibit through the calendar year they turn 19. If they turn 19 in December, they are not eligible to compete in the following SVF.

- Independent exhibitors entering a market animal must provide fair management with a picture, permanent tag and/or tattoo information 120 days prior to the fair for beef and 60 days for sheep, goats & swine.
- Independent exhibitors must turn in a binder at weigh-in, showing all record keeping for that animal. No record book, no show.
- A parent/guardian must fill out a "Leader Form". They will assume all responsibility for the exhibitor and any responsibilities & duties as a project leader.

### **ELIGIBILITY**

An exhibitor must be in good standing with their 4-H/FFA/Grange chapter. A list of exhibitors will be emailed to the Leader/Advisor for verification. The advisor or project leader has the final say on the exhibitor's participation until the moment the exhibitor crosses the scale. At that time, the exhibitor is contractually obligated to show, receive a grading and sell the animal at the Salinas Valley Fair Terminal Junior Livestock Auction. Unless the exhibitor has violated rules or missed a market class in which the Livestock Committee has the final decision.

\*\*\*Livestock entries will not be accepted if a family member purchased or acted as a buying agent for a market animal at any previous livestock auction and has not paid Salinas Valley Fair for the animal, before December 31<sup>st</sup> of that year.

### **BREEDING OWNERSHIP REQUIREMENTS**

- Registration certificates or bill of sale.
- Paperwork must show a minimum of 30 day ownership in the exhibitor's name.
- Sheep breeding paperwork must be checked in on weigh-in day, between 8 am-12 p.m. in the Livestock Office.
- Exhibitors must own and must show their own animal.

## MARKET OWNERSHIP REQUIREMENTS

Date of ownership is defined as the date printed on the bill of sale, as well as the exhibitor's sole care and management of the market animal, within the ownership dates listed at the front of this guidebook.

## TRANSPORTATION

Transportation permits for beef will be given to leaders along with the ear tags. Beef must be ear tagged prior to weigh-in day. All brand inspections, bill of sales, medical release, and out-of-state health inspection papers must accompany beef animals on weigh-in day.

## WEIGH-IN

- Market classes are determined by weight on weigh-in day.
- All animals must be weighed in by an exhibitor.
- Wild cattle will not be allowed, fair management has the final decision to send such animals home.
- All market animals over/under weight will go home immediately.
- Reweighs will be at the discretion of fair management and must be during scale hours.
- Bill of sale, (made out to exhibitor) must be available at weigh-in *upon request*.
- SVF Medication form must accompany animals on weigh-in day.
- Animals will be inspected upon arrival & weighed in prior to penning.
- Beef may be penned prior to weighing.
- All animals are to arrive 'show ready'- only touch up clipping preferred.

## POSTING OF CLASSES

Lists will be posted daily in each species area of the barn, located on the tripod. It is the exhibitor's responsibility to read these posted lists. If an exhibitor believes they are in the wrong class, please notify the clerk or the livestock office immediately.

## PEN DECORATIONS

### CLEAN STALLS & BEDDING

- **Decorations are optional and do not count towards Clean Stall Awards.** Decorations must be installed by Saturday before the fair (receiving day), between 10:00 am - 4:00 pm. Stanchions and beef blocking chutes may be unloaded when your animals arrive on grounds. Weigh-in day is primarily for the arrival of the animal. The fair is not responsible for loss or damage of any items. Decorations and kickboards may not be taken down until 3:00 pm on Sunday of the fair.
- Bedding is not provided. Bedding material must be shavings for all animals, **NO pellet bedding**; however, beef may use straw or shavings. L. A. Hearne Co. will be on grounds with bedding for purchase each morning.
- Feed, bedding, tools and other show equipment must be stored in your assigned tack pens. Exhibitors are to provide their own wheelbarrow and/or tools. Pens and stalls must be kept clean at all times. The aisles in all barns are to be clear of grain, hay, manure and bedding.
- The Clean Stall committee will check pens daily. Points will be compiled by the Danish System and posted in the barns. A Red Tag will be given to any stall not kept up to standard.

## FITTING & WASHING

- **Professional groomers & fitters are not allowed to fit.** Junior exhibitors must groom and fit their own animals or help each other. All market and breeding animals must be in show condition on weigh-in day.
- **Handlers are not allowed in the show ring.** If assistance is needed (i.e. medical condition), it must be approved in writing by the Livestock Committee prior to fair. The assistant must be in the same organization, and must be in appropriate uniform.
- Show rings will not be used for tying, feeding or drying animals.
- Stanchions outside the barns must be placed in the designated fitting area for each species and not block traffic.
- Animals must stay in the designated livestock area. Sheep and swine stay in Topo Barn area, goats and beef stay in Rava Barn area.
- No blowers or generators inside the barns.

## DAILY FEEDING TIMES & NIGHTLY CURFEW

Daily feeding times: 6:00 am to 8:00 am & 5:00 pm to 8:00 pm.

Livestock barns locked: 9:00 pm to 6:00 am

## RED TAG POLICY

Livestock exhibitors are solely responsible for the care of their animals while on exhibit at the Salinas Valley Fair. If SVF becomes aware of any livestock exhibit that is not being cared for in an ethical, humane manner or situations where an acceptable state of pen cleanliness, as determined by the livestock management staff and/or Livestock Director, is not being maintained, the following will occur:

1. The Salinas Valley Fair Livestock Director, overseeing the species of animal in question will determine the name and affiliation of the responsible exhibitor.
2. The Salinas Valley Fair Livestock Director will notify the Livestock Superintendent of the responsible exhibitor to obtain a Red Tag and at such time the Livestock Superintendent will record the violation.
3. A Red Tag, with the following information will be affixed to the exhibitor's pen/stall:
  - a. The exhibitor's name
  - b. The observed problem
  - c. The date and time of the citation
  - d. Signature of the responsible Livestock Director & Livestock Superintendent
1. It is the exhibitor's responsibility to respond to the Red Tag by contacting the Livestock Director.
2. The Livestock Director and the exhibitor will formulate and initiate a plan of correction.
3. Reasonable efforts will be made by the responsible Livestock Director to contact the exhibitor's FFA advisor, 4-H leader, parent or designee and advise them of the situation resulting in the Red Tag citation.
4. Any exhibitor failing to make contact with the Livestock Superintendent within six (6) hours of issuance of citation may be issued an automatic second Red Tag citation.
5. Any exhibitor receiving two (2) Red Tag citations during the fair will be declared ineligible for further competition. If the animal is a market entry, the animal will be sold in the terminal Jr. Livestock Auction at current market price. The exhibitor will forfeit all add-ons & awards. If the animal is a breeding show animal, the animal will be removed immediately.

## RELEASE OF LIVESTOCK & LIVE PICK-UP

- Walk out tack is 3:00 p.m. on Sunday.
- Vehicles entering the fairgrounds to pick up breeding livestock must enter at the Canal Street gate and the exit at the San Lorenzo Street gate beginning at 4:00 p.m.
- Breeding animals, rabbits & poultry can leave the fairgrounds at 4:00 p.m.

## SICK OR AILING ANIMALS

If an animal is in need of immediate care, SVF does not have a veterinarian on call. The livestock office will have a list of veterinarians the exhibitor may call; however, the exhibitor must assume the expense of the veterinarian's service.

In the event that an animal is in need of immediate care, and the owner/exhibitor and leader/advisor is unreachable, the owner extends authority to take such action as deemed expedient and necessary, to the fair management. Fair management has power of attorney for the exhibitor in this instance and by virtue of signing the original entry, the Salinas Valley Fair will not assume any cost for action taken pursuant to this rule.

## VIOLATION OF RULES & DISQUALIFICATION

- Errors made on a livestock online entry may result in disqualification or a \$100 fine. Scrapie Tag I.D., breed, sex and birthdates are all important information that is recorded and kept on file for the USDA to inspect at any time. Records must be accurate. Incorrect information on an entry form will appear as cheating.
- Abuse of animals by exhibitors or handlers is grounds for disqualification.
- Violation of rules and/or misconduct by any exhibitor, adjudicated by the Livestock Committee, may result in forfeiture of premium money and proceeds from sale through the Junior Livestock Auction. All market animals will be terminated and sold at market price as posted on the day of the livestock auction.

- Exhibitors are urged to remember that the continued growth and development of the fair depends, in a large measure, upon the interest and support of their fair-going neighbors and the general public. For this reason, exhibitors should assist the fair management by keeping exhibits and displays clean, neat and attractive. Awards may be withheld if animals are not fed, watered and cared for while at the fair. See RED TAG Procedures.

### **PROHIBITED SUBSTANCES**

- The use of stimulants or depressants will not be tolerated. **Important:** All market animals are subject to inspection for Drug Residues. Animals containing unauthorized residues will be condemned and the parties responsible for these residues are subject to prosecution under the Food, Drug and Cosmetic Act. Offenders will be banned from any future Salinas Valley Fair.
- Any exhibitor with a market animal that does not pass the random drug test inspection, will forfeit all auction proceeds and will no longer be welcome to show at any future SVF events. Salinas Valley Fair takes the health and wellbeing of our community and consumers extremely seriously.

### **PARKING**

- Parking passes will be sold on a first come first served basis starting at 12:00 pm Saturday (receiving day) out of the Admin. Office.
- Parking passes will be required to park on-grounds, in 101 Bowl & Canal St. starting Tuesday, weigh-in day. Animal traffic will enter from Canal St., pass through vet check, pull forward to unload and immediately exit through the San Lorenzo gate when done unloading.
- Leaders will have the option to purchase a parking permit for the Canal Street parking lot or the 101 Bowl parking lot on their Leader Form (due April 1st at the livestock office).
- Ten (10) trailer parking spots will be available for purchase for \$200 in the 101 Bowl parking lot.
- Any vehicle or trailer parked without a parking permit will be towed at the owner's expense.
- There will also be **FREE stock trailer parking** in the vacant lot behind Keefer's Inn.

### **CAMPING**

All camping spots are first come first served and must be purchased at the front office. See camping deadline information on the [Salinasvalleyfair.com](http://Salinasvalleyfair.com) website.

## GENERAL RULES

*EXHIBITORS MUST PRE-ENTER ONLINE ONLY BY APRIL 1ST*

1. Showmanship is mandatory for all animals entered into market classes, excluding Poultry & Rabbit Meat Pens. A \$25 fine for any exhibitor that is a No Show in their showmanship class. If an exhibitor has a valid reason they cannot participate in showmanship, they must notify by writing or email the livestock office asap with a request to [livestock@salinasvalleyfair.com](mailto:livestock@salinasvalleyfair.com) and receive an approval.
2. **Age to be used is as of January 1st.**
3. All exhibitors are **required to wear the official show uniform** of the organization they represent. See below.
4. Independent Junior exhibitors will dress in whites.
5. Premiums are offered for 4-H/FFA **Senior Showmanship** only:

1st	2nd	3rd
Buckle	\$20.00	\$10.00
6. You must show your own market animal in showmanship.
7. If you do not have a market animal, you may show your breeding animal in showmanship.
8. Judge's decision is final.

### 4-H NOVICE SHOWMANSHIP

Exhibitors 9-11 years old who have never shown this species at a fair. Top 3 progress to junior final drive.

### 4-H JUNIOR SHOWMANSHIP

Exhibitors 10-11 years of age, who have shown this species at a fair & exhibitors 12-13 years old, regardless of showmanship experience. Top 3 progress to senior final drive.

### 4-H SENIOR SHOWMANSHIP

All exhibitors age 14-19 years of age, regardless of showmanship experience.

### FFA NOVICE SHOWMANSHIP

Exhibitors have never shown this species of animal at any fair. Top 3 progress to senior final drive.

### FFA SENIOR SHOWMANSHIP

All other FFA Exhibitors.

## SHOW UNIFORM

Complete uniform of the exhibitors organization is required

**FFA Uniform-** This uniform shall be worn by FFA exhibitors and helpers while showing livestock. The uniform shall consist of white trousers, white dress shirt and official blue necktie for boys or official blue scarf for girls. The Official FFA jacket is optional during excessive heat; if worn, the shirt emblem is not required. Hats or headgear of any kind shall not be worn with the official show uniform while showing. Footwear and belts need to be clean, if boots are worn they must be inside and covered by the pant leg. No sandals allowed.

**4-H Uniform-** This uniform shall be worn by all 4-H exhibitors while showing livestock. Uniform shall consist of:

- 4-H cap, white shirt or blouse with 4-H collar for girls & a 4-H necktie for boys. Hat must be worn on the head.
- Trousers may be black or white, no denim color or acid wash allowed, girls may also wear black or white skirts. Footwear and belts need to be clean, if boots are worn they must be inside and covered by the pant leg. No sandals allowed.

**Independent Uniform-** Independent Jr. Exhibitors are required to wear all white trousers & white collared shirts.

1. **This is a terminal sale. All animals that cross the scale on weigh-in day, become contracted to sell at the Junior Livestock Auction of the Salinas Valley Fair, with the exception of replacement heifers. No animals will be allowed to scratch from the auction. Only replacement heifers will be sold for a live pick up. It is the exhibitor's responsibility to continue providing care for their animal, until 3 p.m. Sunday of the fair.**
2. All Champion animals must be walked through the auction by the original exhibitor. If any exhibitor has a medical or family emergency, they may submit a letter to the Livestock Committee requesting a replacement exhibitor to walk their animal through the auction, approval is needed, but is not guaranteed.
3. If the exhibitor is not with their animal by the time their auction lot begins, the animal will be scratched from the auction sales list. Any market animal exhibitor found to be in violation of rules and/or misconduct, adjudicated by the Livestock Committee, will be scratched from the auction sales list.
4. Any market animal scratched from the Livestock Auction Sales List, will still be required to sell at the Posted Resale Price and will be harvested through the terminal Junior Livestock Auction.
5. **Auction checks will be available for pick up 60 days from the auction date.** (If auction checks are ready early, project Leaders will be notified.) This date was chosen based on the reality that auction checks cannot be issued until the majority of buyers have paid their auction bill in full. We thank you for your understanding. A \$50 fee will be applied to any lost or reprinted checks.
6. Selling charges collected on all livestock sold through the SVF JLA:
  - a. SVF Commission 8%. (Auction & Add Ons)
  - b. Ca. Cattle Council Fee \$1.00 (Steers)
  - c. Ca. Beef Council Fee \$1.00 (Steers)
  - d. Pork Board Fee - .0045 x the gross price (hogs)
  - e. Lamb Council Fee - .007 x per pound (sheep)
  - f. Lamb 1st Handler Fee- \$0.42 per head (sheep)
  - g. Photo fee \$20.00 (two color pictures of the exhibitor and animal- all market exhibitors)
7. Exhibitors photo fee will provide the exhibitor with 2 professional photos. One photo shall be provided to your buyer along with their "Thank You" letter before receiving auction monies from advisors or project leaders. Seller/Buyer/Add-On information will be provided to the project leaders.
8. All market animals are subject to inspection for Drug Residues. Animals containing unauthorized residues will be condemned and the parties responsible for these residues are subject to prosecution under the Food, Drug and Cosmetic Act. **Any exhibitor with a market animal that does not pass the random drug test inspection, will forfeit all Auction Proceeds, Add-Ons & Awards, be liable for 3 times the amount the animal was sold for in the JLA and will no longer be welcome to show at any future SVF livestock events.** Salinas Valley Fair takes the health and wellbeing of our community and consumers seriously.
9. Beef cattle sold at auction MUST be accompanied by a Brand Inspection Certificate and bill of sale as proper proof of ownership.
10. Junior livestock entries will not be accepted if a family member purchased or acted as a buying agent for a market animal at any previous livestock auction and has not paid Salinas Valley Fair for the animal.

**Livestock will be sold in the following order, but subject to change:**

**Ring A - Odd lot numbers**

Hogs, Heritage Animal,  
Champions (Including Rabbits & Poultry)  
Heifers, All Beef, Lambs

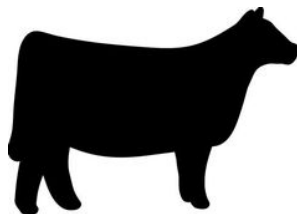

11. **All animals, especially champions must be sold through the Junior Livestock Auction.** Only the champion animals will sell for Poultry and Rabbit Meat Pens.
12. Sale order within each species will be in alphabetical order by club, starting with clubs that begin with the letter H. This gives the clubs who sold first in the last auction a chance to rotate.
13. Add-on donations will be taken in person during the sale. Add-on donations will also be available online beginning on auction day through one additional week after the sale. An 8% commission will apply to all Add-Ons.

#### **RULES**

1. **MARKET STEERS-SLICK SHEAR SHOW-** All steers must arrive clipped to no more than ¼” of hair on any part of the body, except the ears and tail switch. (The tail switch being not more than 12” above the end of the cartilage of the tail). Tail switches clipped to no more than 6” and may be ratted and balled or may be bobbed off. Shearing will not be permitted on grounds, touch up clipping only.
2. **NO PROFESSIONAL FITTERS or HANDLERS** may assist in staging or prepping of the animal or assist in the ring. Exhibitors must fit their own animal or help each other. False tail switches, tail fins, or any hair like substance added to the animal’s body, or any grooming materials that allow color to come off the animal will not be permitted.  
**(REPLACEMENT HEIFER SHOW- “BLOW & SHOW”, NOT A SLICK SHEAR SHOW)**
3. Ear tags will be issued to project leaders on a designated “pick up day”.
4. No dairy breeds.
5. Nose rings will not be allowed in the show ring.
6. All overweight and underweight steers must go home immediately and cannot stay on the grounds.
7. No generators inside the barns.
8. **Grooming Chutes-** Exhibitors must purchase a \$20 Grooming Chute Pass for each chute they intend to bring. Passes must be purchased online & found in the Passes & Credentials Department. Any chute passes purchased

after the April 1st deadline, will be at a cost of \$30 for each chute. Chutes must be placed in the designated area, outside on the south side of the barn with the provided flag.

9. **Pop up tents are allowed in their designated area but must be open and visible. Walls will not be allowed.**
10. **Decorations and kickboards** must be installed from 10 am - 4 pm Saturday receiving day. Weigh-in day is for tack & animal drop off only.
11. On Sunday, decoration tear down and tack removal may begin at 3 pm and can be walked out of the gate. Driving on grounds begins at 4 pm.
12. No Shows- Any Beef animal entered into the SVF that does not show up, or does not notify the SVF 20 days prior to weigh-in day, will be assessed a fine, unless accompanied by a vet notice. *Stalls assigned to no-show animals, will be forfeited.*
13. **Steers must be no older than 24 months and may not display their 2nd set of teeth. Teeth will be checked at Harris Ranch and the carcass may be rejected. If a carcass is rejected by the processor, all auction proceeds will be null and void.**
14. A health check will be performed by a veterinarian at the scale during weigh-in.
15. Horns are not permitted. Scurs must be loose and 1" or less.
16. Please don't leave the show ring until your class is excused.

### **MARKET BEEF SCORECARD GRADE**

**GROUP 1:** Animals grading USDA Prime or Choice in quality grade: having superior and **above average** conformation and cutability. Yield Grade 1 or 2.

**GROUP 2:** Animals grade USDA Prime or Choice in quality grade: having **average** conformation and cutability. Yield Grade 1, 2, or 3. Animals grading USDA Select + in quality grade; having superior conformation and cutability. Yield Grade 1 or 2.

**GROUP 3:** Animals grading USDA Prime or Choice in quality grade: having **below average** conformation and cutability. Yield Grade 4 and 5. Under finished animals that are average or below average in conformation: grading Select + or lower in quality grade and will not be sold in the auction and may be picked up at 3pm on Sunday.

### **RULES**

1. All market steers sold through the Salinas Valley Fair Junior Livestock Auction will be automatically entered into the Carcass Contest.
2. Carcasses will be graded by the time of slaughter by USDA graders and the results compiled in cooperation with the Agricultural Extension Service.
3. To be eligible for cash awards, steers must not have more than one pair of permanent incisor teeth showing and the carcass must have a USDA quality grade of select plus or better.
4. Placing will be based on USDA yield and quality grades. The actual mechanics of applying these principles will be as follows:
  - a. Yield of boneless retail cuts to the nearest 0.1% will be determined from USDA yield grades.
  - b. Quality grades will be determined to the nearest one- third of a grade under current USDA standards.
  - c. Subtract 0.8% from the estimated yield of cuts for each one-third grade quality difference from high prime. This combines the yield and quality factors into a carcass index.
  - d. Ties in the carcass index will be broken by dividing ribeye area by hot carcass weight, and those with higher values will be ranked first.

## BEEF REPLACEMENT HEIFERS

### **RULES**

1. **Replacement Heifer Show is a “Blow & Show”, not a slick shear show.**
2. The exhibitor must have had ownership of their heifer for 120 days. **A bill of sale and brand inspection certificate is required at the scale as proof of ownership.**
3. If a breeding or health problem occurs, a substitute heifer may be allowed if it is owned by the exhibitor by March 1, and is approved in writing by the Salinas Valley Fair.
4. Heifers must be 20-28 months old on weigh-in day.
5. **Heifers must be at least 4 months bred by weigh-in day and will be preg tested by a veterinarian on weigh-in day.** All heifers must be bred to a bull of a beef breed.
6. All heifers must bear evidence of having the official calthood brucellosis vaccination with the presence of an official tattoo visible in the right ear.
7. **Professional groomers, fitters or handlers are not allowed** to assist in staging or prepping of the animal. Exhibitors must fit their own animal or help each other.
8. All animals must sell in the SVF Jr. Livestock Auction.

- 9. If a replacement heifer is not bred the exhibitor must take the animal home on weigh-in day.
- 10. Pop up tents are allowed in their designated area but must be open and visible. Walls will not be allowed.

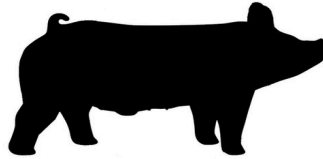

3. All exhibitors must supply individual water containers. All tack boxes must be kept inside assigned pens or designated areas. There shall be NO loose feed pans left in pens, with the exceptions of Thursday during the market show.
4. All overweight and underweight hogs must go home immediately and cannot stay on the grounds.

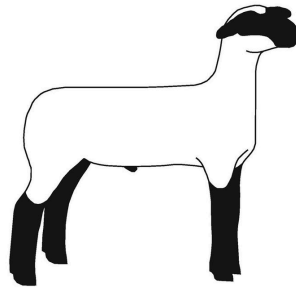

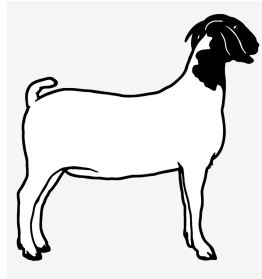

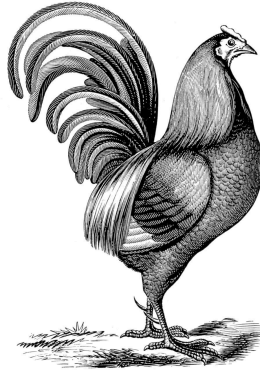
