Director Espericueta- Tab 7 shows the April 30<sup>th</sup> figures on the Balance Sheets. In April we brought in \$284,000 revenue. We had \$300,000 in expenses for a negative \$21,000 for the month. For comparison, the next page shows how it corresponds YTD going back to April 2020. We are topping every other past year. Our expenses were less than they were last year. Tab 3 starts May financials. On the Balance Sheet we still have \$2.9 million in cash in the investment account. Our payables are down from last year. It's a strong-looking balance sheet. Going to the revenue side we brought in \$313,000 in May and we spent \$311,000. We broke even at a \$13,000 net. Which is good because we never break even until the fair. Kudos to Lili & Staff. This money is mainly driven by Interim Events and Parking. Looking at past years we are looking at higher revenue than any other years in May and our expenses are second on the list. So we are doing good.

# Livestock Committee - Blodgie Rodriguez, Chairperson

a. Kern County Agriculture & Leadership Program

Chad Carol- I am one of the Board Members of the KCALP along with Jennifer and Carrie. We would like to talk about our program. We also have Celest Rickett who is one of our Jr Board Members. Are club and groups are involved in several projects. We promote and help any of the kids that are involved in Agriculture that are showing as an Independent. We are strictly just here for the Kern County Fair. Our exhibitors, and on top of us being on the Board, we have two Jr. Board Members. Part of our program also helps our kids, not only with what they are doing in high school, showing animals and stuff for fair, but also showing them career paths that lead them later on in the future.

Jennifer Eyraud- I am also a Board Member for KCALP. One of the biggest things we are striving for is that we see a niche that needed to be filled with Independent exhibitors. They miss fair dates, deadlines, and they do not have guidance out there. I am not saying they are not being helped. This is for kids choosing to be Independent. We have project leaders for every project. If they want help, we are there. If they do not want help, we are still there. We meet monthly with the kids, and they have meeting parliamentary procedure. They vote on every dollar that is spent with the club has earned. They decide where the money goes. The kids do run their meetings, and they must put together agendas, proposals and our goals are to create stronger leaders. I would like to introduce Celest Rickett, one of our Jr. Board Members. I know this is a new program and we do not want to take anything away from the Kern County Fair. Our kids show year around. We host many organizational events open to all youth, Kern County, California and surrounding areas. We are getting ready to put on a "Totes My Goat Show". We already have \$3,000.00 in scholarships for that show and for the kids.

Celest Rickett- Hi, I am 19 years old and this year I had the opportunity to of being a Jr. Board Member of KCALP. I believe this organization stands for many things. We want to empower youth, encourage the pursuit of agriculture careers, and support our members through education and financial support. This year we put on our first Annual Boots and Bling Fundraiser. I got to be a big part of planning and putting on this event which was very fun. For the event I went around talking with businesses, people in the community along with the other Jr. Board Members. I enjoyed being able to help. It was very refreshing seeing the youth run an event like this. I was even able to MC the event speaking in front of everyone. It was an awesome opportunity for me. I am also helping put on "Totes My Goats Show and Clinic" as a Jr. Board Member. This organization is run by the youth for the youth. Another opportunity the organization has provided, is being able to help Independent Exhibitors with their projects. Overall, this organization

has been a great outlet for me and I look forward to continuing to help the youth in our community.

Director Torres – When did you organize?

Jennifer Eyraud- We hit the ground running about a year now. The biggest thing we are most excited about is our Kern AG Foundation. We are going to do scholarships with them open to kids that show as an Independent. Scholarships for kids that show Independent are lacking. Th Director Johnson- you guys are a non-profit.

## Facilities/ Business Development Committee - NaTesha Johnson, Chairperson

Director Johnson- Working on the bids for the roofs.

CEO Olcott- As NaTesha and I discussed we put in bids for the roofs and as you know I spent \$373,387.50, initially for all roofing of all 3 buildings. Well, the bids came back and it's going to be about \$345,000 for 1 building. So, it's way over the cost that they had said it would be for all three buildings. I work through CCA, and I have no choice but to go through them. Therefore I can do building #1 which is the worst building it has mold and leaking. The new roof will add an R rating on the roof to help insulate it. Right now, I am only able to do one building. I was hoping to do all three, but the price is too high. Everything is going way over budget up and down the state. Asphalt is almost done we are going to finish out to the Belle Terrace Parking Lot from the times square area. We are using that parking lot more for events. We will be working on the poultry barn later in summer.

Director Espericueta- can we table it to see if we can buy the foam machine and do it ourselves. CEO Olcott - Yes, we can.

Director Torres- But this might be an issue with liability.

CEO Olcott – I don't believe we can do this ourselves because of the Liability and all the permits to do it.

Director Dunphy- I don't know what to vote or do?

CEO Olcott - You don't have to vote since you already approved it and directed me to move forward. I can stop the project from going forward.

Director Espericueta- have they started work?

CEO Olcott - No they haven't started work yet.

Director Espericueta- I would put it on pause. The price is not acceptable.

Director Lidgett- Are there any other fairs that have roofers on staff?

CEO Olcott – I don't believe any of the fairs have a roofing staff. That would have to go through CCA to go out to bid.

Director Dunphy - I agree we should table it.

CEO Olcott - I think this price is ridiculous and I will cancel the project and we can revisit it at a later time.
