bond for November ballot and it includes \$100 million for Fairgrounds/CDFA; that bond will be on the California ballot in the fall. AB 2143 code clean-up bill on Monday will be on the Senate Floor. Discussion of CEO salary has come up with CDFA. SB 1261 (increase to Fair Funding) will move to the Assembly Appropriations Committee on August 15th, Branding & Marketing – Working on website CDFA Liaison – kick-off meeting was held by Chair Moore, reviewed the committee charter, and scope of work of committee. Aimed to repair relationships with CDFA & the network. Reviewed big sheets from the Managers Conference. Four big areas of focus: Rules & Regulations, Disparity of resources, Executive development (mentorship), DAA-only issues: compensation and board Appointments. 18-month work plan Finance - Carlene Moore is now the Treasurer and previously served as CDFA Liaison Chair, we are now looking for a replacement Chair. Supplemental dues have been sent out. The annual meeting at Managers Conference will have a work session to identify budget needs. **Member Communication** – Create materials to garner support for Prop 4. Model after SB5 communication

Cummings noted the proposed CFA Bylaw amendments will be sent to the WFA Board by August 11, 30-days in advance of the September 12 WFA Board Meeting.
