Finance Committee - Lucas Espericueta, Chairperson

Director Espericueta- Tab 3 the Memo. We are in a really strong position. We have a good amount of cash, and our payables are down from last year. We are ahead in the cash department. Now go to tab 4 you will see Payments we broke even and actually made a profit last month about \$58,000 compared to last year where we lost \$300,000. Director Chavez -The maintenance from 2023 to now it \$200,000 short is that right.

Director Espericueta- Mike has really been hammering overtime. To keep it down. That is why we have \$250,000 savings on maintenance alone. Last year our expenses in August were \$943,000 and this month they were \$623,000. The next page is Year to Date so January to August 31<sup>st</sup>. Going back the last 5 years we are currently sitting at a negative (\$588,000) position which is the best we've had in the past 5 years for pre-fair expenses. Last year we had a 1.3 million deficit as of August 31<sup>st</sup>. We are ahead a couple thousand dollars.

Director Chavez – The fair admission is up, is that just money coming in sooner or actual ticket sales?

Mike- Yes, presale tickets.

Chairman Britschgi - What do we have in presales right now?

Mike-I don't know, because it keeps rising and the sale ends at 11:59 Tuesday the 17<sup>th</sup>. I had a thousand pre-sale tickets purchased today alone.
