Insurance Requirements

All concessionaires and exhibitors participating in the N.C. Mountain State Fair are required to provide a certificate of insurance showing General Liability Insurance with a minimum of \$1,000,000.00 per occurrence. The company must be licensed to do business in the State of North Carolina and the certificate must be countersigned by an agent of record approved by the Commissioner of Insurance, State of North Carolina. The certificate must name the N.C. Mountain State Fair as Additional Insured. This Certificate is required after a contract is written. This form is an application only.

Product Liability Insurance is required of Food Concessions or Commercial Exhibitors selling or giving away any consumable food or drink product and those who have products that are applied to the skin. This includes but is not limited to lotions, magnets and services such as blood pressure checks and chiropractic procedures.
