The Campbell County Public Land Board meeting was held on August 14^{th,} 2025, at the CAM-PLEX. The meeting was called to order by Board Chair Chapman at 6:30 PM.

5. STAFF REPORTS

5.1 Executive Director's Report (Attachment "C") – Director Lyles highlighted key points in the Executive Director's report, notably the upcoming trainings for the Directors, Sales Managers, and the Performing Arts Manager and the request for some last-minute bookings. Request was made to move the next board meeting up to 9/04/25 to accommodate the new booking and the staff conferences. "The Windmill" a watercolor painting by Guy Robinett was delivered to Cam-Plex today gifted from Peggy Ostlund in honor of her father, John Ostlund, along with a letter and was presented to the board.

5.2 Facilities & Operations – Mr. Beyerl reported on the successful completion of his first national event, FRVA, followed directly by Campbell County Fair. He noted that the contract for the Central Pavilion Heater replacement is nearing completion. Mr. Beyerl also provided an update on the tight timeline for the Burn-Out pad project. Additionally, interviews are currently underway for Event Tech Supervisor position.

5.3 Events – Sales and Events Managers reported on a very full month of bookings for September. Starting off with the Fizz Bomb Classic Barrel Race, hosting the Dwarfanators Midget Wrestling and the Spirit of Wyoming Expo, bringing together vendors and community activities. Followed by NADAC Pre-Trial and Championships, Chamber of Commerce Speakers Series, the Army Deployment event, The Jehovah's Witness Assembly, and a Lip Sinc Battler. Welcoming back the

Wyoming Mining Association Safety Show, PACA Regional Corriente Cattle Show, as well as the State Elks Lodge Convention. September also brings the Black Cat Ball, a performance by the Dan Tyminski Band, the 4-H Chili & Bingo Night Fundraiser, and the Wyoming Working Together event. New to Cam-Plex is the Power and Love Conference. Wrapping up September with the Kiwanis Hunter's Feed, The Powder River Symphony and Bill Blagg the Science of Magic.

5.4 Finance – Mrs. Wendy Balo reported that finances are in good standing. She's been gathering information for the fiscal year 2023-24 audit and continues to work on year-end financials and has sent draft financials for June while continuing to work on year-end accruals. She briefly reviewed the quarterly investment report, noting that investments were up about 5% over last year and the current CD rates are in the 4% range on CD returns. Director Lyles reported on a visit from Troy Hunsucker with Wyoming CLASS regarding our investment portfolio, wanting to know if the board would like him to present at the next meeting. Discussion followed and Mr. Lyles will coordinate with Mr. Hunsucker prior to our next meeting.

Cost estimates and contractor availability are expected to be received by August 22^{nd} . The original pad size of 100×200 has been trimmed to 80×180 with Cam-Plex doing the demo. Timeframe has caused a re-evaluation of bid process procedures.
