BRAZORIA COUNTY FAIR REALEASE OF LIABILITY AND INDEMNITYY AGREEMENT

In consideration, the receipt and sufficiency of which is hereby acknowledged, for allowed entry into and participation in activities (the "Activities") associated with the Brazoria County Fair Association ("BCFA"), the undersigned herby enters into this RELEASE OF LIABILITY AND INDEMNITY AGREEMENT (this "Agreement") as of the date set forth below.

- 1. ACKNOWLEDGEMENT OF RISKS: The undersigned recognized and understands that there are risks associated with their participation in the Activities including, but not limited to, bodily injury or death to persons and damage to property. The undersigned further acknowledges and understands that they will be held liable and responsible for any and all damage to persons, livestock, vehicles, property, and/or improvements to property that is caused by them and/or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Activities.
- 2. **RELEASE FROM LIABILITY:** The undersigned hereby REALEASES, ACQUITS AND FOREVER DISCHARGES, and shall DEFEND, INDEMNIFY AND HOLD HARMLESS BCFA, its subsidiaries and affiliates and their present and former directors, officers, employees, agents, and representatives and the respective heirs, administrators, executors, successors and assigns (collectively, the BCFA Parties or individually, an "BCFA Party") from any and all claims, causes of action, suits and/or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown relating to or arising out of any negligent, grossly negligent and/or intentional or unintentional acts of the part of the undersigned in connection with his/her entry into and participation in the Activities. Without limiting the forgoing, the undersigned agrees that the BCFA Parties shall not be liable to him/her, his/her family, heirs, administrators, executors or assigns for Claims arising from or related to the undersigned's entry into and participation in the Activities.
- 3. As used herein, "INDEMNIFY" means to agree to assume the Released Parties' liability in a situation, thereby relieving them of responsibility and/or reimbursing the Released Parties for Claims asserted against them.
