JUDGING: Contest will be held on Saturday, April 5, 2025, at approximately 11:00 a.m. at the Galveston County Fair & Rodeo Entertainment Pavilion

Sponsors for the event are needed. Sponsors will be recognized in the program and during the event.

Those interested in helping sponsor the event with a cash donation to be used for awards or gifts for the winners should check the box on the attached entry form.

1. Baby/Toddler Cowboy and Cowgirl contestants **must be ages 3 months – 2yrs as of the date of the contest.**
2. An Indemnity Form must be submitted with the entry form. Failure to do so will result in the disqualification of the contestant.
3. The contestants may ride in the Parade which will be held on Saturday, March 29, 2025. Contestants will assemble at 9:00 a.m. at the VFW Post 5400 Parking Lot, Hwy 6 in Santa Fe and the parade will start at 10:00 a.m. Rules will be discussed at the parent meeting. Western Wear will be the attire for the parade. The theme of the parade will be announced at the parents meeting. We will need volunteers to pull the float and decorate.
4. A link to a questionnaire will be sent to the parent. A recent and appropriate photograph of the contestant and questionnaire must be completed no later than **Monday, March 24, 2025. The questionnaire information and photograph will be published in the program for this show. The committee reserves the right to edit your information to accommodate the space in the program.**
5. The contestant's parent(s) or guardian(s) agree with the Galveston County Fair & Rodeo, Inc. that the contest is for the purpose of extending an opportunity for the contestants to participate in a good experience and fun event. Each contestant and parents are expected to act properly and to present an appropriate image.
6. Contestants will be judged on the day of the event on personality, attire and poise. Baby contestants will not have a separate interview; each will be accompanied on stage by one adult and come to the center of the stage. At this time, the child should smile, be cute, show his/her personality, charm the judges, etc.
7. Contestants' parent(s) or guardian(s) agree the time, manner, and method of judging shall be within the discretion of the Galveston County Fair & Rodeo, Inc. and the decision of the judges is final.
8. **Only the contestants are allowed free admission the day of the Contest.**
9. **One boy will be named Baby/Toddler Cowboy, and one girl will be named Baby/Toddler Cowgirl. There will also be awards for 1st and 2nd runner up.**
10. A **mandatory parent** meeting will be held **Friday, March 14, 2025** at 6:30 p.m. in the Youth Building located at the Galveston County Fairgrounds. One Parents or Representative must attend.
