Since 1956, the award has been presented at the Manatee County Fair in January. In the spring, a reception and ceremony honors the award recipient when their footprints, along with those of previous winners, are unveiled in concrete on the sidewalk in front of the Manatee County Courthouse.

Any Manatee County citizen may nominate individuals for the award. The selection process for this prestigious award is based on the following:

- The nominee(s) should currently reside in Manatee County.
- The nominee(s) resume of service should demonstrate their longevity, depth and diversity of volunteer service benefiting the citizens of Manatee County but not directly related to their employment or professional responsibilities.
- Active Fair Board or County Commission Board members are not eligible for this award.
- Applications shall remain on file for consideration for a period of two years.
