- All ages will be as of January 1 of the current year.
- The Washington State Grange Youth Fairs Program Guide is a part of the rules and regulations for fair participation.
- Entries will be open to Youth and Junior Grange members, per the guidelines of the Grange Youth Fairs Program.
- With respect to the 4-H and FFA Programs, we will honor the terms of their Memorandum of Understanding in regard to participation in multiple youth programs.

ANIMAL SCIENCES

HERDSMANSHIP

- Each Grange member with animal exhibits is required to perform herdsmanship. Failure to do so means the animal may be sent home. Failure to perform herdsmanship duties on auction animals may preclude the exhibitor from selling the animal in the livestock auction.
- The purpose of herdsmanship is for Grange members to care for their animals and equipment properly, ensure safety, and to keep stalls, surrounding areas, and animals clean and attractive at all times. Educational displays and public relations are also an important component of herdsmanship.
- Exhibitors may perform herdsmanship by chapter or may form several chapters into herdsmanship groups with their section superintendent's approval.
- Stall cards will be furnished for each animal and must be on display for the entire fair.
- Pens must be kept clean before, during, and after the fair. Grange exhibitors ONLY may perform duties of herdsmanship during the ENTIRE fair. Adults in charge may assist when safety requires it.
- All Grange exhibitors must be properly attired while on herdsmanship duty.

- 2. Exhibitors may enter up to two animals per class, with a maximum of five animals total.
- 3. Grays Harbor County Youth Grange members may enter their registered Grange animals in open class. Refer to open class dairy department rules for making entries.
- 4. Entries must have been in continuous ownership, or the care of the exhibitor, since May 1, current year. All animals will be required to be double tied, one halter with rope and one rope chain around neck.
- 5. All animals must be housed in the Grange display areas to be eligible to be judged in the Grange show ring.
- 6. All animals must be left outside the barn until the animals are checked with the superintendent. Superintendents have the authority to refuse entry until the animal is checked by a veterinarian.
- 7. No horned dairy animals will be allowed in the Youth Grange show.
- 8. All animals must be at least four months of age, unless calf is a part of a cow/calf poair.
- 9. All exhibitors are to be properly attired while on herdsmanship duty.

- 4. Entries must have been in continuous ownership, or the care of the exhibitor, since May 1, current year.
- 5. All animals will be required to be double tied, one halter with rope and one rope chain around neck
- 6. All animals must be housed in the Grange display areas to be eligible to be judged in the Grange show ring.
- 7. All animals must be left outside the barn until the animals are checked with the superintendent. Superintendents have the authority to refuse entry until the animal is checked by a veterinarian.
- 8. Exhibitors must be present to check animals in with the Superintendent for all classes.
- 9. Market steers must be polled or dehorned; healed or regrowth must extend less than two inches from the hairline. Breeding beef animals must have safeguards on the horn tips; dehorning is encouraged as a management practice.
- 10. All animals must be at least three months of age, unless calf is a part of a cow/calf pair.
- 11. All exhibitors are to be properly attired while on herdsmanship duty.

- 2. Transportation cages shall be removed from the fairgrounds between time of entry and time of removal of the exhibits.
- 3. Poultry will be inspected for lice. Poultry having lice or showing signs of sickness or excessive dirt will be REFUSED entry by the superintendent and/or vet.
- 4. To prevent the possibility of spreading infectious diseases, it is recommended that all poultry exhibited at the fair be examined and quarantined, if necessary, prior to returning to the farm.
- 5. All birds exhibited must show maturity. Chickens must be at least 16 weeks old, with the exception of live meat birds.
- 6. Poultry injured after being checked in by the superintendent should not be disqualified for that year, but the bird cannot be exhibited again.
- 7. The poultry exhibitors must present a certificate to the superintendent prior to check in that certifies the entries are Samonell Pullorum-Typhoid clean ** State Requirement**
- 8. No decorations will be allowed on cages, other than the stall cards and/or entry tag. Banners and signs may be placed in the area designated by the superintendent. Balloons, streamers, and glitter are not allowed.
- 9. All poultry must be bathed. We recommend the three-bucket method.
- 10. All poultry exhibits are responsible to bring their own feed and feed pans.
- 11. Entry forms are due to the Fair Office no later than July 20th.

- 4. All rabbits must have legible tattoo in left ear. All cavies must have ear tag in left ear.
- 5. Water will be provided by the fair. Containers will be provided for the rabbits, but cavy exhibitors should bring their own containers.
- 6. Rabbits injured after being checked in by the superintendent will not be disqualified for that year, but cannot be exhibited again.
- 7. There will be no cross exhibiting of animals between Grange, 4-H, FFA, and Open Youth Rabbits & Cavies.
- 8. Beginner exhibitors 8 years or younger must have a parent present at all times.
- 9. Entry Forms are due to the Fair Office no later than July 20th.

- 2. Entries are open to Junior and Youth Grange members. The State Grange Office will provide a current membership list to the fair by July 1.
- 3. All entries must have been completed in the last year.
- 4. Specific rules are available in the State and National Grange Program Handbooks. Judging criteria is listed in the handbooks.
- 5. All artwork and those items intended for hanging must have proper hanging devices attached.
- 6. Entries must be neat and clean.
- 7. If the entry is small, fragile, or loose, it must be fastened to a stable base or mount. This is up to the individual before bringing the item to the fair on entry day. The base or mounting will not be judged.
- 8. There is a maximum of five entries per section per exhibitor. If there are multiple classes in a section, there is a maximum to five entries per class per exhibitor.
- 9. Themes listed in the Grange Program Handbook must be used.
- 10. All food preservation entries shall be labeled with type of food, processing method used (including pack, pounds of pressure, etc.) processing time and date preserved.
