



Expo New Mexico RV parking Guidelines and Rules

- **Proof of purchase is required upon arrival.**
- **If you are arriving without an online reservation please call Security at 505-401-5095**
- **Expo NM/NMSF does NOT issue refunds or exchanges**
- **Expo NM is a Smoke Free/ Drug Free Campus. This includes, but is not limited to, Tobacco and Cannabis products.**
- **Staking or any other activity that may damage the asphalt is strictly prohibited. Violators will be subject to a \$750 Fine.**
- RV Space Rental Fee includes parking for one (1) RV and one (1) personal vehicle.
 - Additional personal vehicle passes may be purchased thru Expo NM Staff.
 - RV placard and receipt must be displayed outward in an RV window visible to Expo staff.
 - Personal vehicle placard must be displayed in the lower left hand corner of windshield.
- Waste and Grey water must be discharged into approved receptacle.
- Pets must be under owners' control at all times.
 - When walking pets, keep them on a leash and clean up after them.
 - Outside kennels/pens are allowed WITHIN your RV space.
 - Kennels/pens that occupy another space will be charged \$30 dry camp fee.
 - Pets cannot be tied up outside at any time.
 - Shelter, shade, and clean water for animals must be provided.
- Quiet time is from 11:00 pm to 7:00 am.
- Area must be kept clean and free of debris.
- Guests are responsible for all behavior of children. All children under the age of 14 years must be accompanied by an adult 18 years or older.
- You cannot move locations once parked.
- If you pay/reserve a DRY space and are found utilizing ANY HOOK UP you will be charged the Hookup fee and your dry camp fee will not be refunded.
- If you pay/reserve a spot for a specific vehicle (i.e. BOX TRUCKS) and park a different vehicle in that space you will be asked to move, and pay for a new spot.
- Expo NM/ The New Mexico State Fair is not responsible for fire, theft, damage or loss of any article. This is only a license; no bailment is created. Renter agrees to indemnify and hold harmless the New Mexico State Fair, the New Mexico State Fair Commission, EXPO New Mexico, the State of New Mexico, and all their officers, employees, agents from all claims, losses, damages, including property damages, personal injury including death, and liability of every kind, nature and description, directly or indirectly arising from Renter's actions or the actions of any persons directly or indirectly acting as Renter's agents or guests. This indemnification extends to claims, losses, damages, injury and liability for injuries occurring during or after completion of the rental contemplated by this Agreement. Insurance documentation does not relieve Renter from liability under this indemnification and hold harmless clause. This Indemnification and Hold Harmless clause applies to all damages of every kind suffered by reason of any of Renter's operations regardless of whether or not such insurance policies are determined to be applicable to any of such damages or claims for damages.

The following items are strictly PROHIBITED on Expo NM property.

- Alcohol/ Cannabis/ Drugs of any kind
- Fireworks
- Firearms up to and including BB, Airsoft and pellet guns
- Outdoor fires
- Tent camping, sleeping in personal vehicles, and sleeping outside
- Mechanical work of any kind on Vehicles and RV's

VIOLATION OF THESE GUIDELINES:

- First offense- Verbal warning or written warning to correct violation, and possible fine, TBD by Expo Staff.
- Second offense- You will be escorted off the property by Expo Security and/or New Mexico State Police WITHOUT refund.
