- There are **Winner Certification Information sheets** available to give your fair winners so they can prepare for the PA Farm Show contests. Fairs **no** longer fill out any Farm Show Certification Entry forms. Those Certification Forms will be sent by the PA Special Baking Contest Committee directly to the winners as designated in the fairs' Contest Summary Forms.
- If a first-place winner is unable to attend the state finals, the PA Fairs Special Baking committee will certify the next available winner listed on the fair's Contest Summary.
- Local winners should NOT register directly with the PA Farm Show to compete in the Farm Show special baking finals. The Certification Entry Form signed by the PA Fairs Special Baking committee is their "ticket" to enter. Instructions are listed on the Certification Entry Form.

If you are selected, you will be performing for over 100 fairs and buyers from all over Pennsylvania (from Maryland and New Jersey too) who are actively looking for acts that will make their fair special.

The showcase is a highlight of the convention, an excellent opportunity for fairs to experience acts/attractions/bands firsthand and book them early for the 2025 fair season.

The showcase committee looks for diversity - juggling/magic/illusion and novelty stage acts as well as musical groups, bands, tribute artists and singers – for all sizes of venues.

Additionally, strolling acts/street musicians and grounds entertainers (roving acts who do not offer a stage show) may apply to entertain and mingle in the Chocolate Ballroom lobby prior to the fair banquet on Thursday evening.

The applications for the showcase and strolling entertainment must be received by October 25th. Associates must be current members (or represented by an agent who is a member) to submit for the showcase. You are eligible to apply if you have not showcased in the last 2 years. Those who meet these qualifications should have received an invitation to apply.

M&G LEGISLATIVE UPDATE - PSACF

HARRISBURG OVERVIEW

The 2023-24 session will officially conclude on November 30th, leaving limited session days to move outstanding bills through the legislative process and across the Governor's desk. If they don't make it through the finish line, the bills will have to be reintroduced for consideration during the next session.

This fall, the House plans to gavel-in for 11 session days and the Senate for 14 days.

House of Representatives

The House continues to operate with slim margins between Democrats and Republicans. Without a clear majority, it's difficult for either caucus to successfully pass controversial bills through the chamber.

At full complement, the House has 203 Representatives. Right now, there are 201 members (101R-100D).

Two Democrats recently resigned, bringing their seats down from 102 to 100. The special election to fill those two seats is scheduled for September 17th and it is generally expected that both seats will be filled by Democrats, putting them back in the majority (102) for the remainder of the session.

Senate

Senate Republicans continue to hold the majority with 28 seats; Democrats hold 22 seats.

2024 Elections

On November 5th, all 203 seats of the House of Representatives and 25 out of the 50 Senators are up for election. All odd-numbered Senate district seats are up for election this year.

On your ballots, you'll also find three state row offices: Attorney General, Auditor General and Treasurer. The major party candidates for each office are as follows:

Attorney General

Republican Dave Sunday Democrat Eugene DePasquale

Auditor General

Incumbent Republican Tim DeFoor Democrat Malcolm Kenyatta

Treasurer:

Incumbent Republican Stacy Garrity Democrat Erin McClelland

BUDGET LINE ITEM

Our objective each year is to protect the county fairs line item in the state budget. This year we were able to secure \$4 million in the General Appropriations bill (SB 1001).

Interestingly, the line item was a standalone, separated out from the Race Horse Development Fund. The House Agriculture Committee staff noted that the Equine Coalition has been pushing to have these lines removed from Race Horse Development Fund transfers. Staff did not believe it's a bad idea to have the funding come directly from the Department of Ag. They noted that several years ago, it was a standalone line item.

LEGISLATION

Protecting the Public from Contact with Wild Animals

<u>HB 1451</u> (Hohenstein, D-Philadelphia): Amends Title 34 (Game) by prohibiting menagerie and exotic wildlife permit holders to permit the public to feed or have direct contact with exotic wildlife or wildlife, EXCEPT for ruminants.

Ruminants are defined as "even-toed ungulated mammals that chew the cud regurgitated from their rumen. The term includes cattle, sheep, antelopes and deer and their relations. The term does not include giraffes."

The restrictions would not apply to a nationally recognized circus.

The bill narrowly passed the House with a vote of 109-94. It is now waiting for consideration by the Senate Game & Fisheries Committee.

Banning Traveling Animal Acts in Pennsylvania

<u>HB 1114</u> (Shusterman, D-Chester): Amends Title 18 (Crimes & Offenses) by prohibiting the transport of animals for the purpose of a participating in a traveling animal act.

The bill was introduced and referred to the House Agriculture and Rural Affairs Committee on May 5^{th} , 2023.

LEGISLATIVE CAUCUS

We have officially reorganized the Pennsylvania Fair Caucus! The Pennsylvania Fair Caucus is a bicameral (House and Senate), bipartisan (Republicans and Democrats) caucus.

Representative Robert Leadbeter (R-Columbia) and Senator Lynda Culver (R-Columbia) are the Republican co-chairs. Both represent the Bloomsburg Fair. Senator Culver served on the original fair caucus (under Representative David Millard) when she was a state Representative!

Representative Justin Fleming (D-Dauphin), a former employee of the state Department of Agriculture, is also a co-chair of the caucus.

We collectively identified a few goals to work on throughout the next year:

Identify fair champions in the Capitol;

Provide continued education for fellow legislators about the importance of fairs for our local communities;

Encourage legislators to visit their local fairs and refresh relationships; and

Support the fairs with annual budget line-item initiatives.

Legislative caucuses tend to be relatively informal but provide a solid foundation and list of fair supporters and advocates in the Capitol. Caucus members will be able to help with future line-item requests as well as any other legislative issues that the fairs may encounter. Below is our robust list of members:

John McMullen, A Life Well Lived



Harness racing can be addictive, especially when you grow up around the sport. John McMullen continued a harness racing family tradition started by his late father, Don, in the 1930's and 40's. When it came to training horses in the Indiana PA area, Herman Nichols was once considered the equine authority.

John stated that it was Herman who guided his father's entry into the harness

racing business.

Don McMullen passed away in October 1990, succumbing to cancer just a month after finishing the racing season. He certainly went out on a high note after driving a McMullen owned and trained horse that year, Super Fellow, to a national title as the leading two year-old trotting

gelding on a half mile track.

In addition to continuing his father's success on the racetrack, John took over his Dad's seat on the Indiana County Fair Board and inherited the title of Harness Race Secretary. In addition, John ultimately served on the Board of the State Association of County Fairs. During the harness races at subsequent Indiana Fair's, a horse blanket has been awarded annually in Don McMullen's memory. John and his father raced exclusively at county fairs until the North Strabane track opened south of Pittsburgh in 1963. John and his father earned the unique bragging rights that few can claim by racing a horse on the opening day of the Meadows Pari-mutuel Racetrack.

Recounting a conversation with a friend, John recalled driving horses at numerous Pennsylvania county fair tracks during his career. Although his record would prove differently, he limited his driving because his Dad told him he was not very good at it. We tend to be toughest on the ones we love. For many years, including today, when you drive past Armaugh PA on Route 22 you'll be able to view the picturesque McMullen farm complete with their jogging track and often with several horses of various ages in the fields.

Today, with the help of their dear friend Wilbur Yoder who trains and drives for them, they continue to field horses. John's wife, Judy, has been a major part of the racing success that John has enjoyed during his career. Judy has supported their harness racing ventures as a dedicated partner to John both on and off the track. She has been an integral part of their family operation, along with son John, daughter-in-law Michelle, and grandson Owen.

Some of their best horses followed a McMullen tradition by naming their entries after Pennsylvania counties. This included the very successful horses, Columbia County and Somerset County. John's horses were winners because of his personal commitment as an owner and trainer. This is the same dedication he shared with the Indiana County Fair for the past 34 years as a Board Member and Harness Race Secretary. Well done John, you've earned the enormous respect of the Harness Racing Industry and the Fair Community.
