

## **RULES & REGULATIONS**

-----

- 1. Car numbers will be confirmed by pre-registration only on a first come, first entered basis. Duplication of numbers will not be permitted.
- 2. Heats are determined by number of total entries. Winner of each heat will qualify to the semifinals, 2nd and 3rd place will move to the quarter finals. In consolation, top 2 go to the quarter finals. Top 3 of "semi" heat will move to finals.

## **Automobile Setup Procedures:**

- 1. Any small, 4-cylinder automobile is acceptable. Due to the size of the cars and the small running area, maximum wheelbase allowed is 107 inches. No pickups or 4x4s. No All Wheel Drive.
- 2. The only welding is to be on the bumpers, securing the doors and hood, and the roll cage.
- 3. No foam added to the cars; only foam that came stock with the vehicle is allowed.
- 4. Cars must be stock with the exception of tuners. Stripping plastic pieces and interior parts are allowed.
- 5. All chrome, fiberglass, plastic, diecast metals (i.e. head-, tail-, and parking light assemblies), and all glass MUST be taken out and/or vacuumed out of the inside of doors, passenger compartment, and trunk. The car must be free of any dirt, debris, or fragments anywhere in the automobile prior to entrance into the Fremont County Fairgrounds.
- 6. Driver's door must be welded, taped or pinned shut, they can not come open during the race.
- 7. Automobiles must have a lap and shoulder belt. Seat and seat belts shall be attached securely to the floor. Note: 4 point belts are recommended. All airbags must be disconnected or removed.
- 8. Bumpers can be factory metal or built out of 3/16th metal. If built bumpers are are put on the car they can not go past the center of the tires, must be smooth on the ends and if they are bent back they can not have kickers welded to the frame. They can be bolted or welded but if welded no extra metal added to the frame. NO homemade rear bumpers.
- 9. All cars must have numbers at least 10 inches high placed on each side of the car and on the roof. (Numbers must be approved with Fremont County Fair Staff, no two numbers the same.) Sponsors may be painted on the car. No risqué or obscene sayings will be allowed. **All numbers must be contrasting color from car.**
- 10. Air only in the tires, No foam. Wheel weights must be removed from all wheels. No studded tires. Tires may be sipped. Tires need to be close to the same size all the way around the car.
- 11. A bar from door to door welded behind the seat is highly recommended. You can weld a halo bar off that seat bar. A windshield bar is recommended also in case of a role over.

- 12. Driver window net is mandatory. If you have a passenger that window will need one also.
- 13. No holes are to be cut in the roof -- factory sunroofs only. Hoods may be bolted down, all thread to the frame through the core support is ok.
- 14. Drivers doors are recommended to be a different color. Driver's door and passenger door may have a pipe in them for protection.
- 15. Batteries only may be moved and installed inside the car cab. All batteries must be fastened down and covered.
- 16. NEWLY ADDED! Cars MUST have a coffee can size hole on the driver's side behind the driver's seat. This is to accommodate transponder placement.

## **Drivers, Pit Crew, and Pit Crew Area:**

- 1. Absolutely no alcoholic beverages will be allowed in the pit area. Any driver or pit crew member found with alcohol in his/her possession while on the Fremont County Fairgrounds at any time of day will immediately disqualify the figure 8 car and driver from the event.
- 2. All cars need to drive slowly through the pit area. NO EXCEPTIONS!
- 3. All drivers and pit crew must be 16 years of age or older and must sign a liability release before entering the pit
- 4. Only the figure 8 car, one support vehicle and one vehicle with trailer will be allowed in the pit area. Figure 8 cars must be removed from the Fairgrounds by 12:00 am (midnight) day of the race. Any car left on the grounds after 12:00 am (midnight), without prior permission, will be fined a \$350 fee.

## **Competition Regulations:**

- 1. All Drivers must attend the "Drivers Meeting" to be held TBD day of the race.
- 2. Drivers must wear a helmet and goggles or face shield to protect their eyes from flying debris kicked up by spinning wheels.
- 3. A Passenger is allowed to ride shotgun for a \$25 charge.
- 4. No car that is unsafe, as determined by the judges, shall be allowed into the arena.
- 5. All cars must be inspected by the judges before entering the pit area.
- 6. Unsportsmanlike conduct may be grounds for disqualification for the present and future years.
- 7. No intentional hitting of the driver's or passenger's door will be allowed. You will be disgualified. There will be a judge placed in the arena to specifically enforce this rule.
- 8. Drivers must remain alert to signals by the field judges.
  a. A black flag is a sign of disqualification
  b. A red flag is an emergency stop sign and all drivers must stop until signaled to continue
  - c. A green flag is the sign indicating it is ok to go
  - d. A yellow flag means slow down and no position changes
  - e. A checkered flag is your signal to exit the track.
- 9. Drivers are not allowed to leave their cars unless the car is turned over, on fire, or the driver is instructed to do so by Figure 8 officials.
- 10. Absolutely no switching cars for the semi-finals or winners' heat. You must compete with the same car in which you qualified.
- 11. The winner is determined by the first car to cross the finish line after a predetermined number of laps.
- 12. You will be disqualified for any of the following:
  - a. Intentionally hitting the driver's or passenger's door of another car
  - b. Leaking gas
  - c. Reckless driving
  - d. Leaving the figure 8 course e. Sitting dead on the course

  - Intentionally leaving the figure 8 pattern in order to intentionally hit another car
- 13. Drivers will complete 10 laps in all heats. The final heat will be 20 laps.

- 14. Any protests or complaints will be taken to the field judges. All protests must be made immediately following the heat about which you are protesting. Any complaint must be made with \$100 cash. If judgment is awarded in favor of the judges, the complainant will not be reimbursed the \$100. If judgment is awarded in favor of the contestant, the \$100 will be reinstated to the contestant. All judges' decisions are final.
  - a. It is strongly recommended that you have a pit crew member video your heat for this purpose. Some decisions do come down to video proof.
- 15. Wyoming Rubbin' is Racin' reserves the right to make any necessary changes in rules and will give as much advance notice as possible if that happens.
