EVENT DAY INFORMATION

CHECK-IN: All crock pots must be dropped off warm between 10 – 10:30 AM at the Crock Pot Chili Cook-Off tent in Ed Pickett Memorial Hall (NO LATE ENTRIES)
JUDGING: Judging will take place at 11 AM; bowls and utensils for judging will be provided by the Chili Cook Off committee
AWARDS: Prizes for 1st, 2nd and 3rd in each category will be awarded
Awards will be announced at 12 PM at the Crock Pot Chili Cook-Off tent in Ed Pickett Memorial Hall
PICK-UP: All crock pots must be picked up between 1 – 1:30 PM
RULES:

- 1) AMATEUR Cookers Only! No pros, restaurant owners or caterers.
- 2) Chili must be prepared at home in a crock pot using a crock pot liner.
- 3) Entry must be warm upon arrival.
- 4) No store-bought or canned chili allowed.
- 5) A recipe must accompany your chili, including the ingredients list, on the official recipe sheet (attached).
Note: Recipe will not be shared, and will only be used for judging purposes – it will be returned at pick-up.
- 6) Do NOT put your name on your entry; each entry will be assigned a number to ensure blind judging.
- 7) Judging will be based on the following criteria: Taste, Texture, Aroma, Appearance, Consistency and Aftertaste; each criterion will be rated 1-5 and added for a cumulative total of up to 90 points.
