## GCF&R STUDENT VOLUNTEER PROGRAM REGULATIONS

- 1. Special Day Volunteers must be in grades 5 12 and must attend one volunteer orientation meeting 7:00 p.m. on Thursday, February 6, 2025 or Monday, February 24, 2025 Galveston County Youth Building. A Parent/Guardian should also attend this meeting as their signature is required on the application. A parent may attend the volunteer orientation in place of the student if the student is unable to attend due to TEA/UIL activity or illness. Volunteers who attend this meeting and meet the requirements will also have the opportunity to apply for a Squad 3 Volunteer position. The meeting will begin promptly at 7:00 p.m. Please arrive early. The doors will be monitored and no one will be admitted once the meeting has started.
- 2. **Volunteer must be academically eligible**. Eligibility will be determined by designated school officials in cooperation with the GCF&R Student Volunteer Committees. If a volunteer is deemed ineligible, they will be notified and are **not allowed to be present during these events.**
- 3. <u>Applications must be signed by the student volunteer and by their parent/guardian.</u> The completed application must be turned into the chairperson **before March 22, 2024**. **ABSOLUTELY NO LATE REGISTRATIONS WILL BE ACCEPTED!**
- 4. YOU WILL BE NOTIFIED BY **EMAIL** OF YOUR ACCEPTANCE. Please write the email address clearly that you need us to send this to on the application. If you have any questions, please email us at <a href="mailto:gcfrspecialdays@yahoo.com">gcfrspecialdays@yahoo.com</a> This is the email address that will be sending your notification.
- 5. The student volunteer should be present for roll call at the beginning and the end of the day:

- \*\*\*There will be no adult supervision of the student volunteers once they have been released.

  6. The use of cell phones and other electronic devices by student volunteers is PROHIBITED.

  If a student volunteer needs to contact someone, they will need to go to one of the committee members for assistance.
- 7. Volunteer is not allowed to leave their assignment without permission from a committee member/teacher. If you are released from your assignment by a committee member/teacher, you are required to report to a designated committee member for a new assignment.
- 8. IF A COMMITTEE MEMBER ASKS YOU TO DO A JOB, YOU DO IT!!!

  Committee members and the student volunteers will be designated by shirt color.
- 9. **DRESS CODE Volunteer MUST wear their volunteer shirt all day.** Wear closed toe shoes with backs. Shorts must cover mid-thigh. Remember, you represent the fair, your school, 4-H club, FFA chapter and your parents.
- 10. Face Painters will paint one item only so the line will keep moving.
- 11. Volunteer may only ride the carnival rides with the teacher's permission and must be seated with a "Special Kids' Day student".
- 12. **DO NOT** FEED, WATER OR CHECK ON YOUR SHOW ANIMALS FROM FIRST ROLL CALL TO AFTER LAST ROLL CALL. **You are here to work this event not take care of your animals.**
- 13. EVERYONE will help keep the grounds clean. If you are assigned to an area, keep it clean during the day.
- 14. FAILURE TO COMPLY WITH THESE REGULATIONS WILL RESULT IN a committee member contacting your parents to pick you up. You will be subject to being sent back to school if you do not follow directions.
- 15. STUDENTS WHO ARRIVE LATE, LEAVE EARLY OR ARE RELEASED DUE TO DISCIPLINE PROBLEMS WILL <u>NOT</u> RECEIVE CREDIT FOR PARTICIPATING AND THE SCHOOL WILL BE NOTIFIED.
