## **Rules and Regulations Governing all Open Competitive Exhibits**

- 1. Exhibitors must comply with all rules and regulations of the Tulsa State Fair and work must be completed by the Exhibitor only.
- 2. Do not leave sacks, supplies or other material used to transport your exhibit.
- 3. Entries must be entered online by the deadline.
- 4. ONLY ONE ENTRY PER CLASS; NO ENTRY FEE REFUNDS WILL BE GIVEN.
- 5. No exhibitor will be allowed to interfere in any way with the Superintendent or Judge in the performance of their duties. A violation of this rule will be excluded from the exhibition.
- 6. Superintendents have been instructed to reclassify an entry if it does not fit the classification entered by the exhibitor.
- 7. All entries must have name, division and class marked on the back or bottom of each entry.
- 8. The Tulsa State Fair will not take responsibility for the mailing of items; items must be brought and picked up in person during the designated dates and times. Person dropping off/ picking up items does not have to be the exhibitor.
- 9. Management reserves the right to exclude from the exhibit any article it deems unworthy or inappropriate. After judging, the Tulsa State Fair reserves the privilege of displaying articles, or in the case there is not adequate space, they reserve the right of setting the articles back for the exhibitor to pick up at the conclusion of the fair.
- 10. All judging in the Competitive Exhibits division will be completed before the fair opens; however results will not be given out over the phone prior to the fair or opening or during the fair.
- 11. All photographs taken of exhibitors, demonstrators, and entries become property of the Tulsa State Fair and may be used for promotional reasons.
- 12. 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place winning entries may not be entered in future years after winning any Competitive Exhibits or Contest award. If an item is entered that has previously won is entered into the competition, fair staff has the right to disqualify the entry.
- 13. A judge has the right to not award a first place ribbon if they feel none of the entries merit the award.

## **Hold Harmless**

The exhibitor agrees to defend, indemnify and hold harmless the Tulsa County Public Facilities Authority (TCPFA), Tulsa County, and the State of Oklahoma from and against any liability, claim, loss or expense (including reasonable attorney's fees) arising out of any injury of damage which is caused by, arises from or is in any way connected with participation in this program or event, expecting only that caused by the sole active negligence of the TCPFA. The TCPFA management shall not be responsible for accidents or losses that may occur to any of the exhibitors or exhibits at the Fair. The exhibitor is responsible for any injury or damage resulting from the exhibitor's participation in the program or event. This includes any injury to others, the exhibitor or the exhibitor's property. I certify these are my work.
