GENERAL RULES

Please also read the rules in each Division

1. **This Flower Show conforms to the standards established by The National Garden Clubs, Inc. (NGC). The *Handbook for Flower Shows* (HB), 2017 Edition, with revisions printed in the *National Gardener* magazine (TNG) is the authority for all issues not covered by the schedule, which is the Law of the show. (HB 136)**
2. The *Handbook for Flower Shows* (HB) may be downloaded free of charge at www.GardenClub.org or purchased from the NGC store.
3. The flower show is open to all to enter, provided they adhere to the schedule requirements. Exception: Invitational Division exhibits are by invitation only.
4. **FLOWER SHOW ENTRIES: Thurs., August 15, 2024, 12 PM - 4 PM and/or Fri., August 16, 2024, 8 AM - 11AM.** No late entries will be placed or judged.
5. **FLOWER SHOW REMOVAL: Monday, August 19, 2024, 9AM - 12AM.** After 12 PM, the Dismantling Committee will dispose of all remaining materials.
6. **JUDGING will be on Fri., August 16, 2024 between 1PM - 3PM.**The decisions of the judges are final. Awards may be withheld if not merited.(HB 136)
7. All entries in Horticulture, Botanical Arts, and Youth Divisions are considered competitive exhibits within their respective classes.
8. Horticulture Entry cards are available from the Entries Chairperson or from the General Chairperson Sherri Bardsley firequeensherri@aol.com by July 1, 2024. Entry cards for other Divisions will be placed by the Division Chairperson.
9. All entries will be received and registered through the back-entrance door of the Flower Show building.
10. Horticulture Exhibitors are encouraged to fill out entry cards in advance (typed, with labels or in pencil) see page 6 of this schedule. Exhibitors are required to bring a list of all entries with the required entry card information on the day of the show.
11. Exhibitors are encouraged to fill out entry cards in advance (typed, with labels or in pencil).
12. The Classification Chairperson for each Division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility. (HB 24)
13. The General Chairperson and the Classification Chairperson for each Division are available during judging for consultation. They, along with the Judges and Clerks, are the only personnel allowed on the floor during judging. (HB 136)
14. There must be an emphasis on FRESH plant material; No artificial plant material is permitted in any exhibit in any division.(HB 25)
15. A plant must be identified by its binomial name or its currently accepted scientific identification to be eligible for any NGC Top Exhibitor Award. Please use a 4" x 6" card to list all plants in a collection.
16. Each exhibitor is limited to one entry per class, except in the Horticulture Division and the Botanical Arts Horticulture Section. (HB 25).

17. The Council of Garden Clubs of Greater Charleston and The Exchange Club Fair of Charleston will strive to assure the safety of all items after arrival and placement but are not responsible for any loss or damage to exhibits. (HB 25)
18. Once a reservation is made, it is the responsibility of the exhibitor to fill that reservation or furnish a substitute for the exhibit with prior notice and approval by the appropriate divisional chairperson.
19. No plant material in The Conversation List of Endangered and Threatened Plants adopted by The Garden Club of South Carolina is permitted in any Design, Botanical Arts, or Horticulture Divisions of this show. These plant materials may only be used in Flower Shows for Educational Exhibits and should never be collected from the wild. (See pp 13-14)
20. No plants on the SC Invasive Plants Banned from NGC Flower Shows List adopted by the NAJCSC March 2018 list are allowed in this show. (See pp 13-14) or visit <http://www.se-eppc.org/SouthCarolina/Publications/InvasivePlantsBooklet.pdf>.)
21. National Garden Clubs, Inc. prohibits the use of all living members of the animal kingdom and taxidermal representations of the same in any design or horticultural exhibit.

STATEMENT OF AWARDS

THE NGC STANDARD SYSTEM OF AWARDING

The NGC Standard System of Awarding (HB 5) is used in all Divisions

FLOWER SHOW AWARDS RIBBONS

These awards are given to individual exhibits in every class of all five Divisions within each flower show.

<u>Ribbons (HB 5)</u>	<u>Points</u>
Blue – 1 st place – Only one per class or subclass	90 or above
Red – 2 nd place– Only one per class or subclass	85 or above
Yellow – 3 rd place – Only one per class or subclass	80 or above
White – Honorable Mention – One or more may be offered if worthy.	75 or above

HORTICULTURE DIVISION NGC TOP EXHIBITOR AWARDS

DIVISION AWARD:

Award of Horticultural Excellence - One award is offered to the highest scoring blue ribbon winning exhibit in the entire Horticulture Division. Exhibits must score 95 or above. A plant must be identified by its binomial name or its currently accepted scientific identification to be eligible for any Top Exhibitor Award. Only Section Award winners are eligible for consideration for the Award of Horticultural Excellence. Rosette of green, orange and blue ribbons. (HB 40, 46)

SECTION AWARDS:

Arboreal Award - One award is offered to the highest scoring blue ribbon winner in Sections K, L and M. Exhibits must score a 95 or above, be correctly named, and meet all section requirements. Rosette of green ribbons. (HB 40, 41)

Award of Merit - One award is offered to the highest scoring blue ribbon winner in Sections: A, B, C, D, E, F, G, H, I, N, P, Q and R. Exhibits must score 95 or above, be correctly named, and meet all section requirements. Rosette of orange ribbons. (HB 41, 46)

Collector's Showcase - One award is offered to the highest scoring blue ribbon winner in Section O. Exhibits must score 95 or above, be correctly named, and meet all section requirements. Rosette of brown and green ribbons. (HB 41, 46)

Elfin Award - One award is offered to the highest scoring blue ribbon winner in Section J. Exhibits must score 95 or above, be correctly named, and meet all section requirements. Rosette of chartreuse and purple ribbons. (HB 41, 46)

ADDITIONAL AWARDS:

NGC Sweepstakes Award - One award is offered to the winner of the greatest number of blue ribbons in the Horticulture Division. In case of a tie, red ribbons will be totaled, then yellow and white if necessary. Rosette of green and white ribbons.

Garden Club “Give Peace A Chance” Award - One award is offered to the garden club with the largest number of blue ribbons in the Horticulture Division. This will be calculated as a percentage of club size. Rosette of red and blue ribbons. (HB 46)

Exchange Club Award - One award will be offered as determined by the Exchange Club committee. Rosette of blue and gold ribbons. (HB 48)

YOUTH DIVISION NGC TOP EXHIBITOR AWARDS

SECTION AWARD:

Youth Top Exhibitor Award - One award will be offered per age group to the highest scoring blue ribbon winners, scoring 90 or above in each section. Exhibits must score a 90 or above to be eligible for the award. Plant material must be correctly named by the binomial or currently accepted scientific designation and meet all section requirements. Rosette of red, white and blue ribbons. (HB 44)

ADDITIONAL AWARDS:

Exchange Club Award - One award will be offered as determined by the Exchange Club committee. Rosette of blue and gold ribbons.

BOTANICAL ARTS HORTICULTURE DIVISION NGC TOP EXHIBITOR AWARDS

SECTION AWARD:

Botanical Arts Garden Award - One award will be offered to the highest scoring blue ribbon winner in the Botanical Arts Garden Section. Exhibits must score a 95 or above to be eligible for the award. Plant material must be correctly named by the binomial or currently accepted scientific designation and meet all section requirements. Rosette of medium green ribbons. (HB 45)

ADDITIONAL AWARDS:

Exchange Club Award - One award will be offered as determined by the Exchange Club Committee. Rosette of blue and gold ribbons.

HORTICULTURE RULES

(See also General Rules)

1. Exhibitors must register with the Registration Chairperson at the rear of the Flower Show Building to be assigned an ENTRY NUMBER. This number will be placed on all of the exhibitor’s entry cards as well as the exhibitor’s name, address and name of club (if a member). Exhibitors with many entries are encouraged to contact the Horticulture Entry Chairperson in advance to secure an exhibitor number.
2. **SHOW ENTRIES: Thursday, August 15, 2024, 12 PM - 4 PM or Friday, August 16, 2024 between 8 AM – 11 AM.**
3. **SHOW REMOVAL: Monday, August 19, 9 AM - 12PM.** After these appointed hours, the Dismantling Committee will dispose of all remaining materials.
4. ALL HORTICULTURE ENTRIES must be checked by the Classification Committee for conformance to Class Requirements. Only a member of the Classification Committee may approve and initial entry cards.
5. **ALL CUT HORTICULTURE BECOMES THE PROPERTY OF THE FLOWER SHOW COMMITTEE ONCE ENTERED AND WILL BE DISPOSED OF AFTER THE SHOW. POTTED PLANTS, EPIPHYTES, FRUITS AND VEGETABLES REMAIN THE PROPERTY OF THE EXHIBITOR AND WILL BE RETURNED AT THE END OF EACH SHOW.**
6. **All references to the *Handbook for Flower Shows* (HB) are located in the new *NGC Handbook for Flower Shows, 2017* version effective July 1, 2017 with updates available at www.GardenClub.org.**
7. The Flower Show Committee may refuse any horticulture exhibits that are not deemed show worthy due to pests, virus, infection, or disease.
8. An exhibitor may enter as many specimens as desired, provided each entry is a different cultivar or species.
9. All plant material must be fresh and must be grown by the exhibitor. (HB 137)
10. **Growing Requirements:** (HB 55)
 - a. Annuals 90 days
 - b. Perennials 90 days
 - c. Houseplants 90 days
 - d. Vegetables and Fruits 90 days
 - e. Bulbs 90 days Exception: no minimum for forced bulbs, etc.
 - f. Arboreals 180 days
 - g. Troughs 180 days
11. Entries are to be labeled by genus, specific epithet, cultivar, and/or variety - or patented/trademark names. Common names may also be given.

12. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or currently acceptable scientific designation. (Consult HB, Exhibiting in the Horticulture Division, Chapter 6.(HB 27))
13. Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial "shine" products, etc. that change the natural appearance. No wiring of specimens is permitted.
14. Only foliage and/or flowers naturally grown and still attached to the specimens are permitted in the Flower Show.
15. Horticulture Exhibitors are encouraged to fill out entry cards in advance (typed, with labels or in pencil) see page 6 of this schedule. Exhibitors are required to bring a list of all entries with the required entry card information on the day of the show.
16. Exhibitors should submit only those entries that are clean, without dead leaves, spent blooms, and are free of insects/disease.
17. Exhibitors should strive to correctly identify horticulture specimens and research the botanical/cultivar name prior to the show. If still uncertain the first stop in the entry process will be the identification station for assistance. After identification the exhibitor must complete their entry card and place the entry on the Placement Table located at the back of the building.
18. The NGC Exhibit Policies are printed in the HB, Chapter 6, Exhibiting in the Horticulture Division. (HB 27)
19. The rules for a single species cut or container-grown specimen are listed in the supplement to the HB *Horticulture Exhibiting and Judging*, available from NGC.
20. The Scale of Points for Horticulture is located in HB 129 and on page 14 of this schedule.
21. The Flower Show Committee will furnish clear colorless glass bottles/containers for display of cut specimens.
22. Wedging is permitted using clear plastic wrap only, provided by the show committee. Exception: Roses in Sections C, J, and N. and Trees in Section M may be wedged using green Styrofoam provided by the exhibitor.
23. Cut specimens should not have foliage below the water line, except for *Gladiolus*.(HB 27)
24. Terminal bloom must be present at apex of spray, positioned as high or higher than all other blooms and surrounded by four or more blossoms, each on its own pedicel (stem), initiating from the peduncle (main stem). A spray in which terminal bloom is depressed more than one-half its (the bloom) diameter below the highest point of inflorescence is penalized in direct proportion to the severity of the depression.
25. Camellias are exhibited on one-to-two-inch stems with two leaves attached, in clear plastic cups provided by the show committee. Camellia sasanqua blooms are exhibited on branches. NGC requires that leaves be attached to the stem.
26. The Scale of Points for Horticulture is located in Chapter 14 of the *HB* page 129. The Scale of Points is also listed in this schedule p. 14. (HB 15)
27. If a plant is considered a flowering plant it should be exhibited as a flowering specimen. Foliage plants may flower, but should be exhibited as a foliage plant if they are grown for their leaves.(HB 27)
28. Specimens with a class designation in the schedule may not be entered in the 'Any Other Worthy' class. (HB 27)
29. The Classification Committee has the authority to subdivide classes as necessary prior to exhibits being placed on the show floor. (HB 137) The Horticulture

Classification Chairperson and/or the General Chairperson are free to subdivide classes by color, form, size, cultivar, variety or other distinguishing characteristics. (HB 27)

30. Due to time and space limitations only staging and placement committees may be on the floor in the horticulture section during placement of exhibits. Once an exhibit has been sent to the Classification Committee, the exhibitor may not conduct any further grooming, rearranging, etc. This should be completed prior to entry. Once exhibits are placed they are checked by the Horticulture Chairperson or Horticulture Classification Chairperson. Exhibitors are not allowed on the show floor until after judging. Exceptions are Section A, Large Cut Foliage plants, and Section O, Collections, both of which require the exhibitor to assist in placing the exhibits.

4. An NGC Youth Top Exhibitor Award may be offered and awarded in each of the Sections for each age category. A minimum score of 90 points is required to be eligible for an NGC Youth Top Exhibitor Award. Three may be awarded if merited.
5. All plants must be grown by the exhibitor, but may come from their family garden or yard.
6. Plants need to be listed by scientific name. A map showing the location of each plant must be included on a 4" x 6" index card.
7. A minimum of three plant species must be included.
8. Container grown plants must have been in the possession of the exhibitor for a minimum of 60 days. Combinations must have been grown together for a minimum of 21 days.
9. Youth exhibits are judged using the Scale of Points for Combination Plantings and Gardens shown below. (HB 129)
10. Exhibitors are required to use a 4" x 6" index card to create a diagram listing all plants in the miniature garden.

Accessories are encouraged. Exhibit space must not exceed 24”w x 24”l x 8”h. Plants need to be listed by scientific name. A map showing the location of each plant must be included on a 4” x 6” index card. Exhibits will be staged in 8’ tables covered in black cloth to the floor.

Class 1. ‘Brownies’ – Elementary (age 4-7) Exhibits will be viewed from three sides but judged from the front.

Class 2. ‘Pixies’ – Intermediate (age 8-12) Exhibits will be viewed from three sides but judged from the front.

Class 3. ‘Elves’ – High School (age 13 - 18) Exhibits will be viewed from three sides but judged from the front.
