

Lake County Fair Safe Health Plan

Objective:

It is the goal of the Lake County Fair Association (LCFA) to maintain a safe and healthy environment for our patrons, staff and volunteers utilizing the most accurate safety methods, information and resources provided by our Federal, State and Local health officials. The LCFA will take actions to implement this Safety plan that will include the expenditure of C.A.R.E. funds provided to us recently from the State and Local authorities for the purchase of necessary PPE, cleaning supplies and other resources.

Summary:

The existence of the COVID 19 pandemic is very much on the minds of the LCFA and the Fair and Carnival industry as whole. This plan will cover methods that will be implemented on the grounds during operation to provide a healthy environment in compliance with the recommended safety standards.

LCFA Staff/ Volunteer:

All staff and volunteers will be trained and provided the necessary PPE in order to assist with their safety and those they are in contact with during the Fair. All Staff and Volunteers will be subject to a temperature scan during entry onto the Fairgrounds.

Vendor Staff / Amusement Staff:

All Vendor and Amusement Staff will utilize the latest recommended procedures provided by the C.D.C and authorities within their respective industry. It will be the responsibility of each Vendor Management to ensure their staff is within compliance with these recommended procedures.

Patron/ Guest:

All persons entering the Fairgrounds will be asked to abide by all recommended guidelines pertaining to social distancing and will be asked to wear a mask when in close proximity to others. All persons entering the grounds will be subject to a temperature scan.

All patrons showing signs or symptoms of Covid 19 or not abiding by the suggested guidelines will be asked to leave the premises in a professional and private manner.

Crowd Control Points:

All on ground ticket sales locations or areas where lines are required, there will be appropriate social distancing markings spacing out the guest. The LCFA will ask of our Food Vendors and other Vendors on the premises to monitor and control their lines as well. The LCFA Staff will monitor and if necessary control the amount of patrons gathering in smaller areas of the fairgrounds that could possibly create an overcrowded or hazardous concern.

Sanitation/ Hand cleaning Stations and Janitorial Duties:

There will be hand sanitation stations and hand cleaning stations strategically placed throughout the fairgrounds for easy access to all. The contracted Janitorial staff will be required to wipe down all hand rails or other objects with in high travelled areas.

Visitor Awareness:

The LCFA will provide a strong presence of signage and messaging reminding all persons on the Fairgrounds of the importance of practicing all recommended social distancing procedures.

Commitment to our Local Authority

The Lake County Fair Association is committed to following all recommended practices that are requested by the Board of Lake County Commission and the Department of Health to achieve the desired Healthy environment.
