2. A copy of a current driver's license and insurance must accompany the application for all moving vehicles.
3. Moving vehicles are not allowed to demonstrate excessive out of line movement.
4. All equine entries require a volunteer to follow to clean up any mess in the roadway or the horses must be bagged.
5. Current Coggins papers for equine entries must be presented at parade sign in.
6. Mystics of Time Mardi Gras Society reserves the right to restrict, limit, accept or reject any application.
