
Thank you for being a part of the King County Fair! We recognize the load-in process can be, at times, stressful and a long process that can put a lot of stress on the animals (humans too). In attempt to lessen the wait time to get the animals vet-checked and loaded-in, the process will be spread throughout the afternoon and into the evening of July 12th.

The King County Fair appointed veterinarian is graciously donating his time for the majority of the day. He has asked that we stagger the animals load-in times to reflect the schedule above. The process will start with the small animals and move into large animals. The schedule above reflects a load-in schedule for animals that are going to be staged in the Livestock Barn and sheep barn ONLY. If you have two projects with two different load-in times, you must still follow the load-in schedule per vet request and based on other load-in logistics across the grounds. Volunteer help is also based on the above schedule. More volunteers are needed and

available at 5:00PM than the earlier hours. This is another reason the schedule MUST be followed. Trailers hauling larger animals WILL NOT be allowed to begin load-in until 4:00PM starting with sheep, goats, and Llamas.

Livestock Barn Animals Load- In Procedure Re-Cap:

- 1) All entries must enter through gate 3 and follow the signs to the livestock barn. Volunteers can only assist the entries that approach the barn from ONE direction. Entries will be received and checked on a first come, first serve basis. The only entries that can enter though gate 1 are CATS. NO OTHER LIVESTOCK ENTRIES CAN ENTER THRU GATE 1 NO EXCEPTIONS!
- 2) All entries should arrive at the above identified time. The vet will be on-site for the majority of the day. Please be respectful of the schedule as he has helped set the load-in process based on species.
- 3) Please follow map arrows to help eliminate traffic congestion. Gate one will be monitored so DO NOT ATTEMPT to drive in gate 1, you will be asked to turn around and enter thru gate 3.
