Our facilities offer a comfortable base with access to Seattle's waterfront, designed to support business and foster social engagement.

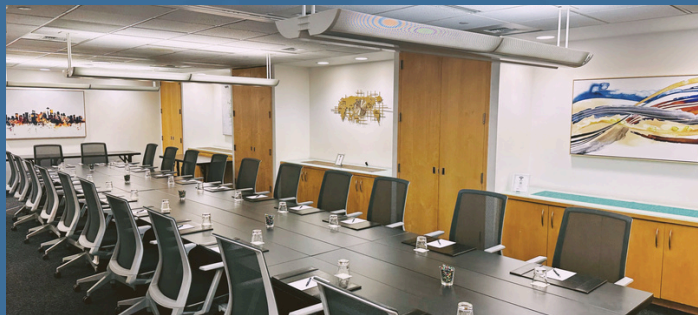


## Bay View Room
