1. Ages 3 to 7
2. Contestant must not weigh more than 60 pounds
3. Long sleeves required
4. Must wear long pants
5. Closed toed shoes
6. Helmet and vest **MUST BE WORN** (we can provide helmet and vest)
7. If the Mutton Bustin' Chairperson determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or sheep, then the said Chairperson reserves the right to disallow the ride. **The decision of the Chairperson is final.**
8. **NO REFUNDS** for any reason.
9. Only one parent/guardian is allowed in the arena with their child. *WARNING: There is an inherent risk of injury or death when farm animal activities are held. The Parent/Guardian voluntarily assumes all risks related to this event and the Galveston County Fair & Rodeo shall not be held liable for the health and safety of the parent/guardian. The parent/guardian must sign a waiver when checking in their child for this event or child will not be able to participate and no refunds will be issued.*
10. The top 5 scored riders will be brought back to ride in the 2024 Bulls and Barrels starting at 2:00pm on Dec. 7, 2024.
