#### A Note to Parents about Your Child's Personal Information:

Why do we require personal information and social security numbers? We understand your concerns, and we want you to know why this info is needed. Many of our 4-H and FFA youths take part in various contests and events-rabbits, poultry, dog show, horse show, and other open

and youth shows. It is possible our kids can earn multiple premiums and accumulate a sum of money that requires us to report their earnings to the IRS. It would be difficult to contact parents after the fair to get the information needed and still get checks written and to the winners in a timely manner. We want you to know their information is guarded and entry forms are shredded when they are no longer needed.

## Photography Release

Photographs will be taken during these events and the images will be used to help promote the fair and educate the public about our different programs and competitions.

I authorize the Greater Jacksonville Agricultural Fair or their assignees to record and photograph my image and/or voice (or that of my child if under 18) for use in research, educational and promotional programs. I also recognize that these audio, video and image recordings are the property of the Greater Jacksonville Agricultural Fair.

**NOTICE:** In the case of papers pending, it is the responsibility of the exhibitor to provide the fair with a letter from the breed association stating that the papers on their animal have been applied for but have not yet been processed. Papers pending will not be accepted without this letter from the association.

## **Rules:**

1. Exhibitors must adhere to the requirements as outlined in the Youth General Livestock Rules and Regulations.

2. Exhibitors must show their own animal(s).

3. 4-H and F.F.A. exhibitors entering the Youth Beef Show or the Youth Dairy Show will be required to be clean, neat, and dressed in white, green, blue or black jeans or slacks, whichever is appropriate, with a solid white shirt or white polo shirt with a white collar. 4-H accessories are strongly recommended. Closed-toed shoes or boots are required. T-shirts, caps or hats are prohibited. If you are an F.F.A. member, official dress is required.

4. Separate shows will be held for each breed with a minimum of 10 head per breed or 3 exhibitors.

# Completion of the Youth Livestock Show Ethics and Animal Care workshop is required.

## **Beef Showmanship:**

Beef Showmanship will be on November 4<sup>th</sup> for Youth Santa Gertrudis and Youth Brahman, November 7<sup>th</sup> for Youth Brangus, November 10<sup>th</sup> for Youth Limousin, Youth Angus, Youth Commercial and Youth AOB, and November 11<sup>th</sup> for Youth Dairy. All bulls intended to be shown in the showmanship class must be shown with a permanent or temporary nose ring.

- 1. Senior Showmanship: 14-18 years of age
- 2. Intermediate Showmanship: 11-13 years of age
- 3. Junior Showmanship: 8-10 years of age

If you wish to compete for Showmanship, you must indicate this on your registration form.

#### **Showmanship Awards:**

First Place Division Winners in Youth Beef Showmanship will be presented with a belt buckle award sponsored by The Duval County Cattlemen's Association. Awards will be presented immediately after the show. Second and third place winners in each division will receive an award.

#### **Eligibility:**

Restricted to bona fide 4-H and FFA members as of September 1st, of the current year. Iunior 8 - 10 Years of age

Senior	14 - 18 Years of age

#### **Cattle will be received:**

See individual breed.

All animals entered in the Greater Jacksonville Agricultural Fair MUST have a current health certificate. All cattle entering the Youth Beef Show must be received when their breed is received.

#### **Release:**

Youth cattle will be released after 8:00 p.m. with their breed. See the Youth General Rules for additional information on the release policy and release map.

## Youth Show Rules

- 1. The Youth Beef Shows will run simultaneously with the Open Breed Shows.
- 2. Only 4-H or FFA members may exhibit animals in this Youth Show. The exhibitor must show their own animal(s). If an exhibitor has more than one animal in any one class, the exhibitor can have another youth exhibitor show that second animal.
- 3. This Youth Show will be governed by the specific breed associations Rules and Regulations.
- 4. All animals exhibited must have been recorded, registered or transferred in the youth exhibitor's name on or before check-in.
- 5. No exhibitor shall be permitted to win more than two premiums in any one class.
- 6. Modified Danish System will be used.
- 7. All decisions by the Barn Superintendents regarding eligibility in the Youth Show(s) are final.

PARKING: Exhibitors participating in the Open and Youth Cattle Shows will be given parking passes for the Exhibitor Lot . Parking Lot # 2 is reserved for 11-day exhibitors, admission control, Fair Board Members, staff, security, Jacksonville Sheriff Officers, and for Fire and Rescue Trucks that may be needed for any emergency that may arise during the Fair. This lot will be monitored to assure that it is not used by anyone except those previously listed and who have a Lot #2 parking pass hanging on the rearview mirror with the correct name.
PASSES: Gate passes will be issued on the following basis. 1-6 animals, six (6) daily admission tickets and three one day Exhibitor Lot parking passes, 7-12 animals, nine (9) daily admission tickets and six one day Exhibitor Lot parking passes.

Please note: All passes will be single daily admission tickets. All parking passes for Open and Youth Shows will be for the Exhibitor Lot. (11-day exhibitors get one Lot 2 pass and one Exhibitor Lot pass.) No additional parking or admission passes will be given if showing in the Youth Show as well.
