#### **Information and Rules:**

- All market lambs must be sheared at the time of arrival at the fairgrounds.
- In accordance with the Missouri Department of Agriculture and the Missouri State Fair health guidelines, all sheep (including wethers) must have a Certificate of Veterinary Inspection (health certificate) to be eligible to show. This health certificate must have been written with 30 days of exhibition. All sheep must also be identified either by ear tag, electronic implant, or tattoo.
- Only healthy animals will be admitted. All animals may be subject to a health inspection from a state licensed veterinarian who has he authority to deem any animal a health risk and require removal from the fairgrounds.
- Open to exhibitors 21 years old or younger.
- Cass County Fair will follow the rules set forth by the Missouri State Fair unless otherwise noted:
  - Wrist bands will not be used for approved animal care and show prep designations.
  - This is a youth show and 4-H/FFA Code of Ethics are enforced.
- Market Lambs must be born on/after January 1, 2024.
- All sheep will be released at the completion of the show.
- Muzzles will not be allowed on sheep
- Classes may be combined at the discretion of the superintendent
- Limited electricity is available, generators are welcome.
- Stalling animals in the provided area (barn/tent)
  is suggested for exhibition purposes, but will not
  be required.
- Bedding will not be supplied. Please remove all bedding at the completion of the show.
- All stalls must be cleaned before being released by the Superintendent.
