A \$50.00 service fee will be charged for all returned checks. Services Installation and Equipment Use for a wireless connection, can be ordered via fax, phone, mailed in or ordered on site at the Exhibitor Service desk. For a private wired connection, you will receive access to the Internet via an access code for one device. If you order 14 days prior to the event, connect your machine to the Cat5 cable that is installed at your location. Scan for wireless networks select WFEH.expo wireless network, The World's Fair Exhibition Hall splash page will pop up. Enter your access code in the box, click on the box to consent to the information and conditions, scroll down and click continue. If you order on-site, go to the Exhibitor Service Desk and they will give you an access code. For a public IP wired connection, a printed copy of the full TCP/IP address information will be provided to you prior to the event to facilitate your configuration of the demonstration machine. To connect additional devices to the network you will need to order additional network connections. Please see the Order Form. Enter your IP information into your machine and then connect your machine to the Cat5 cable that is installed at your location. Keep in mind; the Internet is a public domain. We do not guarantee the performance of any connection outside of the facility. The World's Fair Exhibition Hall has no control over nor is it responsible for the external network performance once the network traffic leaves The World's Fair Exhibition Hall network and is received by the ISP's router and beyond. (Remember, one (1) public or private TCP/IP address must be ordered for each machine to be connected to the internet. No router, DHCP servers, NAT servers, proxy servers, streaming applications or VOIP are allowed with any of our services. If you require any of these services, we will accommodate your request with a written quotation.
