The ramp will be built to A.D.A standards and has been designed by an accessibility specialist at Options Resource Center for Independent Living in East Grand Forks, MN. (Please see attached)

The ramp and associated concrete extensions along the driveway would exceed the City's 30% greenspace zoning on this lot. We therefore respectfully request that a variance be granted, so that the house can continue to be a home for this longtime Ada resident and her daughter.
