Old City Hall parking lot on 4<sup>th</sup> Ave, between West Main and East Main Street.

The County dump will also be open during the times above as well as regular schedule time on Saturdays from 8:00am-1:00pm.

Through the cooperative efforts of the City, area businesses and organizations, residents will be able to dispose of their unwanted and-accumulated items, junk or debris at little or no cost. The contents of this newsletter will provide residents with details on the programs and methods that will be available to get rid of unwanted items and also, information on upcoming efforts to beautify the area in which we live.

Reminder, weight limit is 30 pounds per bag and 30-gallon bags or less. All trash must be placed in bags and tied. **NO-animal droppings, cat litter, dead animals, yard/garden waste, hazardous waste or appliances.** 

Also consider donating unwanted items in good condition to the DAC Hidden Treasure store.

# **Compost Hours**

The City Compost Site will be open 24 hrs. per day, 7 days a week weather permitting. If the gates are closed, the compost is closed. Do not pile leaf bags and branches by the gate when it is closed.

# **Sump Pump Notice**

All sump pumps are to be turned outside as of April 15<sup>th</sup> unless you are paying the \$50 per month surcharge.

**Inoperable motor vehicles.** It shall be unlawful to keep, park, store, or abandon any motor vehicle that is not in operating condition, partially dismantled, used for repair of parts or as a source of repair or replacement parts for other vehicles, kept for scrapping, dismantling, or salvage of any kind, or which is not properly licensed for operation within the state, pursuant to Minn. Stat. § 168B.011, subd. 3, as it may be amended from time to time.

#### Ordinance 176 Junk, Blight, and Junk Automobiles

Storage or accumulation of junk, trash, rubbish or refuse; enumeration. In any area within the city, the storage or accumulation of junk, trash, rubbish, junk automobiles, or garbage of any kind may be stored on residential property. The term "junk" shall include parts of machinery or motor vehicles, old furniture/mattresses, unused stoves or other appliances stored in the open; remnants of wood; decayed, weathered or broken construction materials no longer suitable for safe, approved building materials; and metal or any other material or castoff material of any kind, whether or not the same could be put to any reasonable use.

When the owner or occupant permits a nuisance to exist in violation of this article, the Police Department shall serve notice upon the owner of the property if residing in the city by registered mail or by personal service, ordering such owner and/or occupant to have such nuisance removed within ten days after receipt of the notice. Failure to comply with such notice within the time allowed shall constitute a violation of this division. *Penalty for violation of division*. Violation of this division shall be a misdemeanor punishable, upon conviction,

#### **Ordinance 472 Environmental Code – Grass Clippings**

Residents shall not deposit grass clippings, leaves or other vegetative materials on city streets, storm water drainage system and natural drainageways. The City of Ada has a compost site available north the Public Works

# **A FEW REMINDERS**

A brief review of City Ordinances.

#### **Ordinance 476 Animal Waste**

Anyone walking their dog or cat will be responsible for the cleanup of the animals excrement and for its proper disposal. A citation may be issued from the Police Department if not properly disposed of.

#### Ordinance 347 Animal Acts Constituting Nuisances

The owner of any animal shall prevent such animal from habitually barking, chasing vehicles, assaulting other animals or people, and violent attacks. *Prohibited to run at large*. No dog or cat shall be permitted to run at large within the limits of the city

#### Ordinance 460 Public Nuisances within the City of Ada.

**Unlawful Parking of Trailers** - (1) A person must not place, store, or allow the placement or storage of ice fishing houses, skateboard ramps, or other similar non-permanent structures outside continuously for longer than seventy-two (72) hours in the front yard area or street of residential property. Any structure that creates a hiding place or habitation for wild animals or rodents falls within this provision. (2) A person must not place, store, or allow the placement or storage of pipe, lumber, forms, steel, machinery, or similar materials, including all materials used in conjunction with a business, outside on residential property, unless shielded from public view by an opaque cover or fence.

**Vehicles -** No more than six (6) vehicles or vehicle trailers per lawful residential (R1) unit may be parked or stored anywhere outside on residential property. Four (4) vehicles in regular use and currently licensed, may be parked in the front yard at any given time; the other two (2) must be screened (obscured from public view) using hedges, fences or suitable vehicle covers. Vehicles located in enclosed areas, e.g. a garage, do not count against the six (6).

# **Demolition Pickup**

Al's Disposal will conduct a collection of demolition material at no cost to City of Ada residents. Bring items to the Old City Hall parking lot on 4th Ave on the dates listed for Clean Up Week to dispose of unwanted items. Acceptable and unacceptable items are identified in this brochure. Separate your items into these separate dumpsters when dropping off.

Pile #1- Plaster, sheetrock, tar paper and shingles {place in portable containers/boxes) and no more than 1 - 2 yards; Untreated lumber, toilets, sinks, bathtubs, shower stalls, PVC plastic (small quantities), wood windows and doors with no metal parts.

• Pile #2 - Small amounts of metal and steel items, lawn chairs, lawn mowers (push only), small appliances, toasters, electric frying pans, barbecue grills, roasters, metal windows & doors, bicycles.

• Pile #3 - Mattresses, box spring, couches, dressers, furniture.

• Pile #4 -Household garbage, paper, books, toys, clothes, towels, vacuum cleaners, coffee pots, plastic items, small wood items with no metal parts {please put items in garbage bags, boxes or garbage cans).

• Pile #5-Dehumidifiers, dishwashers, microwaves, washers, dryers, hot water heaters, freezers & refrigerators.

A crew from Al's Disposal will be onsite to help insure proper separation of items.



# **Unacceptable Demolition Items at Disposal Site**

-Ashes

- -Tires & batteries
- -Liquids
- -Vehicle Parts
- -Machinery
- -Treated lumber
- -Appliances or white goods
- -Leaves and yard waste
- -Animal and kennel remains
- -Used motor oil and filters
- -Paint & caulking tube containers
- -Hazardous & Industrial waste
- -Glues, adhesives or sealants
- -Steel, fuel oil or petroleum tanks

-Fluorescent light bulbs, light fixtures with ballasts, televisions or any computer equipment, (accepting Saturdays from 8-1pm at the Norman County Landfill)

# Pet Waste Disposal

Please do not dispose of pet waste in your garbage pickup. There is a pet disposal bin located east of the Public Works building. All pet waste is required to be bagged appropriately.

# **Recycling Center**

The Recycling Dumpsters are located at the Valley View Manor, Bridges Medical (West side), and NE of Dekko Center- east of ball diamonds. Please call Norman County Environmental Services Office at 784-5493

**SPECIAL NOTE:** Remove all fluorescent light bulbs and ballasts, and also any food items from appliances before disposal. **Computer monitors and televisions are not accepted** 

# Waste Oil, Oil Filters, Vehicle Batteries

# Tires

Special arrangements have been made with Wes's Truck Shop for residents to dispose of their used tires at no cost. Residents must deliver their used tires to Wes's Truck Shop facility located at 2738 State HWY 200. Residents must register in the office before they drop off their tires in the established designated area. Registration is necessary because the City of Ada will be subsidizing the cost of disposing of these used tires and only City of Ada residents will be allowed to take advantage of this arrangement. Tires can be dropped off Monday through Friday, during the month of May, the hours of 8:00 a.m. - 5:00 p.m. All types of tires will be accepted provided that the wheel rims have been removed.

# **Branch Pick Up**

Branches will be picked up on the first Wednesday of the month April - November. Branches only!

The City will deliver a truck to residents if they are cutting down trees on their property, if they are not currently being used. If contracted to cut trees, contractors haul their own trees out to the compost site when open. Prepared compost will be available for pickup at no charge. You must bring your own containers to pick up compost. The City will deliver large amounts only. To make arrangements for delivery of large amounts, contact the Public Works Department at 784-5537. Weather permitting. Also, please do not burn excessive amounts of branches and leaves.

# **Grass Clippings and Leaf Disposal**

Residents, when mowing lawns or raking, please do not blow grass clippings or leaves into the street. The grass clippings and leaves will plug the catch basins causing water to backup. Residents will receive a warning letter from the Public Works Department.

# **Boulevard Tree Planting Program and Guidelines**

The City in conjunction with Laughing Earth Nursery will give away 50-60 trees for the Boulevard Shade Tree program. Applications available at Laughing Earth and must be picked up by May 31<sup>st</sup>. First come, first serve. YOU MUST HAVE GOPHER ONE NUMBER TO PICK UP.

The following trees will be available: Honeylocust, Siouxland Poplar, Little Leaf Linden, Greenspire Linden, and American Elm

Guidelines and Rules for 2021 Program

- All trees shall be a 1" or larger tree.
- Boulevard shall be a width suitable for tree planting.
- Trees shall not be planted within 10' of a curb/ sidewalk unless approved by Ada Public Works.
- Trees shall not be planted within 15' of the center of a power line.
- Trees shall not be planted within 5' of a water shutoff.
- An attempt shall be made to place trees in line with other boulevard plantings in the neighborhood.
- Trees shall be planted with a minimum of 30' between trees on boulevard.
- You must be a resident of the City of Ada
- You must call Gopher State One Call for utility locations and receive a ticket number.
- Residents are able to receive one tree.

#### **ATTENTION:** Due to COVID restrictions, clinic will be drive by. Please remain in your vehicles and you must call ahead to register.

**NOTICE:** City Ordinance requires dogs and cats that are 6 months of age or older to be licensed. The license period is from July 1 to June 30 of the following year. The license fee is \$3.00 for each neutered/ spayed dog or cat and \$5.00 for each unneutered / unsprayed dog or cat. A statement from a veterinarian showing that the operation for neutering or spaying was performed is require to be eligible to receive the reduced license fee rate. Also, proof of rabies vaccination is required. **City staff will be present to issue the licenses, also issued at City Hall.**
